A BILL to amend and reenact § 9-6.25:1 of the Code of Virginia and to amend the Code of Virginia by adding a section numbered 62.1-132.11:2, relating to the establishment of the Maritime Incident Response Advisory Committee.

Be it enacted by the General Assembly of Virginia:

1. That § 9-6.25:1 of the Code of Virginia is amended and reenacted, and that the Code of Virginia is amended by adding a section numbered 62.1-132.11:2 as follows:

§ 9-6.25:1. Advisory boards, commissions and councils.

There shall be, in addition to such others as may be designated in accordance with § 9-6.25, the following advisory boards, commissions and councils within the executive branch:

 139 § 62.1-132.11:2. *Maritime Incident Response Advisory Committee established; duties; composition;*
 140 *appointment; terms.*
 141 *A. There is hereby created the Maritime Incident Resonse Advisory Committee to provide guidance in*
 142 *the management of maritime fire and incident issues in the Commonwealth. The Committee shall be*
 143 *composed of thirteen members appointed by the Governor as follows: one representative of the*
 144 *Chesapeake Fire Department; one representative of the Chesterfield County Fire Department, one*
 145 *representative of the Hampton Division of Fire and Response, one representative of the Newport News*
 146 *Fire Department, one representative of the Norfolk Department of Fire and Paramedical Services, one*
 147 *representative of the Portsmouth Fire Department, one representative of the Virginia Beach Department*
 148 *of Fire, one representative of the York County Department of Fire and Life Safety, one representative of*
 149 *the Hampton Roads Maritime Association, one representative of the Hampton Roads Maritime Incident*
 150 *Response Team, one representative of the Virginia Port Authority, the Executive Director of the Port*
 151 *Authority or his designee and one citizen member.*
 152 *Initial appointments shall be made as follows: four members shall be appointed for two years, five*
 153 *members shall be initially appointed for three years, and four members shall be appointed for four-year*
 154 *terms. The Governor shall designate the term to be served by each appointee at the time of appointment.*
 155 *Thereafter, all members shall be appointed for terms of four years each. Vacancies shall be filled for*
 156 *the unexpired terms. No member shall be eligible to serve more than two successive four-year terms;*
 157 *however, after expiration of a term of three years or less, or after the expiration of the remainder of a*
 158 *term to which he was appointed to fill a vacancy, two additional terms may be served by such member*
 159 *if appointed thereto.*
 160 *The Advisory Board shall elect a chairman and vice-chairman from among its members. Members of*
 161 *the Advisory Board shall receive no compensation for their services as members of the Advisory Board,*
 162 *but the nongovernmental member shall receive reasonable expenses. Upon the request of the Advisory*
 163 *Board, such staff support as is necessary for the conduct of the Advisory Board's business shall be*
 164 *furnished by the Port Authority.*
