10	Be it enacted by the General Assembly of Virginia:
11	1. That §§ 23-38.55 and 23-38.56 of the Code of Virginia are amended and reenacted as follows:
12	§ 23-38.55. Definitions.
13	For the purposes of this chapter, the following words shall have the meanings ascribed to them by
14	this section:
15	(a) "Senior citizen" shall mean means any person who, before the beginning of any term, semester or
16	quarter in which such person claims entitlement to the benefits of this chapter, (i) has reached sixty
17	years of age and (ii) has had his legal domicile in this Commonwealth for one year. Such person need
18	not have established domicile, as defined in § 23-7.4, in the Commonwealth.
19	(b) "Course" shall mean means any course of study offered in any state institution of higher
20	education including the regular curriculum of any department, or school, or subdivision of any such
21	institution or any special course given for any purpose, including, but not limited to, adult education.
22	(c) [Repealed.]
$\bar{23}$	Nothing in this section shall be construed to exclude any other rules and requirements now or
24	hereafter made applicable for all other persons with respect to residency in this Commonwealth by a
25	state institution of higher learning.
26	§ 23-38.56. Attendance at state institutions; conditions.
27	A senior citizen shall be permitted, under regulations as may be prescribed by the State Council of
28	Higher Education:
29	(i) To register for and enroll in courses as a full-time or part-time student for academic credit if such
30	senior citizen had a taxable individual income not exceeding \$10,000 for Virginia income tax purposes
31	for the year preceding the year in which enrollment is sought;
32	(ii) To register for and audit courses offered for academic credit; and
33	(iii) To register for and enroll in courses not offered for academic credit in any state institution of
33 34	higher education in this Commonwealth.

35 36	Such senior citizen shall pay no tuition or fees except fees established for the purpose of paying for
30 37	course materials, such as laboratory fees, but shall be subject to the admission requirements of the institution and a datarmination by the institution of its shilling to offer the sources for which
	institution and a determination by the institution of its ability to offer the course or courses for which
38	the senior citizen registers. The State Council of Higher Education shall establish procedures to ensure
39 40	that tuition-paying students are accommodated in courses before senior citizens participating in this
40	program are enrolled. However, the In addition, the State Council shall establish procedures for granting
41	priority in accommodating senior citizens seeking enrollment pursuant to this chapter to those senior
42	citizens who have established domicile in the Commonwealth, as defined in § 23-7.4. The state

44	citizen has completed seventy-five percent of the requirements for a degree.
