This offer for the woman to review the material shall 51 advise her of the following: (i) the Department of Health publishes printed materials which describe the unborn child and list agencies which offer alternatives to abortion, (ii) medical assistance benefits may 52 53 be available for prenatal care, childbirth and neonatal care, and that more detailed information on the 54 availability of such assistance is contained in the printed materials published by the Department, (iii) the father of the unborn child is liable to assist in the support of her child, even in instances where he 55 has offered to pay for the abortion, that assistance in the collection of such support is available, and 56 that more detailed information on the availability of such assistance is contained in the printed 57

materials published by the Department. Where the woman has advised that the pregnancy is the result 58 59 of a rape, this information may be omitted, and (iv) she has the right to review the materials printed by HB1482

Before performing any abortion or inducing any miscarriage or terminating a pregnancy as provided for in §§ 18.2-72, 18.2-73 or § 18.2-74, the physician shall obtain the informed written consent 18 of the pregnant woman; provided, however, if such. However, if the woman has been adjudicated 19 20 incapacitated by any court of competent jurisdiction or if the physician knows or has good reason to 21 believe that such woman is incapacitated as adjudicated by a court of competent jurisdiction, then only 22 after permission is given in writing by a parent, guardian, committee, or other person standing in loco 23

24 The physician shall inform the pregnant woman of the nature of the proposed procedure to be 25 utilized and the risks, if any, in her particular case to her health in terminating or continuing the 26

28 "Informed written consent" means the knowing and voluntary written consent to abortion by a 29 pregnant woman of any age, without undue inducement or any element of force, fraud, deceit, duress, or 30 other form of constraint or coercion by the physician who is to perform the abortion or his agent. The basic information to effect such consent, as required by this subsection, shall be provided by telephone 31 32 or in person to the woman at least twenty-four hours before the abortion by the physician who is to 33 perform the abortion, by a referring physician, or by a licensed professional or practical nurse working 34 under the direct supervision of either the physician who is to perform the abortion or the referring 35 physician; however, the information in subdivision 5 of this subsection may be provided instead by a 36 licensed health-care professional working under the direct supervision of either the physician who is to

60 the Department and that copies will be provided to her free of charge if she chooses to review them.

61 The information required by this subsection may be provided by telephone without conducting a 62 physical examination or tests of the patient, in which case the information required to be provided may 63 be based on facts supplied by the woman and whatever other relevant information is reasonably 64 available to the physician. If a physical examination, tests or the availability of other information to the 65 physician or the nurse subsequently indicates, in the medical judgment of the physician or the nurse, a 66 revision of the information previously supplied to the patient, that revised information may be 67 communicated to the patient at any time prior to the performance of the abortion.

68 C. The physician need not obtain the informed written consent of the woman when the abortion is to 69 be performed pursuant to a medical emergency. "Medical emergency" means any condition which, on 70 the basis of the physician's good faith clinical judgment, so complicates the medical condition of a 71 pregnant woman as to necessitate the immediate abortion of her pregnancy to avert her death or for 72 which a delay will create a serious risk of substantial and irreversible impairment of a major bodily 73 function.

74 D. On or before October 1, 2000, the Department of Health shall publish, in English and in each 75 language which is the primary language of two percent or more of the population of the 76 Commonwealth, the following printed materials in such a way as to ensure that the information is easily 77 comprehensible:

78 1. Geographically indexed materials designed to inform the woman of public and private agencies 79 and services available to assist a woman through pregnancy, upon childbirth and while the child is 80 dependent, including, but not limited to, information on services relating to adoption, paternity establishment and child support enforcement, child development, child rearing and stress management, 81 and pediatric and maternal health care. The materials shall include a comprehensive list of the names 82 83 and telephone numbers of the agencies, or, at the option of the Department of Health, printed materials 84 including a toll-free, twenty-four-hour-a-day telephone number which may be called to obtain, orally, such a list and description of agencies in the locality of the caller and of the services they offer; 85

86 2. Materials designed to inform the woman of the probable anatomical and physiological 87 characteristics of the human fetus at two-week gestational increments from the time when a woman can 88 be known to be pregnant to full term, including any relevant information on the possibility of the fetus's 89 survival and pictures or drawings representing the development of the human fetus at two-week 90 gestational increments. Such pictures or drawings shall contain the dimensions of the fetus and shall be 91 realistic and appropriate for the stage of pregnancy depicted. The materials shall be objective, 92 nonjudgmental and designed to convey only accurate scientific information about the human fetus at the 93 various gestational ages; and

94 3. Materials containing objective information describing the methods of abortion procedures
95 commonly employed, the medical risks commonly associated with each such procedure, the possible
96 detrimental psychological effects of abortion, and the medical risks commonly associated with carrying a
97 child to term.

98 The Department of Health shall make these materials available at each local health department and,99 upon request, to any person or entity, in reasonable numbers and without cost to the requesting party.

100 E. Any physician who fails to comply with the provisions of this section shall be subject to a \$2,500 101 civil penalty.

102 2. That the provisions of this act shall become effective on October 1, 2000.
