11	Be it enacted by the General Assembly of Virginia:
12 13	1. That § 18.2-391 of the Code of Virginia is amended and reenacted as follows: § 18.2-391. Unlawful acts.
13 14	A. It shall be unlawful for any person knowingly to sell, rent or loan to a juvenile, or to knowingly
15	display for commercial purpose in a manner whereby juveniles may examine and peruse:
16	1. Any picture, photography, drawing, sculpture, motion picture film, electronic file or message
17 18	containing an image, or similar visual representation or image of a person or portion of the human body which depicts sexually explicit nudity, sexual conduct or sadomasochistic abuse and which is harmful to
10 19	juveniles, or
20	2. Any book, pamphlet, magazine, printed matter however reproduced, electronic file or message
21	containing words, or sound recording which contains any matter enumerated in subdivision 1 of this
22 23	subsection, or explicit and detailed verbal descriptions or narrative accounts of sexual excitement, sexual conduct or sadomasochistic abuse and which, taken as a whole, is harmful to juveniles.
23 24	However, if a person uses services of an Internet service provider or an electronic mail service
25	provider in committing acts prohibited under this subsection, such Internet service provider or electronic
26	mail service provider shall not be held responsible for violating this subsection.
27 28	B. It shall be unlawful for any person knowingly to sell to a juvenile an admission ticket or pass, or knowingly to admit a juvenile to premises whereon there is exhibited a motion picture, show or other
2 9	presentation which, in whole or in part, depicts sexually explicit nudity, sexual conduct or
30	sadomasochistic abuse and which is harmful to juveniles or to exhibit any such motion picture at any
31	such premises which are not designed to prevent viewing from any public way of such motion picture
32 33	by juveniles not admitted to any such premises. C. It shall be unlawful for any juvenile falsely to represent to any person mentioned in subsection A
34	or subsection B hereof, or to his agent, that such juvenile is eighteen years of age or older, with the
35	intent to procure any material set forth in subsection A, or with the intent to procure such juvenile's
36	admission to any motion picture, show or other presentation, as set forth in subsection B.
37	D. It shall be unlawful for any person knowingly to make a false representation to any person

D. It shall be unlawful for any person knowingly to make a false representation to any person 38 mentioned in subsection A or subsection B hereof or to his agent, that he is the parent or guardian of any juvenile, or that any juvenile is eighteen years of age, with the intent to procure any material set forth in subsection A, or with the intent to procure such juvenile's admission to any motion picture, 39 **40** show or other presentation, as set forth in subsection B. 41 42

E. Violation of any provision hereof shall constitute a Class 1 misdemeanor.
