10 11	Be it enacted by the General Assembly of Virginia:
11	1. That § 32.1-102.1 of the Code of Virginia is amended and reenacted as follows:
13	§ 32.1-102.1. Definitions.
14	As used in this article, unless the context indicates otherwise:
15	"Certificate" means a certificate of public need for a project required by this article.
16	"Clinical health service" means a single diagnostic, therapeutic, rehabilitative, preventive or palliative
17	procedure or a series of such procedures that may be separately identified for billing and accounting
18	purposes.
19	[*] "Health planning region" means a contiguous geographical area of the Commonwealth with a
20	population base of at least 500,000 persons which is characterized by the availability of multiple levels
21	of medical care services, reasonable travel time for tertiary care, and congruence with planning districts.
22	"Medical care facility," as used in this title, means any institution, place, building or agency, whether
23	or not licensed or required to be licensed by the Board or the State Mental Health, Mental Retardation
24 25	and Substance Abuse Services Board, whether operated for profit or nonprofit and whether privately owned or privately operated or owned or operated by a local governmental unit, (i) by or in which
23 26	health services are furnished, conducted, operated or offered for the prevention, diagnosis or treatment of
20 27	human disease, pain, injury, deformity or physical condition, whether medical or surgical, of two or
28	more nonrelated mentally or physically sick or injured persons, or for the care of two or more
29	nonrelated persons requiring or receiving medical, surgical or nursing attention or services as acute,
30	chronic, convalescent, aged, physically disabled or crippled or (ii) which is the recipient of
31	reimbursements from third-party health insurance programs or prepaid medical service plans. For
32	purposes of this article, only the following medical care facilities shall be subject to review:
33	1. General hospitals.
34	2. Sanitariums.
35	 Nursing homes. Intermediate care facilities.
36 37	5. Extended care facilities.
38	6. Mental hospitals.
39	7. Mental retardation facilities.
40	8. Psychiatric hospitals and intermediate care facilities established primarily for the medical,
41	psychiatric or psychological treatment and rehabilitation of alcoholics or drug addicts.
42	9. Specialized centers or clinics or that portion of a physician's office developed for the provision of
43	outpatient or ambulatory surgery, cardiac catheterization, computed tomographic (CT) scanning, gamma
44	knife surgery, lithotripsy, magnetic resonance imaging (MRI), magnetic source imaging (MSI), positron
45 46	emission tomographic (PET) scanning, radiation therapy, [nuclear medicine imaging, not a part of any
46 47	<i>center for specialized cardiology diagnostic procedures</i>] or such other specialty services as may be designated by the Board by regulation

5 0	The term "medical care facility" shall not include any facility of (i) the Department of Mental Health,
51	Mental Retardation and Substance Abuse Services; or (ii) any nonhospital substance abuse residential
52	treatment program operated by or contracted primarily for the use of a community services board under
53	the Department of Mental Health, Mental Retardation and Substance Abuse Services' Comprehensive

Plan; or (iii) a physician's office, except that portion of a physician's office described above in subdivision 9 of the definition of "medical care facility"; or (iv) the Woodrow Wilson Rehabilitation Center of the Department of Rehabilitative Services. "Project" means 54 55 56

- "Project" means: 1. Establishment of a medical care facility; 58
- 59 2. An increase in the total number of beds or operating rooms in an existing medical care facility;

3. Relocation at the same site of ten beds or ten percent of the beds, whichever is less, from one existing physical facility to another in any two-year period; however, a hospital shall not be required to obtain a certificate for the use of ten percent of its beds as nursing home beds as provided in § 32.1-132;

4. Introduction into an existing medical care facility of any new nursing home service, such as intermediate care facility services, extended care facility services, or skilled nursing facility services, regardless of the type of medical care facility in which those services are provided;

5. Introduction into an existing medical care facility of any new cardiac catheterization, computed 67 68 tomographic (CT) scanning, gamma knife surgery, lithotripsy, magnetic resonance imaging (MRI), magnetic source imaging (MSI), medical rehabilitation, neonatal special care, obstetrical, open heart 69 surgery, positron emission tomographic (PET) scanning, psychiatric, organ or tissue transplant service, 70 radiation therapy, [nuclear medicine imaging, not a part of any center for specialized cardiology 71 72 diagnostic procedures] substance abuse treatment, or such other specialty clinical services as may be designated by the Board by regulation, which the facility has never provided or has not provided in the 73 74 previous twelve months;

75 6. Conversion of beds in an existing medical care facility to medical rehabilitation beds or 76 psychiatric beds;

77 7. The addition by an existing medical care facility of any medical equipment for the provision of
78 cardiac catheterization, computed tomographic (CT) scanning, gamma knife surgery, lithotripsy, magnetic
79 resonance imaging (MRI), magnetic source imaging (MSI), open heart surgery, positron emission
80 tomographic (PET) scanning, radiation therapy, or other specialized service designated by the Board by
81 regulation. Replacement of existing equipment shall not require a certificate of public need; or

82 8. Any capital expenditure of five million dollars or more, not defined as reviewable in subdivisions
83 1 through 7 of this definition, by or in behalf of a medical care facility. However, capital expenditures
84 between one and five million dollars shall be registered with the Commissioner pursuant to regulations
85 developed by the Board.

86 "Regional health planning agency" means the regional agency, including the regional health planning
87 board, its staff and any component thereof, designated by the Virginia Health Planning Board to perform
88 the health planning activities set forth in this chapter within a health planning region.

89 "State Medical Facilities Plan" means the planning document adopted by the Board of Health which
90 shall include, but not be limited to, (i) methodologies for projecting need for medical care facility beds
91 and services; (ii) statistical information on the availability of medical care facilities and services; and
92 (iii) procedures, criteria and standards for review of applications for projects for medical care facilities
93 and services.

94 "Virginia Health Planning Board" means the statewide health planning body established pursuant to
95 § 32.1-122.02 which serves as the analytical and technical resource to the Secretary of Health and
96 Human Resources in matters requiring health analysis and planning.
