10 11	WHEREAS, the Implementation of the Federal Mandates Act was enacted by the 1995 General Assembly; and
12 13 14 15	WHEREAS, by enacting this Act, the General Assembly asserted its legislative authority to establish that the people of Virginia, acting through their elected officials in Virginia government, have the responsibility and authority to establish policy in and for Virginia pertaining to federal programs mandated in federal statutes; and
16 17 18 19	WHEREAS, the intent of the General Assembly is to assure the primacy of the Commonwealth of Virginia's legal and political authority to implement in and for Virginia the policy mandated by federal statutes and to vigorously challenge and scrutinize the extent and scope of authority asserted by federal executive branch agencies when federal agency actions and interpretations are inconsistent with Virginia
20 21 22 23 24 25	policy and exceed the lawful authority of the federal government or are not required by federal law; and WHEREAS, the Act required state officials charged with the duty of implementing any federal statute to implement the law as required by the federal statute in good faith and exercising a critical view toward the provisions of any federal regulation, guideline, or policy in order to identify those provisions of any federal regulation, guideline, or policy that are inconsistent with Virginia policy or do not advance Virginia policy in a cost-effective manner; and

31 32 33 34 35	RESOLVED by the House of Delegates, the Senate concurring, That the Joint Legislative Audit and Review Commission (JLARC) be directed to study state compliance with the Implementation of the Federal Mandates Act. All agencies of the Commonwealth shall provide assistance to JLARC for this study, upon request.
33 36 37 38 39	The Joint Legislative Audit and Review Commission shall complete its work in time to submit its findings and recommendations to the Governor and the 2001 Session of the General Assembly as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents.
