9 WHEREAS, Marta Villalpando Wyatt of Fairfax City, a leader of and advocate for Northern
10 Virginia's Hispanic community, died on May 28, 1999; and

11 WHEREAS, born in Baltimore, Marta Wyatt grew up near Mexico City and graduated from the 12 Universidad Iberoamericana in 1964 with a degree in philosophy; and

WHEREAS, Marta Wyatt moved to Northern Virginia in 1964, where she quickly became involved
 in the local Hispanic community, serving as Hispanic services director for the Catholic Charities of the
 Diocese of Arlington from 1985 to 1989; and

WHEREAS, in 1989, Marta Wyatt became director of the Hispanic Committee of Virginia, a
 nonprofit organization that assists Hispanics with immigration problems, emergency aid, and
 employment and housing needs; and

19 WHEREAS, under Marta Wyatt's leadership, the Hispanic Committee grew into a powerful and20 influential voice for Hispanics, with a budget exceeding \$1 million annually and a staff of 21; and

WHEREAS, an exceptionally effective advocate for Hispanic causes and issues, Marta Wyatt
 combined a strong will with a gentle manner, a powerful voice with a nonconfrontational style, to
 become one of the most influential and respected leaders in the Hispanic community; and

WHEREAS, Marta Wyatt often became personally involved in helping individuals, as when she ledthe effort to raise \$60,000 for a bone marrow transplant for the baby of a local Salvadoran couple; and

WHEREAS, Marta Wyatt was equally effective in her official capacity, persuading Fairfax County to
 restore its grant to the Hispanic Committee by pointing out that her group was more efficient than the
 county's similar operation; and

WHEREAS, a remarkably capable, generous, and popular leader, Marta Wyatt will be sorely missed
by the Hispanic community of Northern Virginia on whose behalf she worked with such passion and
effectiveness; now, therefore, be it
