## **SENATE BILL NO. 104**

Offered January 12, 2000

A BILL to amend and reenact § 24.2-643 of the Code of Virginia, relating to voting procedures at the polls; voter identification project.

## Referred to Committee on Privileges and Elections

Be it enacted by the General Assembly of Virginia:

1. That § 24.2-643 of the Code of Virginia is amended and reenacted as follows: 11

§ 24.2-643. Qualified voter permitted to vote; procedures at polling place.

A. After the polls are open, each qualified voter at a precinct shall be permitted to vote. The officers 13 14 of election shall ascertain that a person offering to vote is a qualified voter before admitting him to the 15 voting booth and furnishing an official ballot to him.

B. An officer of election shall ask the voter for his full name and current residence address and 16 17 repeat, in a voice audible to party and candidate representatives present, the full name and address stated by the voter. The officer shall ask any voter, who is subject to the requirement to vote in person 18 pursuant to subsection B of § 24.2-416.1, or as authorized by subsection E below, to present any one of 19 20 the following forms of identification: his Commonwealth of Virginia voter registration card, his social 21 security card, any preprinted form of identification which shows his name and address, any preprinted 22 form of identification which shows his name and signature, or any preprinted form of identification 23 which shows his name and photograph.

24 If the voter's name is found on the registered voter list, if he is qualified to vote in the election, and 25 if no objection is made, an officer shall mark the voter's name on the registered voter list, an officer 26 shall enter, opposite the voter's preprinted name on the pollbook, the first or next consecutive number from the voter count form provided by the State Board, an officer shall provide the voter with the 27 28 official ballot, and another officer shall admit him to the voting booth.

29 If a voter, who is subject to the requirement to vote in person pursuant to subsection B of 30 § 24.2-416.1, is entitled to vote except that he is unable to present one of the forms of identification 31 listed above, he shall be allowed to vote after signing a statement, subject to felony penalties for false 32 statements pursuant to § 24.2-1016, that he is the named registered voter who he claims to be. 33

A voter may be accompanied into the voting booth by his child age fifteen or younger.

34 C. If the current residence address stated by the voter is different from the address shown on the 35 registered voter list, the officer of election shall furnish the voter with a change of address form prescribed by the State Board. Upon its completion, the voter shall sign the prescribed form, subject to 36 37 felony penalties for making false statements pursuant to § 24.2-1016, which the officer of election shall 38 then place in an envelope provided for such forms for transmission to the general registrar who shall 39 then transfer or cancel the registration of such voter pursuant to Chapter 4 (§ 24.2-400 et seq.) of this 40 title.

41 D. At the time the voter is asked his full name and current residence address, the officer of election 42 shall ask any voter for whom an identification number other than a social security number is recorded 43 on the registered voter list if he presently has a social security number and note that number on the list if the voter is able to provide it. Any social security numbers so provided shall be entered by the 44 45 general registrar in the voter's record on the voter registration system.

E. The Board is authorized to conduct a pilot project requiring mandatory voter identification at the 46 polling place, in up to ten jurisdictions, if agreed to by the jurisdiction's local electoral board. Proper 47 voter identification includes a Virginia voter identification card, social security card, or any preprinted **48** 49 form of identification with the voter's name and address, preprinted form of identification with name and signature, or preprinted form of identification with name and photo. Additionally, if a voter is entitled to 50 vote, except that he fails to present one of the forms of identification listed above, he shall be allowed 51 to vote, by signing a statement, subject to felony penalties for false statements pursuant to § 24.2-1016, 52 53 that he is the named registered voter he claims to be.
