That the Code of Virginia is amended by adding sections numbered 58.1-3650.848 through 8 58.1-3650.857 as follows: 9 § 58.1-3650.848. Property of Needle's Eye Ministries, Inc. 10 A. Needle's Eye Ministries, Inc., a nonprofit corporation, is hereby designated as a religious organization within the context of Section 6 (a) (6) of Article X of the Constitution of Virginia. 11 12 B. Real property located in the City of Richmond owned by Needle's Eye Ministries, Inc., and used 13 by such organization exclusively for religious purposes on a nonprofit basis as set forth in subsection A of this section, is hereby determined to be exempt from local taxation. 14 15 § 58.1-3650.849. Property of Reston Interfaith Housing Corporation, Inc. 16 A. Reston Interfaith Housing Corporation, Inc., a nonprofit corporation, is hereby designated as a 17 charitable and benevolent organization within the context of Section 6 (a) (6) of Article X of the 18 Constitution of Virginia. 19 B. Property located in Fairfax County and the Town of Herndon, owned by Reston Interfaith 20 Housing Corporation and used by it exclusively for charitable and benevolent purposes on a nonprofit 21 basis as set forth in subsection A of this section, is hereby determined to be exempt from local taxation. 22 § 58.1-3650.850. Property of The Women's Center. 23 A. The Women's Center, a nonprofit corporation, is hereby designated as a charitable and benevolent 24 organization within the context of Section $\delta$ (a) (6) of Article X of the Constitution of Virginia. B. Property located at 133 Park Street, N.E., Unit 3 in Fairfax County and the Town of Vienna, 25 26 owned by The Women's Center and used by it exclusively for charitable and benevolent purposes on a 27 nonprofit basis as set forth in subsection A of this section, is hereby determined to be exempt from local 28 taxation. 29 § 58.1-3650.851. Property of the Rivanna Conservation Society. 30 A. The Rivanna Conservation Society, a nonprofit organization, is hereby designated as a charitable 31 organization within the context of Section 6 (a) (6) of Article X of the Constitution of Virginia. 32 B. Real property located in the Scheier Natural Area in Fluvanna County, owned by the Rivanna 33 Conservation Society and used by it exclusively for charitable purposes on a nonprofit basis as set forth 34 in subsection A of this section, is hereby determined to be exempt from local taxation. 35 § 58.1-3650.852. Property of Springboard Recreation Club, Inc. 36 A. Springboard Recreation Club, Inc., a nonprofit corporation, is hereby designated as a public park 37 and playground organization within the context of Section 6 (a) (6) of Article $\bar{X}$ of the Constitution of 38 Virginia. 39 B. Real and personal property located in Fairfax County at 6500 Deepford Street, which is owned by 40 Springboard Recreation Club, Inc., and used by it exclusively for public park and playground purposes 41 on a nonprofit basis as set forth in subsection A of this section, is hereby determined to be exempt from 42 local taxation. § 58.1-3650.853. Property of Parent Educational Advocacy Training Center, Inc. 43 44 A. Parent Educational Advocacy Training Center, Inc., a nonprofit corporation, is hereby designated 45 as a charitable organization within the context of Section 6 (a) (6) of Article X of the Constitution of 46 Virginia. B. Personal property located in Fairfax County at 6320 August Drive, owned by Parent Educational 47 48 Advocacy Training Center, Inc., and used by it exclusively for charitable purposes on a nonprofit basis 49 as set forth in subsection A of this section, is hereby determined to be exempt from local taxation. 50 § 58.1-3650.854. Property of The Royal Pool Association, Inc. 51 A. The Royal Pool Association, Inc., a nonprofit corporation, is hereby designated as a public park and playground organization within the context of Section 6 (a) (6) of Article X of the Constitution of 52 53 Virginia. 54 B. Property located at 5220 Parkway Place in Fairfax County, which is owned by The Royal Pool 55 Association, Inc., and used by it exclusively for public park and playground purposes on a nonprofit

basis as set forth in subsection A of this section, is hereby determined to be exempt from local taxation.

57 § 58.1-3650.855. Property of BizNet, Inc.

58 A. BizNet, Inc., a nonprofit corporation, is hereby designated as a benevolent organization within the context of Section 6 (a) (6) of Article X of the Constitution of Virginia. 59

B. Property located in the City of Virginia Beach, owned by BizNet, Inc., and used by it exclusively 60 61 for benevolent purposes on a nonprofit basis as set forth in subsection A of this section, is hereby 62 determined to be exempt from local taxation.

§ 58.1-3650.856. Property of Virginia Beach Community Trust Exempt Fund. 63

A. Virginia Beach Community Trust Exempt Fund, a nonprofit organization, is hereby designated as 64 65 a benevolent organization within the context of Section 6 (a) (6) of Article X of the Constitution of 66 Virginia.

67 B. Property located in the City of Virginia Beach, owned by Virginia Beach Community Trust Exempt Fund and used by it exclusively for benevolent purposes on a nonprofit basis as set forth in 68 69 subsection A of this section, is hereby determined to be exempt from local taxation.

§ 58.1-3650.857. Property of Central Virginia Housing Coalition, Inc. 70

A. Property of Central Virginia Housing Coalition, Inc., a nonprofit corporation, is hereby designated as a charitable organization within the context of Section 6 (a) (6) of Article X of the 71 72 73 Constitution of Virginia.

74 B. Property located in the City of Fredericksburg, owned by Central Virginia Housing Coalition, 75 Inc., and used by it exclusively for charitable purposes on a nonprofit basis as set forth in subsection A 76 of this section, is hereby determined to be exempt from local taxation.
