VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact §§ 24.2-643 and 24.2-651.1 of the Code of Virginia, relating to voting 3 procedures at the polls; voter identification; certain challenged votes.

6 Be it enacted by the General Assembly of Virginia:

7 1. That §§ 24.2-643 and 24.2-651.1 of the Code of Virginia are amended and reenacted as follows: 8 § 24.2-643. Qualified voter permitted to vote; procedures at polling place; voter identification.

9 A. After the polls are open, each qualified voter at a precinct shall be permitted to vote. The officers 10 of election shall ascertain that a person offering to vote is a qualified voter before admitting him to the voting booth and furnishing an official ballot to him. 11

B. An officer of election shall ask the voter for his full name and current residence address and 12 13 repeat, in a voice audible to party and candidate representatives present, the full name and address stated by the voter. The officer shall ask any the voter, who is subject to the requirement to vote in person 14 15 pursuant to subsection B of § 24.2-416.1, or as authorized by subsection E below, to present any one of the following forms of identification: his Commonwealth of Virginia voter registration card, his social 16 security card, any preprinted form of identification which shows his name and address, any preprinted 17 form of identification which shows his name and signature, or any preprinted form of identification 18 19 which shows his name and photograph his valid Virginia driver's license, or any other identification card issued by a government agency of the Commonwealth, one of its political subdivisions, or the 20 21 United States; or any valid employee identification card containing a photograph of the voter and issued 22 by an employer of the voter in the ordinary course of the employer's business.

23 If the voter's name is found on the registered voter list, if he presents one of the forms of 24 identification listed above, if he is qualified to vote in the election, and if no objection is made, an 25 officer shall mark the voter's name on the registered voter list, an officer shall enter, opposite the 26 voter's preprinted name on the pollbook, the first or next consecutive number from the voter count form 27 provided by the State Board; an officer shall provide the voter with the official ballot; and another 28 officer shall admit him to the voting booth.

29 If a voter, who is subject to the requirement to vote in person pursuant to subsection B of 30 <u>§ 24.2-416.1</u>, is entitled to vote except that he is unable to present one of the forms of identification 31 listed above, he shall be allowed to vote after signing a statement, subject to felony penalties for false 32 statements pursuant to § 24.2-1016, that he is the named registered voter who he claims to be. 33

A voter may be accompanied into the voting booth by his child age fifteen or younger.

34 C. If the current residence address stated by the voter is different from the address shown on the 35 registered voter list, the officer of election shall furnish the voter with a change of address form prescribed by the State Board. Upon its completion, the voter shall sign the prescribed form, subject to 36 37 felony penalties for making false statements pursuant to § 24.2-1016, which the officer of election shall 38 then place in an envelope provided for such forms for transmission to the general registrar who shall 39 then transfer or cancel the registration of such voter pursuant to Chapter 4 (§ 24.2-400 et seq.) of this 40 title.

41 D. At the time the voter is asked his full name and current residence address, the officer of election 42 shall ask any voter for whom an identification number other than a social security number is recorded 43 on the registered voter list if he presently has a social security number and note that number on the list 44 if the voter is able to provide it. Any social security numbers so provided shall be entered by the 45 general registrar in the voter's record on the voter registration system.

E. The Board is authorized to conduct a pilot project requiring mandatory voter identification at the 46 polling place, in up to ten jurisdictions, if agreed to by the jurisdiction's local electoral board. Proper 47 voter identification includes a Virginia voter identification card, social security card, or any preprinted 48 49 form of identification with the voter's name and address, preprinted form of identification with name and 50 signature, or preprinted form of identification with name and photo. Additionally, if a voter is entitled to vote, except that he fails to present one of the forms of identification listed above, he shall be allowed 51 52 to vote, by signing a statement, subject to felony penalties for false statements pursuant to § 24.2-1016, 53 that he is the named registered voter he claims to be.

54 § 24.2-651.1. Voter who is shown as having already voted; challenge and procedure for voting; voter 55 identification.

56 The officers of election shall challenge the vote of any person who offers to vote, who is listed on SB1ER

57 the precinct registered voter list, and whose name is marked to indicate that he has already voted in58 person in the election.

59 When the person is challenged, an officer shall explain to him the basis for the challenge. If the 60 person being challenged states that he has not voted and is qualified, an officer shall ask the voter to present one of the following forms of identification: his Commonwealth of Virginia voter registration 61 62 card, his social security card, any preprinted form of identification which shows his name and address, any preprinted form of identification which shows his name and signature, or any preprinted form of 63 identification which shows his name and photograph his valid Virginia driver's license, or any other 64 identification card issued by a government agency of the Commonwealth, one of its political 65 subdivisions, or the United States; or any valid employee identification card containing a photograph of 66 67 the voter and issued by an employer of the voter in the ordinary course of the employer's business.

If the person presents the requested form of identification showing him to be the person listed on the
precinct registered voter list, an officer of election shall give him the form set out in § 24.2-651 for the
person to sign subject to felony penalties for making false statements pursuant to § 24.2-1016.

71 If the person challenged refuses to sign the statement, he shall not be permitted to vote. If, however, 72 he signs the statement, he shall be permitted to vote on the voting system in use at the precinct.

73 When the voter has shown the requested identification, has signed the statement, and is permitted to

74 vote, the officers of election shall mark the precinct registered voter lists and shall indicate that the

75 person has signed the required statement in accordance with the instructions of the State Board of

76 Elections.
