10	Be it enacted by the General Assembly of Virginia:
11	1. That § 24.2-908 of the Code of Virginia is amended and reenacted as follows:
12	§ 24.2-908. Statement of organization.
13	[Each A. Except as provided in subsection B, each] political committee which anticipates receiving
14	contributions or making expenditures in excess of \$200 in a calendar year shall file with the State Board
15	a statement of organization (i) within ten days after its organization or, if later, within ten days after the
16	date on which it has information which causes the committee to anticipate it will receive contributions
17	or make expenditures in excess of \$200 or on which it otherwise becomes subject to the provisions of
18	this chapter, and (ii) annually thereafter by January 15.
1 9	The statement of organization shall include:
20	1. The name and address of the committee and its address in the Commonwealth;
2 1	2. The names, addresses, and relationships of affiliated or connected organizations;
$\overline{22}$	3. The area, scope, or jurisdiction of the committee;
23	4. The name, residence and business addresses address, and position of the custodian, if any, of
24	books and accounts and his residence address in the Commonwealth;
25	5. The name, residence address, and position of other principal officers, including officers and
26	members of the finance committee, if any, and including at least one principal officer who is a resident
27	of the Commonwealth and who serves as treasurer or chief executive officer of the committee;
28	6. The name, address, office sought, and party affiliation of each individual whom the committee is
29	supporting or opposing for nomination or for election to any public office whatever or, if supporting the
30	entire ticket of any party, the name of the party;
31	7. In the event the committee is promoting or opposing a referendum, the subject of the referendum,
32	the date and location of the election, and a statement whether the committee is promoting or opposing
33	the referendum question;
34	8. In the case of an inaugural fund committee, the name, address, and office to which elected of the
35	person on whose behalf the committee is organized;
36	9. A statement whether the committee is a continuing one;
37	10. The disposition of residual funds which will be made in the event of dissolution;
38	11. A listing of all banks, safe-deposit boxes, or other repositories The designated sole depository to
39	be used for the receipt and holding of funds and contributions received by the committee, in an account
40	in a financial institution within the Commonwealth; and
41	12. Such other information as shall be required by the State Board.
42	Any change in information previously submitted in a statement of organization shall be reported to
43	the State Board within ten days following the change.
44	Any committee which, after having filed one or more statements of organization, disbands or
45	determines it will no longer receive contributions or make expenditures during the calendar year in an
46	aggregate amount exceeding \$200 shall so notify the State Board.
47	[B. Notwithstanding the provisions of subsection A, a political committee that is established or
48	controlled by a corporation doing business in Virginia shall provide the following information in its
49	statement of organization in lieu of the information required in subdivisions 1, 4, 5, and 11:
50	1. The name and address of the committee;
51	4. The name, residence and business addresses, and position of the custodian, if any, of books and
52	accounts;
