That § 19.2-390.1 of the Code of Virginia is amended and reenacted as follows: 11 § 19.2-390.1. Sex Offender and Crimes Against Minors Registry; maintenance; access. 12 A. The Department of State Police shall keep and maintain a Sex Offender and Crimes Against 13 14 Minors Registry, separate and apart from all other records maintained by it. The purpose of the Registry shall be to assist the efforts of law-enforcement agencies to protect their communities from repeat sex 15 offenders and to protect children from becoming victims of criminal offenders by helping to prevent 16 such individuals from being hired or allowed to volunteer to work directly with children. 17 18 The Registry shall include conviction data received from the courts, including the disposition records for juveniles tried and convicted in the circuit courts pursuant to § 16.1-269.1, on convictions for 19 20 offenses for which registration is required as defined in § 19.2-298.1 and registrations and reregistrations 21 received from persons required to do so by § 19.2-298.1, whether such requirement arose before, on, or 22 after July 1, 1997. 23 The Registry shall also include a separate indication that a person has been convicted of a sexually 24 violent offense. 25 Upon receipt of a registration or reregistration pursuant to § 19.2-298.1 the State Police shall forthwith notify the chief law-enforcement officer of the county, city or town of the locality listed as the 26 27 person's address on the registration or reregistration and any person who has requested automatic 28 notification pursuant to § 19.2-390.2. The State Police shall forthwith transmit the appropriate 29 information as required by the Federal Bureau of Investigation for inclusion in the National Sex 30 Offender Registry. The State Police shall promulgate regulations governing the giving of notice to the chief local law-enforcement officer, the operation and maintenance of the Registry and the expungement 31 32 of records on persons who are deceased, whose convictions have been reversed or who have been 33 pardoned, and those for whom an order of expungement or relief from frequent registration has been 34 entered pursuant to §§ 19.2-298.3, 19.2-298.4 or § 19.2-392.1. B. Except as provided in subsection A, C or D, Registry information shall be disseminated upon request made directly to the Department of State Police or to the State Police through a local 35 36 law-enforcement agency. Such information may be disclosed to any person requesting information on a 37 38 specific individual in accordance with subsection C. The Department of State Police shall make Registry information available, upon request, to criminal justice agencies including local law-enforcement 39 40 agencies through the Virginia Criminal Information Network (VCIN). Registry information provided 41 under this section shall be used for the purposes of the administration of criminal justice, for the 42 screening of current or prospective employees or volunteers or otherwise for the protection of the public in general and children in particular. Use of the information for purposes not authorized by this section 43 44 is prohibited and a willful violation of this section with the intent to harass or intimidate another shall 45 be punished as a Class 1 misdemeanor. The VCIN and any form or document used by the Department of State Police to disseminate 46 47 information from the Registry shall provide notice that any unauthorized use of the information with the intent to harass or intimidate another is a crime punishable as a Class 1 misdemeanor. The Department **48** of State Police may by regulation establish a fee not to exceed fifteen dollars for responding to requests 49 50 for information from the Registry pursuant to this subsection. Any fees collected shall be deposited in a 51 special account to be used to offset the costs of administering the Registry. C. Information regarding a specific person requested pursuant to subsection B shall be disseminated 52 53 upon receipt of an official request form which may be submitted directly to the Department of State 54 Police or to the State Police through a local law-enforcement agency. The official request form shall include a statement of the reason for the request; the name and address of the person requesting the 55 information; the name, address and, if known, the social security number of the person about whom 56 information is sought; and such other information as the State Police may require to ensure reliable 57

identification. Unlawful use of the information for purposes of intimidating or harassing another is

prohibited and a willful violation of this section shall be punished as a Class 1 misdemeanor.

D. On or before January 1, 1999, the State Police shall develop and maintain a system for making 60 certain Registry information on violent sex offenders publicly available by means of the Internet. The information to be made available shall include the offender's name; all aliases which he has used or 61 62 63 under which he may have been known; the date and locality of the conviction and a brief description of the offense; his date of birth, current address and photograph; and such other information as the State 64 Police may from time to time determine is necessary to preserve public safety. The system shall be 65 secure and not capable of being altered except by [or through] the State Police. The system shall be 66 updated each business day with newly received registrations and reregistrations. The State Police shall 67 remove all [outdated and inaccurate information information which it knows to be inaccurate] from 68 69 the Internet system.

E. No liability shall be imposed upon any law-enforcement official who disseminates information orfails to disseminate information in good faith compliance with the requirements of this section, but this

72 provision shall not be construed to grant immunity for gross negligence or willful misconduct.
