2 *An Act to amend the Code of Virginia by adding sections numbered 46.2-746.4:2 and 46.2-746.6:2 and*
3 *by adding in Article 10 of Chapter 6 of Title 46.2 sections numbered 46.2-749.32, 46.2-749.33, and*
4 *46.2-749.34 and to repeal §§ 46.2-746.4:1 and 46.2-746.6:1 of the Code of Virginia, relating to*
5 *special license plates; submarine service veterans; supporters of the American Red Cross; naval*
6 *aviators; insurance agents; supporters of the Family and Children's Trust Fund; fees.*

9 **Be it enacted by the General Assembly of Virginia:**

10 **1. That Code of Virginia is amended by adding sections numbered 46.2-746.4:2 and 46.2-746.6:2**
11 **and by adding in Article 10 of Chapter 6 of Title 46.2 sections numbered 46.2-749.32, 46.2-749.33,**
12 **and 46.2-749.34 as follows:**

13 § 46.2-746.4:2. *Special license plates for submarine service veterans.*

14 *On receipt of an application and written evidence that the applicant is a submarine service veteran,*
15 *the Commissioner shall issue special license plates to submarine service veterans.*

16 § 46.2-746.6:2. *Special license plates for supporters of the American Red Cross.*

17 *On receipt of an application, the Commissioner shall issue special license plates to supporters of the*
18 *American Red Cross.*

19 § 46.2-749.32. *Special license plates; naval aviators.*

20 *On receipt of an application and written evidence that the applicant is or has been a naval aviator,*
21 *the Commissioner shall issue to the applicant special license plates.*

22 § 46.2-749.33. *Special license plates; insurance agents.*

23 *On receipt of an application therefor, the Commissioner shall issue to the applicant special license*
24 *plates bearing the legend: INSURANCE AGENT.*

25 § 46.2-749.34. *Special license plates for supporters of Family and Children's Trust Fund; fees.*

26 *On receipt of an application and payment of the fee prescribed by this section, the Commissioner*
27 *shall issue special license plates for supporters of the Family and Children's Trust Fund.*

28 *The annual fee for plates issued pursuant to this section shall be twenty-five dollars plus the*
29 *prescribed fee for state license plates. For each such twenty-five-dollar fee collected in excess of 1,000*
30 *registrations pursuant to this section, fifteen dollars shall be paid into the state treasury and credited to*
31 *the Family and Children's Trust Fund.*

32 **2. That §§ 46.2-746.4:1 and 46.2-746.6:1 of the Code of Virginia are repealed.**
