9	Be it enacted by the General Assembly of Virginia:
10	1. That § 20-109 of the Code of Virginia is amended and reenacted as follows:
11	§ 20-109. Changing maintenance and support for a spouse; effect of stipulations as to maintenance
12	and support for a spouse; cessation upon cohabitation, remarriage or death.
13	A. Upon petition of either party the court may increase, decrease, or terminate the amount or
14	duration of any spousal support and maintenance that may thereafter accrue, whether previously or
15	hereafter awarded, as the circumstances may make proper. Upon order of the court based upon clear and

16 convincing evidence that the spouse receiving support has been habitually cohabiting with another person in a relationship analogous to a marriage for one year or more commencing on or after July 1, 17 1997, the court may decrease or shall terminate spousal support and maintenance unless (i) otherwise 18 19 provided by stipulation or contract or (ii) the spouse receiving support proves by a preponderance of the 20 evidence that termination of such support would constitute a manifest injustice.

B. The court may consider a modification of an award of spousal support for a defined duration upon petition of either party filed within the time covered by the duration of the award. Upon consideration of the factors set forth in subsection E of § 20-107.1, the court may increase, decrease or 21 22 23 24 terminate the amount or duration of the award upon finding that (i) there has been a material change in 25 the circumstances of the parties, not reasonably in the contemplation of the parties when the award was 26 made or (ii) an event which the court anticipated would occur during the duration of the award and 27 which was significant in the making of the award, does not in fact occur through no fault of the party 28 seeking the modification.

29 C. In suits for divorce, annulment and separate maintenance, and in proceedings arising under 30 subdivision A 3 or subsection L of § 16.1-241, if a stipulation or contract signed by the party to whom 31 such relief might otherwise be awarded is filed before entry of a final decree, no decree or order directing the payment of support and maintenance for the spouse, suit money, or counsel fee or 32 33 establishing or imposing any other condition or consideration, monetary or nonmonetary, shall be 34 entered except in accordance with that stipulation or contract. If such a stipulation or contract is filed 35 after entry of a final decree and if any party so moves, the court shall modify its decree to conform to 36 such stipulation or contract.

37 D. Unless otherwise provided by stipulation or contract, spousal support and maintenance shall 38 terminate upon the death of either party or remarriage of the spouse receiving support.
