WHEREAS, Dr. Featherston was the district president of the Young Women's Christian Council and served as district missionary of the Norfolk District for many years; and

WHEREAS, on the state level, Dr. Featherston served as chairperson of the Program Committee, president of the State Young Women's Christian Council, president of the Board of Education, and assistant state supervisor and state supervisor; and

WHEREAS, at the time of her death, Dr. Featherston was state supervisor emeritus of the Department of Women, Second Jurisdiction, State of Virginia, Church of God in Christ, Inc.; and

WHEREAS, nationally, Dr. Featherston was chairperson of Area 1A, a member of the board of directors of the Lillian Brooks Coffey Home, and a member of the executive board of the International Women's Department of the Church of God in Christ; and

WHEREAS, a woman of great achievement, compassion, and integrity, Dr. Mary Mays Featherston will be sorely missed by her large and loving family, by the parishioners of the C. H.
