That § 46.2-392 of the Code of Virginia is amended and reenacted as follows: 11 § 46.2-392. Suspension of license or issuance of a restricted license on conviction of reckless driving; 12 13 probationary conditions required; generally. 14 In addition to the penalties for reckless driving prescribed in § 46.2-868 any court may suspend any 15 license issued to a convicted person under Articles 1 through 9 (§ 46.2-300 et seq.) of this chapter for a period of not less than ten days nor more than six months and the court shall require the convicted 16 person to surrender his license so suspended to the court where it will be disposed of in accordance with 17 § 46.2-398. Additionally, any person convicted of a reckless driving offense which the court has reason 18 19 to believe is alcohol-related or drug-related may be required as a condition of probation or otherwise to 20 enter into and successfully complete an alcohol safety action program. 21 If a person so convicted has not obtained the license required by this chapter, or is a nonresident, the 22 court may direct in the judgment of conviction that he shall not, for a period of not less than ten days 23 or more than six months as may be prescribed in the judgment, drive any motor vehicle in the 24 Commonwealth. The court or the clerk of court shall transmit the license to the Commissioner along 25 with the report of the conviction required to be sent to the Department. The court may, in its discretion and for good cause shown, provide that such person be issued a 26 27 restricted permit to operate a motor vehicle during the period of suspension for any or all of the 28 following purposes: (i) travel to and from his place of employment; (ii) travel during the hours of such 29 person's employment if the operation of a motor vehicle is a necessary incident of such employment; 30 (iii) travel to and from school if such person is a student, upon proper written verification to the court 31 that such person is enrolled in a continuing program of education; or (iv) such other medically necessary travel for health care services as the court deems necessary and proper upon written verification of need 32 33 by a licensed health professional; or (v) travel to and from an alcohol safety action program. The court 34 shall order the surrender of such person's license to operate a motor vehicle to be disposed of in 35 accordance with the provisions of § 46.2-398 and shall forward to the Commissioner a copy of its order 36 entered pursuant to this subsection, which shall specifically enumerate the restrictions imposed and 37 contain such information regarding the person to whom such a permit is issued as is reasonably necessary to identify such person. The court shall also provide a copy of its order to the person who 38 39 may operate a motor vehicle on the order until receipt from the Commissioner of a restricted license. A 40 copy of such order and, after receipt thereof, the restricted license shall be carried at all times while 41 operating a motor vehicle. Any person who operates a motor vehicle in violation of any restrictions imposed pursuant to this section shall be punished as provided in subsection C of § 46.2-301. No 42 restricted license issued pursuant to this section shall permit any person to operate a commercial motor 43 vehicle as defined in the Virginia Commercial Driver's License Act (§ 46.2-341.1 et seq.). 44
