Patrons—Shuler and Griffith; Senator: Marye 6 7 Referred to Committee on Counties, Cities and Towns 8 9 Be it enacted by the General Assembly of Virginia: **1.** § 1. Title. 10 This act shall be known and may be cited as the Virginia Tech/Montgomery Regional Airport 11 12 Authority Act. 13 § 2. Creation; public purpose. 14 If the governing bodies of the Towns of Blacksburg and Christiansburg and the County of 15 Montgomery and the Board of Visitors of Virginia Polytechnic Institute and State University by resolution support the formation of a regional airport authority to operate and lease the existing 16 Virginia Tech Airport and a memorandum of understanding is approved for the purpose of joining such 17 authority, an airport authority to be known as the Virginia Tech/Montgomery Regional Airport Authority 18 19 (hereinafter "the Authority") shall thereupon exist for such participating entities and shall exercise its 20 powers and functions as prescribed herein. 21 In any suit, action, or proceeding involving the validity or enforcement of or relating to any contract 22 of the Authority, the Authority shall be deemed to have been created as a political subdivision and body 23 corporate and to have been established and authorized to transact business and exercise its powers 24 hereunder upon proof of the adoption of a resolution as aforesaid by the governing bodies of such 25 towns, county and university supporting the formation of such Authority. A copy of such resolution duly certified by the clerks of the towns, county and university by which it is adopted shall be admissible as 26 27 evidence in any suit, action, or proceedings. Any political subdivision of the Commonwealth is 28 authorized to join such Authority pursuant to the terms and conditions of this Act. 29 The ownership and operation by the Authority of modern and efficient air transportation and related 30 facilities and the exercise of powers conferred by this Act are proper and essential governmental 31 functions and public purposes and matters of public necessity for which public moneys may be spent and private property acquired through the power of eminent domain as hereinafter provided. The purposes of such Authority shall be to develop a regional airport based on the mission of servicing 32 33 corporate executive markets and other general aviation markets, obtaining grants, loans and other funding for airport improvements and other activities, and in promoting and assisting in regional 34 35 36 economic development. The actual airport operations to be created hereunder shall be limited to 37 functioning as a C-1 general aviation airport as designated by the Virginia Department of Aviation. 38 § 3. Definitions. 39 As used in this act the following words and terms have the following meanings unless a different 40 meaning clearly appears from the context: 41 "Act" means the Virginia Tech/Montgomery Regional Airport Authority Act. "Airport Lease" means the leasehold interest conveyed by Virginia Polytechnic Institute and State 42 43 University to the Authority for the Airport Real Property. "Airport Lease closing" means the date upon which the Airport Lease is entered into by the 44 45 appropriate parties. "Airport Real Property" means the real property and improvements located thereon which the 46 47 existing Airport and improvements are situated and the additional real property shown on the Master Plan as part of the Airport, all in the Town of Blacksburg, Montgomery County, Virginia. 48 49 "Authority" means the Virginia Tech/Montgomery Regional Airport Authority created by this Act. 50 "Board" means the governing body of the Authority. 51 "Bonds" means any bonds, notes, debentures, grant obligations or other evidence of financial 52 indebtedness issued by this Authority pursuant to this Act. 53

"Commonwealth" means the Commonwealth of Virginia.

54 "Facility" means any and all airports, terminals, runways, hangars, loading facilities, repair shops, 55 parking areas, facilities for the preparation of in-flight meals, restaurants and accommodations for temporary or overnight use by passengers, and other facilities functionally related to the needs or 56 convenience of passengers, shipping companies and airlines, and industrial and commercial facilities, 57 58 purchased, constructed or otherwise acquired or operated by the Authority pursuant to the provisions of 86

59 this Act. Any facility may consist of or include any or all buildings or other structures, improvements, 60 additions, extensions, replacements, machinery, or equipment, together with appurtenances, lands, rights

61 in land, aviation rights, water rights, franchises, furnishings, landscaping, utilities, approaches, 62 roadways, or other facilities necessary or desirable in connection therewith or incidental thereto.

63 "Master Plan" means the Master Plan Study for Virginia Tech Airport, produced by Greiner, Inc. of 64 Richmond, Virginia dated October 1995.

"Operating deficit" means the amount of budgeted expenditures in excess of anticipated revenues 65 66 from operations or capital budgets.

67 "Participating political subdivisions" means the Towns of Blacksburg and Christiansburg, the County of Montgomery and Virginia Polytechnic Institute and State University or any other political subdivision **68** 69 that may join or has joined the Authority pursuant to §§ 4 and 5 of this Act.

"Premises" means the Airport Real Property together with the ownership interests the University has 70 71 acquired in facilities, equipment, aircraft, improvements, easements, rights, licenses (including but not limited to any licenses related to the sale of aviation fuel), privileges and other property rights that have 72 been or may hereafter be provided at or in connection with the Airport from time to time, including 73 74 without limiting the generality of the foregoing, the landing field and any extensions thereof or additions 75 thereto, roadways, runways, aprons, taxiways, signage, maintenance equipment, fuel storage and 76 delivery equipment, fire protection and safety equipment, sewage and water facilities, flood lights, 77 landing lights, beacons, control tower, weather observation equipment, navigational equipment, signals, communication equipment, radio aids, radar and all other conveniences for flying, landings and 78 79 take-offs of aircraft, buildings (including but not limited to storage buildings, maintenance areas, 80 hangars, offices and garages), parking areas, fences, roadways, lounges and waiting rooms, public spaces and any and all appurtenances to the foregoing. 81

"Political subdivision" means a county, city, town, public body, public authority (including an airport 82 83 authority), or institution (including an institution of higher education), or commission of the 84 Commonwealth. 85

"Term" means the duration of the Airport Lease.

"University" means Virginia Polytechnic Institute and State University.

"Virginia Tech/Montgomery Regional Airport" means the airport facilities located on the Airport 87 88 Real Property, the Premises, and any other facilities necessary, incidental, or convenient to the 89 operation of the facilities. 90

§ 4. Participating political subdivision.

At the time of creation of the Authority, each participating political subdivision shall have entered or 91 92 shall into a memorandum of understanding by and among each of the participating political 93 subdivisions setting forth the terms and conditions of the intended formation of the Authority and the 94 leasing of the Airport Real Property.

95 No pecuniary liability of any kind shall be imposed upon any participating political subdivision 96 because of any act, omission, agreement, contract, tort, malfeasance, misfeasance, or nonfeasance by or 97 on the part of the Authority or any member thereof, or its agents, servants, or employees, except as 98 otherwise provided in this Act with respect to contracts and agreements between the Authority and any 99 other political subdivision. 100

§ 5. Appointment of members of the Board.

101 The powers of the Authority shall be vested in the members of the Board. The Board shall consist of 102 five persons. Each participating political subdivision shall have the right to appoint one member of the Board and all participating political subdivisions shall jointly appoint the fifth member of the Board by 103 unanimous approval of the participating political subdivisions. Each member of the Board shall be 104 appointed for a term of four years, except that the initial members of the Board representing the 105 participating political subdivisions shall be appointed for the following staggered terms to be selected by 106 107 lot by the members of the Board at its initial meeting: one member shall be appointed for a term of one 108 year; one member shall be appointed for a term of two years; one member shall be appointed for a term of three years; and one member shall be appointed for a term of four years. The jointly appointed 109 110 member shall be appointed for an initial term of four years. Upon the expiration of the original term of 111 office of a member of the Board, that member may continue to exercise all powers as a member of the 112 Board until that person's successor is duly appointed and qualified.

113 Any vacancy in the membership of the Board other than by expiration of term shall be filled by the 114 governing body that appointed the member or, in the case of the jointly appointed member, by approval of the governing bodies. The person appointed to fill such vacancy shall serve for the unexpired term 115 only. Each participating political subdivision shall have the absolute right to remove its appointee to the 116 Board, with or without cause, at any time, and all participating political subdivisions shall have the 117 absolute right to remove their joint appointee to the Board, with or without cause, at any time by 118 119 resolution of all of the governing bodies of the participating political subdivisions. Except as may be prohibited by the Constitution of Virginia, members of the Board may include elected or appointed 120

officials, employees, managers, administrators or officers of any participating political subdivision. 121

122 Membership in the Authority may be expanded only in accordance with the terms of a joinder 123 agreement adopted by the governing bodies of all participating political subdivisions. Only a political 124 subdivision may become a participating political subdivision of the Authority.

125 Each member of the Board may be reimbursed by the Authority for the amount of actual expenses 126 incurred by him in the performance of his duties in addition to such other salary or benefit, or both, to 127 be determined by the Authority.

128 § 6. Organization.

129 A majority of the members of the Board shall constitute a quorum and the vote of a majority of 130 members of the Board shall be necessary for any action taken by the Board. Each member of the Board 131 shall be entitled to one vote, except as otherwise set forth herein. No vacancy in the membership of the 132 Board shall impair the right of a quorum to exercise all the rights and perform all the duties of the 133 Authority. The Board shall elect from its membership a chairmen, vice-chairman and secretary-treasurer 134 of the Board; such officers to serve in these capacities for terms of two years, except that an initial 135 member of the Board whose term on the Board is for one year may be elected to serve in such capacity 136 for a term of one year and if re-appointed to the Board may thereupon be re-elected to serve in such 137 capacity.

138 The Authority shall hold regular meetings at such times and places as may be established by its 139 bylaws.

140 The Board may make and from time to time amend and repeal bylaws, not inconsistent with this Act, 141 governing the manner in which the Authority's business may be transacted and in which the power 142 granted to it may be enjoyed. The Board may appoint such committees as it may deem advisable and fix 143 the duties and responsibilities of such committees. 144

§ 7. Powers.

- 145 The Authority is hereby granted all powers necessary or appropriate to carry out the purposes of 146 this Act, including the following, to:
- 147 1. Adopt bylaws for the regulation of its affairs and the conduct of its business;
- 148 2. Sue and be sued in its own name;
- 149 3. Have perpetual succession;
- 150 4. Adopt a corporate seal and alter the same;
- 151 5. Maintain offices at such places as it may designate;

152 6. Acquire, establish, construct, enlarge, improve, maintain, equip, operate and regulate any airport, 153 air landing fields, structures, aviation facilities and other property incidental thereto;

154 7. Construct, install, maintain and operate facilities for the servicing and storage of aircraft and for 155 the accommodation of cargo, freight and mail, and for the accommodation and comfort of air travelers, 156 and for lease or sale to industrial or commercial users, and to purchase and sell equipment and 157 supplies incidental to the operation of its airport facilities;

158 8. Grant to others the privilege to operate for profit concessions, leases, and franchises, including 159 but not limited to the sale of airplanes, fuel, parts and equipment, maintenance of aircraft, the 160 accommodation and comfort of person using its facilities and the providing of ground transportation 161 and parking facilities for such persons, and such concessions, leases and franchises shall be exclusive or 162 limited as determined by the Authority:

163 9. Determine fees, rates and charges for the use of its facilities;

164 10. Apply for and accept gifts, grants of money or gifts, grants or loans of other property or other 165 financial assistance from, or to borrow money from or issue bonds to, the United States of America and 166 agencies and instrumentalities thereof, the Commonwealth and political subdivisions, agencies and 167 instrumentalities thereof, or any other person or entity whether public or private, for or in aid of the 168 construction, acquisition, ownership, operation, maintenance or repair of the Authority's facilities 169 (whether or not such facilities are then in existence) or for the payment of principal of any indebtedness 170 of the Authority, interest thereon or other costs incident thereto and to borrow money on such terms as 171 the Authority deems advisable, and to this end the Authority shall have the power to render such 172 services, comply with such conditions and execute such agreements and legal instruments as may be 173 necessary, convenient or desirable or imposed as a condition to such financial aid, loans, grants or 174 other assistance;

175 11. Establish, operate and maintain a foreign trade zone and otherwise to expedite and encourage 176 foreign commerce;

177 12. Appoint, employ or engage such officers, employees, architects, engineers, attorneys, accountants, 178 financial advisors, investment bankers, and other advisors, consultants and agents as may be necessary 179 or appropriate, and to fix their duties and compensation;

180 13. Establish personnel rules;

181 14. Own, purchase, lease, obtain options upon, acquire by gift, grant, bequest or otherwise acquire 182 any property, real, personal or intangible, or any interest therein, and in connection therewith to create, 183 assume or take subject to any indebtedness secured by such property;

184 15. Sell, lease, grant options upon, exchange, transfer, assign, or otherwise dispose of any property, 185 real or personal, or any interest therein;

186 16. Make, assume and enter into all contracts, leases and arrangements necessary or incidental to 187 the exercise of its powers, including contracts for the management or operation of all or any part of its 188 facilities:

189 17. Adopt, amend, and repeal rules and regulations for the use, maintenance, and operation of its 190 facilities and governing the conduct of persons and organizations using its facilities and to enforce such 191 rules and regulations and all other rules, regulations, ordinances, and statutes relating to its facilities;

192 18. Purchase and maintain insurance and to provide indemnification on behalf of any person who is 193 or was a director, officer, employee or agent of the Authority against any liability asserted against or 194 incurred by him in any such capacity or arising out of his status as such;

195 19. Exercise police power upon Authority facilities for the enforcement of all state and local laws;

196 20. Place a lien upon any or all of its property, not including the University's property rights not 197 assigned hereby, or otherwise secure its debts; and

198 21. Do all things necessary or convenient to the purposes of this Act.

199 § 8. Name of airport.

200 The name of the airport operated by the Authority shall be the Virginia Tech/Montgomery Regional 201 Airport. The name of this airport, or any other airport owned and/or operated by the Authority, may be 202 changed upon approval of a majority of the members of the Board. 203

§ 9. Rules, regulations, and minimum standards.

204 The Authority shall have the power to adopt, amend, and repeal rules, regulations, and minimum 205 standards, for the use, maintenance, and operation of its facilities and governing the conduct of persons 206 and organizations using its facilities.

207 The Authority's rules and regulations shall be available for public inspection in the Authority's 208 principal office.

209 The Authority's rules and regulations relating to: (i) traffic, including but not limited to motor 210 vehicle speed limits and the location of and charges for public parking; (ii) access to Authority 211 facilities, including but not limited to solicitation, handbilling, and picketing; and (iii) aircraft operation 212 and maintenance, shall have the force of law, as shall any other rule or regulation of the Authority that 213 shall contain a determination by the Authority that it is necessary to accord the same force and effect of 214 law in the interest of the public safety. However, with respect to motor vehicle traffic rules and regulations, the Authority shall obtain the approval of the appropriate official of the political subdivision in which such rules or regulations are to be enforced. The violation of any rule or 215 216 regulation of the Authority relating to motor vehicle traffic shall be tried and punished in the same 217 218 manner as if it had been committed on the public roads of the participating political subdivision in 219 which such violation occurred. All other violations of the rules and regulations having the force of law 220 shall be punishable as misdemeanors.

221 All ordinances, rules, regulations, and minimum standards duly adopted for the regulation, 222 administration and operation of Virginia Tech/Montgomery Regional Airport, in force at the effective 223 date of this Act, shall remain in full force insofar as they or any part thereof are not inconsistent with 224 the provisions of this Act until amended or repealed in accordance with this Act. 225

§ 10. Eminent domain.

226 The Authority is hereby granted full power to exercise the right of eminent domain within the 227 participating political subdivisions other than the University in the acquisition of any lands, easements, 228 privileges, or other property interests that are necessary for airport purposes including, where necessary 229 to provide unobstructed air space for the landing and taking off of aircraft utilizing its airport, aviation 230 easements over lands or water outside the boundaries of its airport even though such aviation easement 231 may be either inconsistent with the continued use of such land for the same purposes for which it had 232 been used prior to such acquisition, or inconsistent with the maintenance, preservation, and renewal of 233 any structure or any tree or other vegetation standing or growing on said land at the time of such 234 acquisition. Proceedings for the acquisition of such land, easements, and privileges by condemnation 235 may be instituted and conducted in the name of the Authority in accordance with Title 25 of the Code of 236 Virginia. The University shall not obstruct or impede any Airport uses or plans that are shown on the 237 Master Plan. 238

§ 11. Reports.

239 The Authority shall keep minutes of its proceedings, which shall be open to public inspection during 240 normal business hours, and shall keep suitable records of all its financial transactions and shall arrange to have the same audited annually by an independent certified public accountant. Copies of each such 241 242 audit shall be furnished to each participating political subdivision and shall be open to public inspection. The Authority shall be deemed a local governmental agency subject to the requirements of 243

244 the State and Local Government Conflict of Interests Act (§ 2.1-639.1 et seq.).

245 § 12. Procurement.

246 All contracts that the Authority may let for professional services, nonprofessional services, or 247 materials shall be subject to the Virginia Public Procurement Act (§ 11-35 et seq.).

248 § 13. Deposit and investment of funds.

249 Except as provided by contract with a participating political subdivision, all moneys received 250 pursuant to the authority of this Act, whether as proceeds from the sale of bonds or as revenues or 251 otherwise, shall be deemed to be trust funds to be held and applied solely as provided in this Act. All 252 moneys of the Authority shall be deposited as soon as practicable in a separate account or accounts in 253 one or more banks or trust companies organized under the laws of the Commonwealth or national 254 banking associations having their principal offices in the Commonwealth. Such deposits shall be 255 continuously secured in accordance with the Virginia Security for Public Deposits Act (§ 2.1-359 et 256 seq.).

257 Funds of the Authority not needed for immediate use or disbursement may, subject to the provisions 258 of any contract between the Authority and the holders of its bonds, be invested in securities that are 259 considered lawful investments for public sinking funds or other public funds as set forth in Chapter 18 260 of Title 2.1. 261

§ 14. Authority to issue bonds.

262 The Authority shall have the power to issue bonds from time to time in its discretion, for any of its 263 purposes, including the payment of all or any part of the cost of Authority facilities and including the 264 payment or retirement of bonds previously issued by it. The Authority may issue such types of bonds as 265 it may determine, including (without limiting the generality of the foregoing) bonds payable, both as to 266 principal and interest: (i) from its revenues and receipts generally and (ii) exclusively from the revenues and receipts of certain designated facilities or loans whether or not they are financed in whole or in 267 268 part from the proceeds of such bonds. Any such bonds may be additionally secured by a pledge of any 269 grant or contribution from a participating political subdivision, the Commonwealth or any political 270 subdivision, agency or instrumentality thereof, and federal agency or any unit, private corporation, 271 co-partnership, association, or individual, as such participating political subdivision, or other entities may be authorized to make under general law or by pledge of any income or revenues of the Authority 272 273 or by mortgage or encumbrance of any property or facilities of the Authority. Unless otherwise provided 274 in the proceeding authorizing the issuance of the bonds, or in the trust indenture or agreement securing 275 the same, all bonds shall be payable solely and exclusively from the revenues and receipts of a particular facility or loan. Bonds may be executed and delivered by the Authority at any time and from 276 277 time to time, may be in such form and denominations and of such terms and maturities, may be in 278 registered or bearer form either as to principal or interest or both, may be payable in such installments 279 and at such time or times not exceeding forty years from the date thereof, may be payable at such place 280 or places whether within or without the Commonwealth, may bear interest at such rate or rates, may be 281 payable at such time or times and at such places, may be evidenced in such manner, and may contain 282 such provisions not inconsistent herewith, all as shall be provided and specified by the Authority in 283 authorizing each particular bond issue.

284 If deemed advisable by the Authority, there may be retained in the proceedings under which any 285 bonds of the Authority are authorized to be issued an option to redeem all or any part thereof as may 286 be specified in such proceedings, at such price or prices and after such notice or notices and on such 287 terms and conditions as may be set forth in such proceedings and as may be briefly recited on the face 288 of the bonds, but nothing herein contained shall be construed to confer on the Authority any right or 289 option to redeem any bonds except as may be provided in the proceedings under which they shall be 290 issued. Any bonds of the Authority may be sold at public or private sale in such manner and from time 291 to time as may be determined by the Authority to be most advantageous, and the Authority may pay all 292 costs, premiums, and commissions that it may deem necessary or advantageous in connection with the 293 issuance thereof. Issuance by the Authority of one or more series of bonds for one or more purposes 294 shall not preclude it from issuing other bonds in connection with the same facility or any other facility. 295 but the proceedings whereunder any subsequent bonds may be issued shall recognize and protect any 296 prior pledge or mortgage made for any prior issue of bonds. Any bonds of the Authority at any time 297 outstanding may from time to time be refunded by the Authority by the issuance of its refunding bonds 298 in such amount as the Authority may deem necessary, but not exceeding an amount sufficient to refund 299 the principal of the bonds so to be refunded, together with any unpaid interest thereon and any costs, 300 premiums, or commissions necessary to be paid in connection therewith. Any such refunding may be 301 effected whether the bonds to be refunded shall have then matured or shall thereafter mature, either by 302 sale of the refunding bonds and the application of the proceeds thereof to the payment of the bonds to be refunded thereby, or by the exchange of the refunding bonds for the bonds to be refunded thereby, 303 304 with the consent of the holders of the bonds so to be refunded, and regardless of whether or not the

305 bonds to be refunded were issued in connection with the same facilities or separate facilities, and
306 regardless of whether or not the bonds proposed to be refunded shall be payable on the same date or
307 on different dates or shall be due serially or otherwise.

308 All bonds shall be signed by the chairman or vice-chairman of the Authority or shall bear his 309 facsimile signature, and the corporate seal of the Authority or a facsimile thereof shall be impressed or 310 imprinted thereon and attested by the signature of the secretary (or the secretary-treasurer) or the 311 assistant secretary (or assistant secretary-treasurer) of the Authority or shall bear his facsimile signature, and any coupons attached thereto shall bear the facsimile signature of said chairman. In case 312 313 any officer whose signature or a facsimile of whose signature shall appear on any bonds or coupons 314 shall cease to be an officer before delivery of such bonds, such signature, or such facsimile, shall 315 nevertheless be valid and sufficient for all purposes the same as if he had remained in office until such delivery. When the signatures of both the chairman or the vice-chairman and the secretary (or the 316 317 secretary-treasurer) or the assistant secretary (or the assistant secretary-treasurer) are facsimiles, the 318 bonds must be authenticated by a corporate trustee or other authenticating agent approved by the 319 Authority.

320 If the proceeds derived from a particular bond issue, due to error of estimates or otherwise, shall be 321 less than the cost of the Authority facilities for which such bonds were issued, additional bonds may in 322 like manner be issued to provide the amount of such deficit, and, unless otherwise provided in the 323 proceedings authorizing the issuance of the bonds of such issue or in the trust indenture securing the same, shall be deemed to be of the same issue and shall be entitled to payment from the same fund 324 325 without preference or priority of the bonds of the first issue. If the proceeds of the bonds of any issue shall exceed such cost, the surplus may be deposited to the credit of the sinking fund for such bonds or 326 327 may be applied to the payment of the cost of any additions, improvements, or enlargements of the 328 Authority facilities for which such bonds shall have been issued.

329 Prior to the preparation of definitive bonds, the Authority may, under like restrictions, issue interim 330 receipts or temporary bonds with or without coupons, exchangeable for definitive bonds when such 331 bonds shall have been executed and are available for delivery. The Authority may also provide for the 332 replacement of any bonds that shall become mutilated or shall be destroyed or lost. Bonds may be 333 issued under the provisions of this Act without obtaining the consent of any department, division, 334 commission, board, bureau or agency of the Commonwealth, and without any other proceedings or the 335 happening of any other conditions or things other than those proceedings, conditions, or things that are 336 specifically required by this Act; provided that nothing contained in this Act shall be construed as 337 affecting the powers and duties now conferred by law upon the State Corporation Commission.

All bonds issued under the provisions of this Act shall have and are hereby declared to have all the
qualities and incidents of and shall be and are hereby made negotiable instruments under the Uniform
Commercial Code of Virginia (§8.1-101 et seq.), subject only to provisions respecting registration of the
bonds.

In addition to all other powers granted to the Authority by this Act, the Authority is authorized to
provide for the issuance from time to time of notes or other obligations of the Authority for any of its
authorized purposes. All of the provisions of this Act that relate to bonds shall apply to such notes or
other obligations insofar as such provisions may be appropriate.

§ 15. Fees, rents, and charges.

347 The Authority is hereby authorized to and shall fix, revise, charge, and collect fees, rents, and other 348 charges for the use and services of any facilities. Such fees, rents, and other charges shall be so fixed 349 and adjusted as to provide a fund sufficient with other revenues to pay the cost of maintaining, 350 repairing, and operating the facilities and the principal and any interest on its bonds as the same shall become due and payable, including reserves therefor. Such fees, rents, and charges shall not be subject 351 352 to supervision or regulation by any commission, board, bureau, or agency of the Commonwealth or any 353 participating political subdivision. The fees, rents, and other charges received by the Authority, except 354 such part thereof as may be necessary to pay the cost of maintenance, repair, and operation and to 355 provide such reserves therefor as may be provided for in any resolution authorizing the issuance of such 356 bonds or in any trust indenture or agreement securing the same, shall to the extent necessary be set 357 aside at such regular intervals as may be provided in any such resolution or trust indenture or 358 agreement in a sinking fund or sinking funds pledged to, and charged with, the payment and the interest 359 on such bonds as the same shall become due, and the redemption price or the purchase price of such 360 bonds retired by call or purchase as therein provided. Such pledge shall be valid and binding from the 361 time when the pledge is made. So long as any of its bonds are outstanding, the fees, rents, and charges so pledged and thereafter received by the Authority shall immediately be subject to the lien of such 362 363 pledge without any physical delivery thereof or further act, and the lien of any such pledge shall be valid and binding as against all parties having claims of any kind in tort, contract, or otherwise against 364 365 the Authority irrespective of whether such parties have notice thereof. Neither the resolution nor any 366 trust indenture or agreement by which a pledge is created need be filed or recorded except in the

records of the Authority. The use and disposition of moneys to the credit of any such sinking fund shall 367 368 be subject to the provisions of the resolution authorizing the issuance of such bonds or of such trust 369 indenture or agreement.

370 § 16. Credit of Commonwealth and political subdivisions not pledged.

371 Bonds issued pursuant to the provisions of this Act shall not be deemed to constitute a debt of the 372 Commonwealth, or any political subdivision thereof other than the Authority, but such bonds shall be 373 payable solely from the funds provided therefor as herein authorized. All such bonds shall contain on 374 the face thereof a statement to the effect that neither the Commonwealth, nor any political subdivision 375 thereof, nor the Authority, except as may be otherwise stated, shall be obligated to pay the same or the 376 interest thereon or other costs incident thereto except from the revenues and money pledged therefor 377 and that neither the faith and credit nor the taxing power of the Commonwealth, or any political 378 subdivision thereof, is pledged to the payment of the principal of such bonds or the interest thereon or 379 other costs incident thereto.

380 All expenses incurred in carrying out the provisions of this Act shall be payable solely from the 381 funds of the Authority.

Bonds issued pursuant to the provisions of this Act shall not constitute an indebtedness within the 382 383 meaning of any debt limitation or restriction.

384 § 17. Members of the Board and persons executing bonds not liable thereon.

385 Neither the members of the Board nor any person executing the bonds shall be liable personally on 386 the Authority's bonds by reasons of the issuance thereof.

387 § 18. Security for payment of bonds; default.

388 The principal of and interest on any bonds issued by the Authority may be secured by a pledge of 389 the revenues and receipts out of which the same shall be made payable, and may be secured by a trust 390 indenture or agreement covering all or any part of the Authority facilities from which revenues or 391 receipts so pledged may be derived, including any enlargements of any additions to any such projects 392 thereafter made. The resolution under which the bonds are authorized to be issued and any such trust 393 indenture or agreement may contain any agreements and provisions respecting the maintenance of the 394 projects covered thereby, the fixing and collection of rents for any portions thereof leased by the 395 Authority to others, the creation and maintenance of special funds from such revenues and the rights 396 and remedies available in the event of default, all as the Authority shall deem advisable not in conflict 397 with the provisions hereof. Each pledge, agreement, and trust indenture made for the benefit or security 398 of any of the bonds of the Authority shall continue to be effective until the principal of and interest on 399 the bonds for the benefit of which the same were made shall have been fully paid. In the event of 400 default in such payment or in any agreements of the Authority made as a part of the contract under 401 which the bonds were issued, whether contained in the proceedings authorizing the bonds or in any 402 trust indenture or agreement executed as security therefor, may be enforced by mandamus, suit, action, 403 or proceeding at law or in equity to compel the Authority and the members, officers, agents, or **404** employees thereof to perform each and every term, provision and covenant contained in any trust 405 indenture or agreement of the Authority, the appointment of a receiver in equity, or by foreclosure of 406 any such trust indenture, or any one or more of said remedies.

407 § 19. Taxation.

408 The exercise of the powers granted by this Act shall in all respects be presumed to be for the benefit 409 of the inhabitants of the Commonwealth, for the increase of their commerce, and for the promotion of 410 their health, safety, welfare, convenience and prosperity, and as the operation and maintenance of any 411 project that the Authority is authorized to undertake will constitute the performance of an essential 412 governmental function, the Authority shall not be required to pay any taxes or assessments upon any 413 facilities acquired and constructed by it under the provisions of this Act and the bonds issued under the 414 provisions of this Act, their transfer and the income therefrom including any profit made on the sale 415 thereof, shall at all times be free and exempt from taxation by the Commonwealth and by any political 416 subdivision thereof. Unless exempted by the laws of the Commonwealth, persons, firms, partnerships, 417 associations, corporations, and organizations leasing property of the Authority or doing business on 418 property of the Authority shall be subject to and liable for payment of all applicable taxes of the 419 political subdivision in which such leased property lies or in which business is conducted including, but 420 not limited to, any leasehold tax on real property and taxes on tangible personal property and 421 machinery and tools, taxes for admission, taxes on hotel and motel rooms, taxes on the sale of tobacco 422 products, taxes on the sale of meals and beverages, privilege taxes and local general retail sales and 423 use taxes, taxes to be paid on licenses in respect to any business, profession, vocation or calling, and taxes upon consumers of gas, electricity, telephone, and other public utility services. 424 425

§ 20. Bonds as legal investments.

426 Bonds issued by the Authority under the provisions of this Act are hereby made securities in which 427 all public officers and public bodies of the Commonwealth and its political subdivisions, all insurance

428 companies, trust companies, banking associations, investment companies, executors, administrators, 429 trustees, and other fiduciaries may properly and legally invest funds, including capital in their control 430 or belonging to them. Such bonds are hereby made securities that may properly and legally be 431 deposited with and received by any state or municipal officer or any agency or political subdivision of 432 the Commonwealth for any purpose for which the deposit of bonds or obligations is now or may 433 hereafter be authorized by law.

§ 21. Appropriation by political subdivision.

435 Any participating political subdivision or other political subdivision of the Commonwealth is authorized to provide services, to donate real or personal property and to make appropriations to the 436 437 Authority for the acquisition, construction, maintenance, and operation of the Authority's facilities. Any 438 such political subdivision is hereby authorized to issue its bonds, including, but not limited to general 439 obligation bonds, in the manner provided in the Public Finance Act (§ 15.2-2600 et seq.) or in any 440 applicable municipal charter for the purpose of providing funds to be appropriated to the Authority, and 441 such political subdivisions may enter into contracts obligating such bond proceeds to the Authority.

442 The Authority may agree to assume, or reimburse a participating political subdivision for any 443 indebtedness incurred by such participating political subdivision with respect to facilities conveyed by it 444 to the Authority. 445

§ 22. Operating deficit.

446 The board shall have full authority to adopt its operating and capital budgets on an annual fiscal 447 year (July 1 through June 30) basis, to amend the same from time to time, and for the operating deficit 448 to be divided equally among all participating political subdivisions. Each participating political 449 subdivision shall contribute its respective one-quarter share of the operating deficit each year and otherwise as required; however, such obligation shall be subject to and dependent upon annual 450 appropriations being made from time to time by the governing body of each such respective participating political subdivision, and as to the University, by normal approval of appropriations, and 451 452 453 shall not be deemed to constitute a debt of such participating political subdivisions within the meaning 454 of Article VII, Section 10 of the Constitution of Virginia, and as to the University, within the meaning of 455 Article X, Section 9 of the Constitution of Virginia, or any applicable statutory debt limitation. Should any participating political subdivision fail to contribute in full its proportionate share of the operating 456 deficit, it shall remain a member of the Authority but its representative on the board shall not be 457 458 entitled to cast a vote on any Authority matter until that participating political subdivision's share of the 459 operating deficit has been paid in full. Further, should any participating political subdivision fail to 460 contribute in full its proportionate share of the operating deficit, the Authority shall have a lien on any 461 share of the Authority's profit or surplus revenues otherwise entitled to be distributed to the 462 participating political subdivision. A participating political subdivision may contribute a portion or all of its share of the operating deficit through "in-kind" contributions, subject to the approval of such 463 464 contribution and valuation by the Authority.

465 § 23. Contracts with political subdivisions.

466 The Authority is authorized to enter into contracts with any one or more political subdivisions.

§ 24. Lease Agreement.

468 The University is authorized, directed and empowered to lease the Airport Real Property and the 469 Premises to the Authority and to make representations and warranties as follows:

470 1. The Authority is a political subdivision whose actions are exempt from the Commonwealth's rules 471 and regulations on its agencies and commissions as to demolition, alteration, capital process, temporary 472 building use requirements, and like regulations and requirements. The Authority is subject to local 473 building code requirements.

474 2. Upon the creation of the Authority, the University shall lease to the Authority and the Authority 475 shall lease from the University a leasehold interest in the Airport Real Property and the Premises for 476 use as an airport and related activities, and all appurtenances thereto and personal property defined in 477 subsection 3, which use, without limiting the generality hereof, shall include the right to repair, 478 maintain, condition, service, test, park or store aircraft and other equipment, to sell, dispose or 479 exchange aircraft, engines, accessories, aviation and other fuel, oil, greases, lubricants and other equipment and supplies, to transport, load and unload persons, cargo, property and mail, to provide 480 amenities (including food and lodging) to pilots, passengers, Authority employees, members of the public 481 482 and any other person, to operate and maintain a system of air traffic control and all activities related 483 thereto, and to acquire, construct, renovate and equip any and all improvements at the Premises. The 484 Airport Lease shall include provisions consistent with the terms of this section.

485 3. In connection with ownership of the Airport Real Property and the operation of the Airport, the 486 Premises include but are not limited to the personal property initially agreed to by the parties to the 487 Airport Lease. The University shall warrant and represent to the Authority that it will disclose known 488 defects in the Premises. The University's representation that it will disclose known defects shall not 489 include any representation or agreement to repair the same, if any. The Authority shall receive its

interest in the Airport Real Property and the Premises "as is." The parties shall agree that hazardous 490 waste or toxic waste, as either term is defined or designated by federal or state statute or regulation 491 492 existing prior to the creation of the Authority, is not included within the Premises or the Airport Real 493 Property and that the University shall cause any hazardous waste or toxic waste that is presently 494 located on the Airport Real Property prior to the creation of the Authority to be properly disposed of in 495 accordance with any applicable local, regional, state or federal statute, law, rule, regulation, order or 496 decree pertaining to environmental preservation, contamination, remediation or cleanup or to the 497 operation of any airport facility.

498 4. The Airport Lease closing shall be on or before July 15, 2001, or as soon thereafter as title can be examined and proper conveyance documents prepared and executed.

500 5. The initial term of the Airport Lease shall be for thirty years, subject to the option granted to the
501 Authority to renew the Airport Lease for two additional terms of ten years each under the same terms
502 and conditions as provided herein, at the same rental for said renewal terms.

503 6. The Airport Lease shall provide that the Authority will agree to pay and the University will agree 504 to accept for the use of the Premises granted hereunder, rent in the amount of one dollar per year. The 505 University shall warrant and represent that it has full power and authority to enter into the Airport 506 Lease, subject to this Act, that it has good and marketable title to the Premises, and that the University 507 has entered into no leases, agreements or restrictive covenants that would prohibit or interfere with the 508 uses of the Premises as an airport, other than its lease with the National Weather Service. The 509 University shall covenant and agree that the Premises shall be delivered to the Authority free from all 510 tenancies and occupancies, and free from all orders and notices and violations filed or entered by any 511 public or quasi-public authority and free from complaints and reports of violations, noted or existing in 512 or filed with any federal or state local authority, other than those leases already disclosed to the Authority. The Authority shall have, hold and enjoy the Premises and all the rights and privileges of the 513 514 Airport and the Premises granted in the Airport Lease.

515 7. The Airport Lease shall provide that the Authority shall operate, maintain and keep in good repair 516 the Airport and all appurtenances, facilities and services now or hereafter connected with the Airport. 517 The Authority shall operate the Airport in accordance with all applicable federal, state and local laws, 518 rules, regulations and ordinances. The Authority may make, assume and enter into all contracts, leases 519 and arrangements necessary or incidental to the exercise of its powers including contracts for the 520 management or operation of all or any part of the Airport. The Authority shall have the right to impose 521 and collect any charges, fees, tolls and assessments from any person or entity in amounts determined by 522 the Authority and as allowed by law in connection with the operation, maintenance, equipping, repair, 523 renovation and improvement of the Airport. The Authority may take any action, other than against the 524 University, it considers necessary to protect the aerial approaches of the Airport from obstructions and 525 may prevent any person from erecting any building or other structure that in the reasonable opinion of 526 the Authority would limit the usefulness of the Airport or constitute a hazard to aircraft using the 527 Airport. The University shall cooperate completely and fully with the Authority in the Authority's 528 operation of the Airport in accordance with the Airport Lease, and shall provide the Authority all 529 available information, data and documents relevant or necessary to the Authority's operation of the 530 Airport. The University shall have the option, but not the responsibility, to provide for security, public 531 safety or police duties on the Premises during the term of the Airport Lease. The University agrees not 532 to obstruct or interfere with the plans for the Airport as shown in the Master Plan.

533 8. The Authority, at its own cost and expense, may construct or install, in accordance with all 534 applicable laws and ordinances, in or on any space that is or may be leased to the Authority under the 535 Airport Lease, any buildings, structures or improvements, including equipment and storage tanks, on the 536 surface or underground, that it shall determine to be necessary for use in connection with the operation 537 of the Airport subject to the University's consent thereof, which consent shall not be unreasonably 538 withheld and shall be considered by the University based upon aesthetic considerations in architectural 539 plans and building finishes and materials to conform generally to the University's building 540 considerations. The Authority shall have the unrestricted right to alter, modify, repair and maintain any 541 buildings, structures or improvements now or hereafter existing on the Premises, subject to the 542 University's consent thereof, which consent shall not be unreasonably withheld and shall be considered 543 by the University based upon aesthetic considerations in architectural plans and building finishes and 544 materials to conform generally to the University's building considerations. The Authority may, within its 545 discretion, erect, install and remove signage as it deems appropriate on the Premises, other than the 546 University's stone signage in the main terminal. The Authority shall have the right to modify the Master 547 *Plan as it deems appropriate.*

548 9. The University shall assign in the Airport Lease to the Authority all warranties and all service
549 agreement rights that pertain to the Premises. All such manufacturer warranties and service agreements
550 shall be disclosed prior to the execution of the lease agreement. The assignment of warranties and

551 service agreement rights shall be effective as to any particular item of the Premises at the time that the **552** University transfers a leasehold interest in that particular item to the Authority.

553 10. The University shall cause all funds received by the University after the Airport Lease closing 554 that in any way arise from the University's operation of the Airport or that would have been deposited 555 in the normal course of business by the University had the Airport Lease closing not taken place, to be 556 paid to the Authority. The University shall assign to the Authority all right, title and interest in all 557 accounts receivable and the accounts payable that in any way arise from the University's operation of 558 the Airport or that would have been deposited or due in the normal course of business by the University 559 had the Airport Lease closing not taken place. The Authority shall agree to be responsible for and assume all contractual obligations of the University relating to the Airport, including those related to 560 561 federal grants, disclosed prior to the Airport Lease closing.

11. If the Premises are damaged by fire or other casualty, then the damage may be repaired by the 562 563 Authority at the expense of the Authority with reasonable promptness from the proceeds of casualty 564 insurance. If the Premises are damaged or rendered untenable by fire or other casualty to the extent 565 such that the Authority's architect certifies that the Premises cannot be completely repaired within 180 566 days after the casualty, then the Authority may, at its option, terminate the Airport Lease by giving 567 written notice of termination to the University within thirty days after the date the Authority receives 568 notice of such certification by the architect. The University may provide liability and casualty insurance 569 coverage for all or any portion of the Premises, to the extent possible, with the approval of the 570 Authority, which may be included as an 'in-kind' contribution of its portion of the deficit, if so approved 571 by the Authority.

572 12. Upon the expiration of the term or any renewal thereof, whichever is later, any buildings,
573 structures, alterations, additions and improvements affixed to the Premises shall become the property of
574 the University and shall be surrendered with the Premises.

575 13. The Authority may at any time mortgage, encumber, or assign any of its leasehold rights under
576 the Airport Lease only for the purpose of providing security for the issuance of bonds, the receipt of
577 grants or the borrowing of money by the Authority or for such other purposes as it shall deem
578 necessary.

579 14. The University shall not be liable for any injury to persons or any loss or damage to property 580 resulting from the negligence of the Authority or the Authority's agents or employees. The Authority 581 shall, at all times during the term of the Airport Lease, or any renewal thereof, carry or provide for the 582 carrying with an insurance carrier or insurance carriers licensed to operate in the Commonwealth, 583 public liability insurance with limits of liability of not less than twenty million dollars with respect to 584 personal injury, ten million dollars with respect to property damage, and an appropriate coverage for 585 casualty. Any of the foregoing insurance coverages may be obtained from a risk management pool, self-insurance program or similar arrangement provided by the University in which the Authority may 586 587 participate or engage in, if approved by the Authority. The University shall be listed as an additional 588 insured on all of the foregoing policies and coverages. The Authority shall agree to defend legal actions 589 against the University claiming liability under this section.

590 15. The University shall transfer all aviation, business, financial and other records and date of any 591 type pertaining to the Airport to the Authority.

592 16. The University shall represent and warrant that it has provided to the other participating 593 political subdivisions no later than July 15, 2001: (i) complete copies of any title insurance policies, 594 binders or commitments and any abstracts or similar opinions as to the state of title at any time of or 595 encumbrances at any time affecting the Airport Real Property that the University may have in its 596 possession, (ii) all surveys of the Airport Real Property, (iii) all permits, licenses or documents 597 pertaining to governmental permission of any sort relating to or affecting the Airport Real Property, and (iv) all notices, reports, filings or similar documents made by the University and sent to any 598 599 governmental authority concerning the University's ownership of the Airport Real Property or operation 600 of the Airport.

601 17. The Authority's obligation to lease the Premises shall be subject to receipt by the Authority of a
602 Phase I Environmental Assessment acceptable to the Authority and indicating that the Premises does not
603 pose a substantial present or potential hazard to human health or the environment. Such Phase I
604 Environmental Assessment shall be furnished by the University at the University's expense. Upon the
605 termination of the Authority's leasehold interest in the Premises, the Authority shall provide to the
606 University, at the Authority's expense, a Phase I Environmental Assessment of the Premises.

607 18. The University shall agree to use its best efforts to facilitate the transfer to the Authority of all
608 permits, licenses or other permissions that are necessary for the continued operation of the Airport by
609 the Authority after leasehold title to the Airport Real Property is held by the Authority, and to procure
610 the agreement and consent of the Federal Aviation Administration and Virginia Department of Aviation
611 to the Authority's operation of the Airport, as may be required by law. Should any such permits,
612 licenses, consents, agreements or other permissions not be transferable, the Authority shall use its best

efforts to acquire them, and in such case the University shall agree that the Airport will be operated in
the name of the University as necessary until the Authority acquires any such necessary permits,
licenses, consents, agreements or other permissions.

616 19. The University shall grant the Authority full access to the Airport Real Property and the
617 Premises in order for the Authority's agents, employees and representatives to perform any and all
618 testing, inspection or studies concerning the Airport Real Property or Premises. The University shall
619 represent and warrant that should it or any other agency or institution of the Commonwealth exercise
620 any powers of eminent domain over the Airport Real Property or the Premises without the written
621 consent of the Authority, the Authority may terminate the Airport Lease.

622 20. Any obligation of the Authority or the University that is delayed or not performed due to acts of
623 God, strike, riot or war (whether declared or undeclared), shall not constitute a default hereunder and
624 shall be performed within a reasonable time after the end of such cause for delay or nonperformance.

625 21. If any term or provision of the Airport Lease or the application thereof to any person or
626 circumstances shall, to any extent, be illegal, invalid or unenforceable, the remainder of the Airport
627 Lease, or the application of such term or provision to persons of circumstances other than those to
628 which it is held invalid or unenforceable, shall not be affected thereby, and all other terms and
629 provisions of the Airport Lease shall be valid and enforced to the fullest extent permitted by law.

630 22. At the request of the Authority, the University shall execute and acknowledge a memorandum of
631 lease in recordable form, indicating the names and address of the Authority and the University, a
632 description of the Premises, the commencement and expiration dates of the term, options for renewal,
633 and other provisions hereof at the Authority's option.

634 23. The University shall cause the Premises to be insured against liability and risk of loss by 635 adequate liability, property and casualty insurance at all times prior to the time that the Authority takes 636 leasehold title to and possession of the Premises. In the event of any leasehold damage or loss to any 637 item of the Premises that occurs prior to the time that the Authority takes title to and possession of that 638 item of the Premises, the University shall repair, restore or replace that item so that the Authority 639 receives that item (or the substantial equivalent thereof) in not less than the same condition than the 640 item was in prior to such damage or loss.

641 24. No later than the date of the Airport Lease closing, the Authority shall offer employment to the
642 University employees listed on a schedule to the Airport Lease, except for those who are no longer
643 employed in good standing by the University at that time, and the University shall consent to such offers
644 of employment.

645 25. The Authority shall agree to maintain contractual agreements with various vendors formerly
646 made with the University until the expiration of the present terms of those contracts to the extent
647 allowed by said vendors. Copies of all such contracts shall be provided to the Authority by the
648 University before the parties prior to the Airport Lease closing. The University shall provide the
649 Authority at the time of Airport Lease closing a complete itemized list of Airport accounts receivable
650 and accounts payable.

651 26. The University shall represent and warrant that it shall assume all liability and responsibility if 652 any, and subject to the Virginia Tort Claims Act (§ 8.01-195.1 et seq.), for any and all claims, damages, 653 liabilities, actions, losses, costs or expenses of any kind in any way relating to, attributable to or 654 connected with the Airport Real Property, Premises or the Airport arising out of or related to 655 occurrences or actions or a failure or failures to act that occurred prior to the time of Airport Lease 656 closing.

657 27. The Authority shall represent and warrant that it shall assume all liability and responsibility for
658 any and all claims, damages, liabilities, actions, losses, costs or expenses of any kind in any way
659 relating to, attributable to or connected with the Airport Real Property, Premises or the Airport arising
660 out of or related to occurrences or actions or a failure or failures to act that occur subsequent to the
661 time of Airport Lease closing, to the extent permitted by law.

662 28. The University shall represent and warrant that there shall not exist at the time of the Airport
663 Lease closing, and shall not have existed at any time prior to the Airport Lease closing, any known
664 conditions or circumstances on or about the Airport Real Property that are or were in violation of any
665 local, regional, state or federal statute, law, rule, regulation, order or decree pertaining to
666 environmental preservation, contamination, remediation or cleanup or to the operation of any airport
667 facility.

668 29. The University shall represent and warrant that at the time of the Airport Lease closing there
669 shall not exist on or about the Airport Real Property any known toxic or hazardous waste, material or
670 other substance, as defined under any applicable local, regional, state or federal statute, law, rule,
671 regulation, order or decree, or any other condition, which might require any person or entity to report
672 to or notify the United States Environmental Protection Agency, the Virginia Department of
673 Environmental Quality or any other federal, state or local governmental or regulatory authority of the

presence of such toxic or hazardous waste, material, other substance, or other condition. 674

675 30. The University shall represent and warrant that at the time of the Airport Lease closing there 676 shall be no known existing, pending or threatened claims, administrative actions, lawsuits or legal 677 proceedings whatsoever with respect to the Airport Real Property and that no valid or substantial legal 678 basis for any such claim, action, lawsuit or proceeding now exists or shall exist at the time or the 679 Airport Lease closing, except as disclosed to the Authority prior to the Airport Lease closing.

680 31. The University shall represent and warrant that the Airport Real Property is in compliance with all applicable ordinances, laws, rules and regulations, and shall provide an opinion from the 681 University's counsel to this effect at the time of the Airport Lease closing. 682

32. The University shall represent and warrant that no mortgages, pledges, liens, encumbrances, 683 **684** conditions or other limitations exist regarding the Airport Real Property that would limit or prevent the Authority from using the Airport Real Property as an airport, except as may be set forth in any grants **685** 686 disclosed to the Authority prior to the Airport Lease closing.

687 33. The University shall represent and warrant that all access roads to the Airport will be 688 maintained in a manner adequate for access to the Airport by automobiles, trucks and other vehicles 689 that might reasonably be expected to utilize the Airport, that all such access roads will continue to be 690 used as public highways, and that the University shall execute perpetual easements in recordable form granting the Authority the right to use such access roads for Authority purposes. The University may **691** 692 alter such roads so long as similar access is provided and there is no material affect or violation of 693 aviation rules.

694 34. The University shall represent and warrant that, except as specifically described in the Airport 695 Lease, there shall be no contracts, agreements or other obligations concerning or affecting the Airport 696 *Real Property or operation of the Airport.*

697 35. The University shall represent and warrant that there shall be adequate utilities, including but 698 not limited to electricity, sewer, natural gas, and water service, available to the Airport. After the 699 Airport Lease closing, the Authority shall be responsible for all fees and charges for such utilities.

700 36. The University shall represent and warrant that there shall not be any defaults or breaches of 701 any University obligation whatsoever concerning or relating to any bond issue, contract or other 702 agreement that is related to or concerns the Airport Real Property or the University's ownership or 703 operation of the Airport, except as specifically described in the Airport Lease.

704 37. The University shall represent and warrant that copies of all policies of insurance, risk sharing 705 or similar agreements relating to the Airport Real Property, Premises or Airport, including 706 environmental liability insurance, if any, shall have been disclosed to the Authority prior to the Airport 707 Lease closing.

708 38. The University may provide in such Airport Lease an option to terminate such lease if the 709 Authority has operated the Airport facilities in such a manner in violation of the requirements of the 710 Virginia Department of Aviation that has resulted in the closure of operations at the Airport after having given notice to the Authority five years prior to termination pursuant to such option. 711

712 39. The University shall have the right to utilize non-improved areas of the Airport Real Property 713 not required by the Authority for Airport purposes, provided that such uses shall not violate any federal, state or local laws, rules or regulations and shall not interfere with the Authority's operation of the 714 715 Airport in accordance with this Act or the Airport Lease. The University shall also have the right to 716 utilize outbuildings located on the Airport Real Property, provided that such activities shall not violate 717 any federal, state or local laws, rules or regulations and shall not interfere with the Authority's 718 operation of the Airport in accordance with this Act or the Airport Lease. 719

§ 25. Liberal construction.

720 Neither this Act nor anything herein contained is or shall be construed as a restriction or limitation 721 upon any powers that the Authority might otherwise have under any laws of the Commonwealth, and 722 this Act is cumulative to any such powers; however, the borrowing of money or issuance of bonds under 723 the provisions of this Act need not comply with the requirements of any other law applicable to the 724 issuance of bonds, notes or other obligations. This Act does and shall be construed to provide a 725 complete, additional, and alternative method for the doing of the things authorized hereby and shall be 726 regarded as supplemental and additional to powers conferred by other laws. The provisions of this Act 727 are severable, and if any of its provisions shall be held unconstitutional by any court of competent 728 jurisdiction, the decision of such court shall not affect or impair any of the other provisions of this Act. 729 § 26. Application of local ordinances, service charges, and taxes upon leaseholds.

730 Nothing herein contained shall be construed to exempt the Authority's property from any applicable zoning, subdivision, erosion and sediment control, and fire prevention codes or from building 731 regulations of a political subdivision in which such property is located. Nor shall anything herein 732 contained exempt the property of the Authority from any service charge authorized by the General 733 Assembly pursuant to Article X, Section 6 (g) of the Constitution of Virginia, or exempt any lessee of 734 735 any of the Authority's property from any tax imposed upon his leasehold interest in such property or

736 upon the receipts derived therefrom. 737

§ 27. Existing contracts, leases, franchises, etc., not impaired.

738 No provisions of this Act shall relieve, impair, or affect any right, duty, liability, or obligation 739 arising out of any contract, concession, lease, or franchise now in existence except to the extent that such contract, concession, lease, or franchise may permit. Notwithstanding the foregoing provision of 740 741 this section, the Authority may renegotiate, renew, extend the term of, or otherwise modify at any time 742 any contract, concession, lease, or franchise now in existence in such manner and on such terms and 743 conditions as it may deem appropriate, provided that the operator of or under any said contract, 744 concession, lease, or franchise consents to said renegotiation, renewal, extension, or modification.

745 § 28. Withdrawal of membership.

746 A participating political subdivision may withdraw its membership in the Authority at the end of any 747 fiscal year if the withdrawing participating political subdivision has given notice to the Authority and all 748 other participating political subdivisions of its intention to withdraw at least six months before the end 749 of such fiscal year and the withdrawing participating political subdivision has paid in full its share of 750 the operating deficit, if any; provided that no participating political subdivision may withdraw its 751 membership in the Authority if the Authority has any outstanding debt without written approval of each 752 participating political subdivision. As used in this section, the term "debt" shall mean a monetary 753 obligation, whether general or limited in any way, to repay a loan or bond, or any long-term obligation, 754 whether absolute or contingent in any way, to refund or reimburse any agency or entity for grant funds 755 received by the Authority. 756

§ 29. Dissolution of Authority.

757 Whenever it shall appear to the board or to all participating political subdivisions that the need for 758 the Authority no longer exists, the Authority Board or all participating political subdivisions may 759 petition the Circuit Court of Montgomery County, Virginia, for the dissolution of the Authority. If the 760 Court determines that the need for the Authority as set forth in this Act no longer exists and that all 761 debts and other obligations of any kind have been fully paid or provided for,

762 1. The Court shall enter an order dissolving the Authority:

763 2. The Airport Real Property and Premises subject to the Airport Lease shall be returned to the 764 University as set forth in the Airport Lease to the extent required thereunder; and

765 3. The remaining assets of the Authority shall be distributed to the participating political 766 subdivisions in proportion to their respective shares of the operating deficit less any amounts owed to 767 the Authority by such participating political subdivision.

768 Each participating political subdivision and all holders of the Authority's bonds shall be made 769 parties to any such proceeding and shall be given notice as provided by law. Any party defendant may 770 reply to such petition at any time within six months after the filing of the petition. An appeal from the 771 final judgment of the court shall lie to the Supreme Court of Virginia.
