10	1. That § 55-530 of the Code of Virginia is amended and reenacted as follows:
11	§ 55-530. Powers of the Board.
12	A. The Board shall administer the provisions of this chapter pursuant to the powers conferred by
13	§ 54.1-2105.1 and this chapter.
14 15	B. [The Board shall designate an ombudsman A community association liaison shall be appointed in
15 16	accordance with § 54.1-303] who shall administer the requirements of this chapter and serve as an information resource on issues relating to the governance, administration and operation of common
17	interest communities, including the laws and regulations relating thereto. Such information may include
18	nonbinding interpretations of laws or regulations governing common interest communities and referrals
19	to public and private agencies offering alternative dispute resolution services, with a goal of reducing
20	and resolving conflicts among associations and their members. The compensation for the [ombudsman
21 22	community association liaison] designated pursuant to this chapter shall be paid from the Fund; provided that no more than sixty percent of the moneys collected annually in the Fund shall be used for

24	C. The Board may shall use at least forty percent of the moneys collected annually in the Fund
25	created by this chapter for financing or promoting the following:
26 27	 Information and research in the field of common interest community management and operation; Expeditious and inexpensive procedures for resolving common interest community disputes;
2 7 28	3. Seminars and educational programs designed to address topics of concern to community
29	associations; and
30	4. Other programs deemed necessary and proper to accomplish the purpose of this chapter.
31	B. D. The Board shall establish accounting procedures whereby sixty forty percent of the net
32 33	revenues collected in any fiscal year shall be expended in accordance with subsection $A B$ in the calendar year that begins during that fiscal year.
34	C. E. The Board shall issue a certificate of filing to each association which has properly filed in
35	accordance with this title. The certificate shall include the date of registration and a unique registration
36	number assigned by the Board.
37 38	D. F. The Board may prescribe regulations which shall be adopted, amended or repealed in accordance with the Administrative Process Act (\S 9-6.14:1 et seq.) to accomplish the purpose of this
