5 6	(Patron Prior to Substitute—Delegate Phillips) A BILL to amend and reenact § 2.1-548.29 of the Code of Virginia, relating to duties of the Virginia
7	Economic Development Partnership.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 2.1-548.29 of the Code of Virginia is amended and reenacted as follows:
10	§ 2.1-548.29. Economic development services.
11	A. It shall be the duty of the Authority to encourage, stimulate, and support the development and
12	expansion of the economy of the Commonwealth. The Authority is charged with the following duties
13	and responsibilities:
14 15	1. To see that there are prepared and carried out effective economic development marketing and
15 16	2. To make available to prospective new businesses, in conjunction and cooperation with localities,
17	chambers of commerce, industrial authorities, and other public and private groups, basic information and
18	pertinent factors of interest and concern to such businesses;
19	3. To formulate, promulgate, and advance programs throughout the Commonwealth for encouraging
20	the location of new businesses in the Commonwealth and the retention and growth of existing
21	businesses;
22 23	4. To encourage and solicit private sector involvement, support, and funding for economic development in the Commonwealth;
23 24	5. To encourage the coordination of the economic development efforts of public institutions, regions,
25	communities, and private industry and collect and maintain data on the development and utilization of
26	economic development capabilities;
27	6. To establish such offices within and without the Commonwealth that are necessary to the
28	expansion and development of industries and trade;
29 30	7. To encourage the export of products and services from the Commonwealth to international markets;
31	8. Upon request, to advise the State Board for Community Colleges in designating technical training
32	programs in Virginia's comprehensive community colleges for the Community College Incentive
33	Scholarship Program pursuant to § 23-220.4; and
34	9. Upon request, to advise the State Council of Higher Education for Virginia in designating certain
35	collegiate programs for the Virginia Undergraduate and Vocational Incentive Scholarship Program
36 37	pursuant to Article 3 (§ 23-38.19:3 et seq.) of Chapter 4.1 of Title 23. B. The Authority shall prepare a specific plan annually that shall serve as the basis for marketing
38	high unemployment areas of Virginia. This plan shall be submitted to the Governor and General
<u>39</u>	Assembly annually on or before November 1 of each year. The report shall contain the plan and
40	activities conducted by the Authority to market these high unemployment areas. The annual report shall
41	be part of the report required by § 2.1-548.40 and shall be distributed in accordance with § 2.1-467.
