11	Be it enacted by the General Assembly of Virginia:
12	1. That §§ 51.1-138 and 51.1-212 of the Code of Virginia are amended and reenacted, and that the
13	Code of Virginia is amended by adding a section numbered 51.1-213.1 as follows:
14	§ 51.1-138. Benefits.
15	A. Employees who become members under this article and on whose behalf contributions are paid as
16	provided in this article shall be entitled to benefits under the retirement system.
17 18	B. By resolution legally adopted and approved by the Board, the employer may elect to provide
10 19	benefits equivalent to those provided under the State Police Officers' Retirement System, as set out in Charter 2 ( $\$$ 51 1 200 at seq.) of this title accent for $\$$ 51 1 200 in lieu of the benefits that would

23	his superior officer, if so certified by his appointing authority, but not including any employee as defined
24	in § 51.1-212, (ii) positions as full-time salaried fire fighters, or (iii) positions as regional jail
25	superintendents and jail officers of regional jail farms, regional jails or jail authorities, as approved by
26	the respective jail board or authority and by the participating political subdivisions of such entities.
27	Sheriffs of political subdivisions which participate in the retirement system shall receive benefits
28	equivalent to those of state police officers, except for the benefits provided under § 51.1-209, regardless
29	of whether the employer has elected to provide equivalent benefits as set out in this subsection.
30	C. Each employer providing the benefits of subsection B for its employees prior to July 1, 1990,
31	may elect to provide for the early retirement of employees as set forth in this subsection in lieu of the
32	early retirement and death before retirement provisions of the State Police Officers' Retirement System.
33	Such election must be made to the Board in writing prior to July 1, 1990. Any member in service on or
34	after his fifty-fifth birthday with five or more years of creditable service may retire upon written
35	notification to the Board setting forth at what time the retirement is to become effective. The effective
36 37	date shall be after his last day of service but shall not be more than ninety days prior to the filing of
37 38	such notice. The member shall receive an allowance which shall be determined in the same manner as for retirement at an employee's normal retirement with creditable service and average final compensation
39	being determined as of the date of his actual retirement. If the member has less than thirty years of
<b>40</b>	service at retirement, the amount of the retirement allowance shall be reduced on an actuarial equivalent
41	basis for the period by which the actual retirement date precedes the earlier of (i) the member's normal
42	retirement date or (ii) the first date on or after the member's fifty-fifth birthday on which the member
43	would have completed a total of thirty years of creditable service.
44	Members retiring under the provisions of this subsection shall be entitled to receive post-retirement
45	supplements as provided in § 51.1-166. In computing the amount of any supplement, any additional
46	allowances being paid under the provisions of subsection B of § 51.1-206 shall be disregarded. In the
47	case of death before retirement, members whose employers elect to provide benefits in accordance with
48	the provisions of this subsection and who have not attained the age of fifty-five on the date of death
49 <b>-</b> 0	shall be assumed to be fifty-five years of age for the purposes of reducing the benefits on an actuarial
50	equivalent basis.
51	D. The retirement system shall not be liable for the payment of any retirement allowances or other
52	benefits on behalf of a member or beneficiary of a member for which reserves have not been previously
53 54	created from funds contributed by the employer or the members for such benefits.
