WHEREAS, Sandy Harris was a member of the American Society of Legislative Clerks and Secretaries; and

WHEREAS, Sandy Harris has served as a resource consultant to youth organizations, including the Virginia YMCA Model General Assembly for 18 years, which honored her with its Service to Youth Award, and the American Legion Auxiliary Girls State Program; and

WHEREAS, along with her 31-year dedication to the House of Delegates, she has had a 23-year relationship with Skipwith Baptist Church—having served as Moderator, Sunday School Teacher, Music Committee Chairman, Church Council Member, and First Soprano in the choir; and

WHEREAS, Sandy Harris, an exemplary "team player" with extensive institutional memory, agreed to assist in the House staff transition by returning for the 2001 Session of the General Assembly, and is anxious to begin her new life, with her husband, Charles, at their home on the Great Wicomico River and to be involved in her new church, Morattico Baptist Church; now, therefore, be it
