

## 1 VIRGINIA ACTS OF ASSEMBLY — CHAPTER

2 *An Act to amend and reenact § 46.2-334 of the Code of Virginia, relating to driver's licenses for*  
3 *persons less than eighteen years old.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 46.2-334 of the Code of Virginia is amended and reenacted as follows:**

8 § 46.2-334. Conditions and requirements for licensure of persons under eighteen; requests for  
9 cancellation of minor's driver's license; temporary driver's licenses; Board of Education approved  
10 programs; fee.

11 A. Minors at least sixteen years old may be issued driver's licenses under the following conditions:

12 1. The minor shall submit a proper application and satisfactory evidence that he (i) is a resident of  
13 the Commonwealth; (ii) has successfully completed a driver education course approved by either the  
14 State Department of Education or, in the case of a course offered by a commercial driver training school  
15 licensed under Chapter 17 (§ 46.2-1700 et seq.) of this title, by the Department of Motor Vehicles; and  
16 (iii) is mentally, physically, and otherwise qualified to drive a motor vehicle safely.

17 2. The minor's application for a driver's license must be signed by a parent of the applicant,  
18 otherwise by the guardian having custody of him. However, in the event a minor has no parent or  
19 guardian, then a driver's license shall not be issued to him unless his application is signed by the judge  
20 of the juvenile and domestic relations district court of the city or county in which he resides. If the  
21 minor making the application is married or otherwise emancipated, in lieu of any parent's, guardian's or  
22 judge's signature, the minor may present proper evidence of the solemnization of the marriage or the  
23 order of emancipation.

24 3. The minor shall be required to state in his application whether or not he has been convicted of an  
25 offense triable by, or tried in, a juvenile and domestic relations district court or found by such court to  
26 be a child in need of supervision, as defined in § 16.1-228. If it appears that the minor has been  
27 adjudged not innocent of the offense alleged or has been found to be a child in need of supervision, the  
28 Department shall not issue a license without the written approval of the judge of the juvenile and  
29 domestic relations district court making an adjudication as to the minor or the like approval of a similar  
30 court of the county or city in which the parent or guardian, respectively, of the minor resides.

31 4. The application for a permanent driver's license by a minor of the age of persons required to  
32 attend school pursuant to § 22.1-254 shall be accompanied by evidence of compliance with the  
33 compulsory school attendance law set forth in Article 1 (§ 22.1-254 et seq.) of Chapter 14 of Title 22.1.  
34 This evidence shall be provided in writing by the minor's parent. If the minor is unable to provide such  
35 evidence, he shall not be granted a driver's license until he reaches the age of eighteen or presents  
36 proper evidence of the solemnization of his marriage or an order of emancipation, or the parent, as  
37 defined in § 22.1-1, or other person standing in loco parentis has provided written authorization for the  
38 minor to obtain a driver's license.

39 A minor may, however, present a high school diploma or its equivalent or a certificate indicating  
40 completion of a prescribed course of study as defined by the local school board pursuant to  
41 § 22.1-253.13:4 as evidence of compulsory school attendance compliance.

42 5. The minor applicant shall certify in writing, on a form prescribed by the Commissioner, that he is  
43 a resident of the Commonwealth. The applicant's parent or guardian shall also certify that the applicant  
44 is a resident by signing the certification. Any minor providing proper evidence of the solemnization of  
45 his marriage or a certified copy of a court order of emancipation shall not be required to provide the  
46 parent's certification of residence.

47 B. Any custodial parent or guardian of an unmarried or unemancipated minor may, after the issuance  
48 of a permanent driver's license to such minor, file with the Department a written request that the license  
49 of the minor be canceled. When such request is filed, the Department shall cancel the license of the  
50 minor and the license shall not thereafter be reissued by the Department until a period of six months has  
51 elapsed from the date of cancellation or the minor reaches his eighteenth birthday, whichever shall occur  
52 sooner. *Notwithstanding the foregoing provisions of this subsection, in the case of a minor whose*  
53 *parents have been awarded joint legal custody, a request that the license of the minor be cancelled must*  
54 *be signed by both legal custodians. In the event one parent is not reasonably available or the parents*  
55 *do not agree, one parent may petition the juvenile and domestic relations district court to make a*  
56 *determination that the license of the minor be cancelled.*

57 C. The provisions of subsection A of this section requiring that an application for a driver's license  
58 be signed by the parent or guardian shall be waived by the Commissioner if the application is  
59 accompanied by proper evidence of the solemnization of the minor's marriage or a certified copy of a  
60 court order, issued under the provisions of Article 15 (§ 16.1-331 et seq.) of Chapter 11 of Title 16.1,  
61 declaring the applicant to be an emancipated minor.

62 D. A learner's permit accompanied by documentation verifying the minor's successful completion of  
63 an approved driver education course, signed by the minor's parent, guardian, legal custodian or other  
64 person standing in loco parentis, shall constitute a temporary driver's license for purposes of driving  
65 unaccompanied by a licensed driver as required in § 46.2-335, if all other requirements of this chapter  
66 have been met. The temporary license shall only be valid until the permanent license is presented as  
67 provided in § 46.2-336.

68 E. Notwithstanding the provisions of subsection A of this section requiring the successful completion  
69 of a driver education course approved by the State Department of Education, the Commissioner, on  
70 application therefor by a person at least sixteen years of age but less than eighteen years of age, shall  
71 issue to the applicant a temporary driver's license valid for six months if he (i) certifies by signing,  
72 together with his parent or guardian, on a form prescribed by the Commissioner that he is a resident of  
73 the Commonwealth; (ii) is the holder of a valid driver's license from another state; and (iii) has not been  
74 found guilty of or otherwise responsible for an offense involving the operation of a motor vehicle. No  
75 temporary license issued under this subsection shall be renewed, nor shall any second or subsequent  
76 temporary license under this subsection be issued to the same applicant. Any such minor providing  
77 proper evidence of the solemnization of his marriage or a certified copy of a court order of  
78 emancipation shall not be required to obtain the signature of his parent or guardian for the temporary  
79 driver's license.

80 F. For persons qualifying for a driver's license through driver education courses approved by the  
81 Department of Education or courses offered by commercial driver training schools licensed by the  
82 Department, the application for the learner's permit shall be used as the application for the driver's  
83 license pursuant to § 46.2-335.

84 G. Driver's licenses shall be issued by the Department to minors successfully completing driver  
85 education courses approved by the Department of Education (i) when the Department receives from the  
86 school proper certification that the student (a) has successfully completed such course, including a road  
87 skills examination and (b) is regularly attending school and is in good academic standing or, if not in  
88 such standing or submitting evidence thereof, whose parent or guardian, having custody of such minor,  
89 provides written authorization for the minor to obtain a driver's license, which written authorization shall  
90 be obtained on forms provided by the Department and indicating the Commonwealth's interest in the  
91 good academic standing and regular school attendance of such minors; and (ii) upon payment of a fee of  
92 \$2.40 per year, based on the period of the license's validity. For applicants attending public schools,  
93 good academic standing may be certified by the public school principal or any of his designees. For  
94 applicants attending nonpublic schools, such certification shall be made by the private school principal  
95 or any of his designees; for minors receiving home schooling, such certification shall be made by the  
96 home schooling parent or tutor. Any minor providing proper evidence of the solemnization of his  
97 marriage or a certified copy of a court order of emancipation shall not be required to provide the  
98 certification of good academic standing or any written authorization from his parent or guardian to  
99 obtain a driver's license.

100 **2. That an emergency exists and this act is in force from its passage.**
