

## 1 VIRGINIA ACTS OF ASSEMBLY — CHAPTER

2 *An Act to amend and reenact § 15.2-6403 of the Code of Virginia, relating to appointment to regional*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That § 15.2-6403 of the Code of Virginia is amended and reenacted as follows:**

8 § 15.2-6403. Board of the authority.

9 A. All powers, rights and duties conferred by this chapter, or other provisions of law, upon an  
10 authority shall be exercised by a board of directors. A board shall consist of two members for each  
11 member locality. The governing body of each member locality shall appoint two members to the board,  
12 who shall be residents of the appointing member locality. *However, in any instance in which the*  
13 *member localities are not equally contributing funding to the authority, and upon agreement by each*  
14 *member locality, the number of appointments to be made by each locality may be based upon the*  
15 *percentage of local funds contributed by each of the member localities.* Each member of a board shall  
16 serve for a term of four years and may be reappointed for one additional term. However, the board may  
17 elect to provide for staggered terms, in which case the members that draw an initial two-year term shall  
18 be eligible for reappointment for one additional four-year term.

19 However, with regard to any authority created by Planning Districts 11 and 12, only members of the  
20 appointing governing body of each member locality shall be appointed to the board. In the event such  
21 board members feel it is necessary to have an odd number of members, they may establish a rotation  
22 system that will allow one locality to appoint one extra member to serve for up to two years. Each  
23 locality will, in turn, appoint such extra member. Once the cycle is completed, the rotation shall be  
24 repeated.

25 B. Each member of a board shall, before entering upon the discharge of the duties of his office, take  
26 and subscribe to the oath prescribed in § 49-1. Members shall be reimbursed for actual expenses  
27 incurred in the performance of their duties from funds available to the authority.

28 C. A majority of the members of a board shall constitute a quorum, and the affirmative vote of a  
29 quorum of the board shall be necessary for any action taken by the board. No vacancy in the  
30 membership of a board shall impair the right of a quorum to exercise all the rights and perform all the  
31 duties of the board. The board shall determine the times and places of its regular meetings. Special  
32 meetings of a board shall be held when requested by a majority of the members of the board. Any such  
33 request for a special meeting shall be in writing, and the request shall specify the time and place of the  
34 meeting and the matters to be considered at the meeting. A reasonable effort shall be made to provide  
35 each member with notice of any special meeting. No matter not specified in the notice shall be  
36 considered at such special meeting unless all the members of the board are present.

37 D. Each board shall elect from its membership a chairman for each calendar year. The board may  
38 also appoint an executive director and staff who shall discharge such functions as may be directed by  
39 the board. The executive director and staff shall be paid from funds received by the authority.

40 E. Each board, promptly following the close of the fiscal year, shall submit an annual report of the  
41 authority's activities of the preceding year to the governing body of each member locality. Each such  
42 report shall set forth a complete operating and financial statement covering the operation of the authority  
43 during such year.
