11 12	Be it enacted by the General Assembly of Virginia: 1. That §§ 16.1-248.1, 16.1-250.1, 16.1-340, 16.1-341, 19.2-174.1, as it is currently effective and as it
12	shall become effective, 19.2-182.9, 32.1-48.02, 32.1-48.03, 32.1-48.04, 37.1-67.3 and 63.1-248.9 of the
14	Code of Virginia are amended and reenacted as follows:
15	§ 16.1-248.1. Criteria for detention or shelter care.
16	A. A juvenile taken into custody whose case is considered by a judge, intake officer or magistrate
17	pursuant to § 16.1-247 shall immediately be released, upon the ascertainment of the necessary facts, to
18 19	the care, custody and control of such juvenile's parent, guardian, custodian or other suitable person able and willing to provide supervision and care for such juvenile, either on bail or recognizance pursuant to
<b>20</b>	Chapter 9 (§ 19.2-119 et seq.) of Title 19.2 or under such conditions as may be imposed or otherwise.
<b>2</b> 1	However, a juvenile may be detained in a secure facility, pursuant to a detention order or warrant, only
22	upon a finding by the judge, intake officer, or magistrate, that there is probable cause to believe that the
23	juvenile committed the act alleged, and that at least one of the following conditions is met:
24	1. The juvenile is alleged to have committed an act which would be a felony or Class 1
25 26	misdemeanor if committed by an adult, and there is clear and convincing evidence that: a. Considering the seriousness of the current offense or offenses and other pending charges, the
20 27	seriousness of prior adjudicated offenses, the legal status of the juvenile and any aggravating and
28	mitigating circumstances, the release of the juvenile, constitutes a clear and substantial threat to the
29	person or property of others;
30 31	b. The release of the juvenile would present a clear and substantial threat of serious harm to such
31 32	juvenile's life or health; or c. The juvenile has threatened to abscond from the court's jurisdiction during the pendency of the
33	instant proceedings or has a record of willful failure to appear at a court hearing within the immediately
34	preceding twelve months.
35	2. The juvenile has absconded from a detention home or facility where he has been directed to
36 37	remain by the lawful order of a judge or intake officer. 3. The juvenile is a fugitive from a jurisdiction outside the Commonwealth and subject to a verified
38	petition or warrant, in which case such juvenile may be detained for a period not to exceed that
	provided for in § 16.1-323 while arrangements are made to return the juvenile to the lawful custody of a
40	parent, guardian or other authority in another state.
41	4. The juvenile has failed to appear in court after having been duly served with a summons in any
42 43	case in which it is alleged that the juvenile has committed a delinquent act or that the child is in need of services or is in need of supervision; however, a child alleged to be in need of services or in need of
44	supervision may be detained for good cause pursuant to this subsection only until the next day upon
45	which the court sits within the county or city in which the charge against the child is pending, and
46	under no circumstances longer than seventy-two hours from the time he was taken into custody. If the
47	seventy-two hour period expires on a Saturday, Sunday or legal holiday, the seventy-two hours shall be
48 49	extended to the next day that is not a Saturday, Sunday or legal holiday. When a juvenile is placed in secure detention, the detention order shall state the offense for which
<b>5</b> 0	the juvenile is being detained, and, to the extent practicable, other pending and previous charges.
51	B. Any juvenile not meeting the criteria for placement in a secure facility shall be released to a
52	parent, guardian or other person willing and able to provide supervision and care under such conditions
53	as the judge, intake officer or magistrate may impose. However, a juvenile may be placed in shelter care
54 55	if: 1. The invention is aligible for placement in a secure facility:
55 56	1. The juvenile is eligible for placement in a secure facility; 2. The juvenile has failed to adhere to the directions of the court, intake officer or magistrate while
57	on conditional release;
58	3. The juvenile's parent, guardian or other person able to provide supervision cannot be reached

59 within a reasonable time;

60 4. The juvenile does not consent to return home;

5. Neither the juvenile's parent or guardian nor any other person able to provide proper supervision 61 62 can arrive to assume custody within a reasonable time; or

63 6. The juvenile's parent or guardian refuses to permit the juvenile to return home and no relative or 64 other person willing and able to provide proper supervision and care can be located within a reasonable 65 time.

66 C. The criteria for continuing the juvenile in detention or shelter care as set forth in this section shall govern the decisions of all persons involved in determining whether the continued detention or shelter 67 care is warranted pending court disposition. Such criteria shall be supported by clear and convincing 68 69 evidence in support of the decision not to release the juvenile.

70 D. Nothing in this section shall be construed to deprive the court of its power to punish a juvenile 71 summarily for contempt for acts set forth in § 18.2-456, other than acts of disobedience of the court's 72 dispositional order which are committed outside the presence of the court.

73 E. A detention order may be issued pursuant to subdivision 2 of subsection A by the committing 74 court or by the court in the jurisdiction from which the juvenile fled or where he was taken into 75 custody.

§ 16.1-250.1. Appointment of counsel; detention review hearing.

77 When a child is not released after a detention hearing held pursuant to § 16.1-250 and, at the time of 78 the detention hearing, the child was not represented by legal counsel, then the child shall be afforded the 79 opportunity to be represented by counsel prior to a detention review hearing.

80 The court shall, upon request of counsel, rehear the matter as soon as is practicable but in no event 81 later than seventy-two hours after the request for the review hearing. If the seventy-two hour period expires on a Saturday, Sunday or legal holiday, the seventy-two hours shall be extended to the next day 82 83 that is not a Saturday, Sunday or legal holiday. During the hearing, the court shall evaluate the need for 84 continued detention of the child.

85 Notice of the detention review hearing, either oral or written, stating the time, place and purpose of 86 the hearing shall be given to the parent, guardian, legal custodian or other person standing in loco 87 parentis if he can be found, to the child's attorney, to the child if twelve years of age or over, and to the 88 attorney for the Commonwealth who shall be given an opportunity to be heard. 89

§ 16.1-340. Emergency admission.

90 A minor may be taken into custody and admitted for inpatient treatment pursuant to the procedures 91 specified in § 37.1-67.01 or § 37.1-67.1. If the minor is admitted to a willing facility in accordance with 92 § 37.1-67.1, the temporary detention order shall be effective until such time as the juvenile and domestic relations district court schedules a hearing. The juvenile and domestic relations district court shall schedule a hearing pursuant to § 16.1-341 no sooner than twenty-four hours and no later than 93 94 95 seventy-two hours from the time of the issuance of the temporary detention order. If the seventy-two hour period expires on a Saturday, Sunday or other legal holiday, the seventy-two hours shall be 96 97 extended to the next day which is not a Saturday, Sunday or legal holiday. In no case may the time 98 period between the filing of the petition and the hearing under § 16.1-344 exceed ninety-six hours. 99

§ 16.1-341. Involuntary commitment; petition; hearing scheduled; notice and appointment of counsel.

100 A. A petition for the involuntary commitment of a minor may be filed with the juvenile and 101 domestic relations district court by a parent or, if the parent is not available or is unable or unwilling to file a petition, by any responsible adult. The petition shall include the name and address of the petitioner 102 and the minor and shall set forth in specific terms why the petitioner believes the minor meets the 103 criteria for involuntary commitment specified in § 16.1-345. The petition shall be taken under oath. 104

If a commitment hearing has been scheduled by a juvenile and domestic relations district judge pursuant to subdivision 3 of subsection C of § 16.1-339, the petition for judicial approval filed by the 105 106 107 facility under subsection C of § 16.1-339 shall serve as the petition for involuntary commitment as long 108 as such petition complies in substance with the provisions of this subsection.

109 B. Upon the filing of a petition for involuntary commitment of a minor, the juvenile and domestic 110 relations district court may schedule a hearing which shall occur no sooner than twenty-four hours and 111 no later than seventy-two hours from the time the petition was filed. If the seventy-two-hour period expires on a Saturday, Sunday or other legal holiday, the seventy-two hours shall be extended to the 112 113 next day that is not a Saturday, Sunday or legal holiday. In no case may the time period between the 114 filing of the petition and the hearing under § 16.1-344 exceed ninety-six hours.

115 If the petition is not dismissed, copies of the petition, together with a notice of the hearing, shall be served immediately upon the minor and the minor's parents, if they are not petitioners. No later than 116 117 twenty-four hours before the hearing, the court shall appoint counsel to represent the minor, unless it has determined that the minor has retained counsel. Upon the request of the minor's counsel, for good cause 118 119 shown, and after notice to the petitioner and all other persons receiving notice of the hearing, the court 120 may continue the hearing once for a period not to exceed seventy-two hours.

121 § 19.2-174.1. (Effective July 1, 2001) Information required prior to admission to a mental health 122 facility.

123 Prior to any person being placed into the custody of the Commissioner for evaluation or treatment 124 pursuant to §§ 19.2-169.2, 19.2-169.3, 19.2-169.6, 19.2-176, 19.2-177.1, 19.2-182.2, and 19.2-182.3, and 125 Article 1.1 (37.1-70.1 et seq.) of Chapter 2 of Title 37.1, the court or special justice shall provide the 126 Commissioner with the following, if available: (i) the commitment order, (ii) the names and addresses 127 for the attorney for the Commonwealth, the attorney for the person and the judge holding jurisdiction 128 over the person, (iii) a copy of the warrant or indictment, and (iv) a copy of the criminal incident 129 information as defined in § 2.1-341 or a copy of the arrest report or a summary of the facts relating to the crime. The party requesting the placement into the Commissioner's custody or, in the case of 130 131 admissions pursuant to §§ 19.2-169.3, 19.2-169.6, 19.2-176, and 19.2-177.1, and Article 1.1 (37.1-70.1 132 et seq.) of Chapter 2 of Title 37.1, the person having custody over the defendant shall gather the above 133 information for submission to the court at the hearing. If the information is not available at the hearing, 134 it shall be provided by the party requesting placement or the person having custody directly to the 135 Commissioner within ninety-six hours of the person being placed into the Commissioner's custody. If 136 the ninety-six-hour period expires on a Saturday, Sunday or legal holiday, the ninety-six hours shall be 137 extended to the next day that is not a Saturday, Sunday or legal holiday.

**138** § 19.2-182.9. Emergency custody of conditionally released acquittee.

139 When exigent circumstances do not permit compliance with revocation procedures set forth in 140 § 19.2-182.8, any judge as defined in § 37.1-1 or a magistrate may issue an emergency custody order, 141 upon the sworn petition of any responsible person or upon his own motion based upon probable cause 142 to believe that an acquittee on conditional release (i) has violated the conditions of his release or is no 143 longer a proper subject for conditional release and (ii) requires inpatient hospitalization. The emergency 144 custody order shall require the acquittee within his judicial district to be taken into custody and 145 transported to a convenient location where a person designated by the community services board who is 146 skilled in the diagnosis and treatment of mental illness shall evaluate such acquittee and assess his need 147 for inpatient hospitalization. A law-enforcement officer who, based on his observation or the reliable 148 reports of others, has probable cause to believe that any acquittee on conditional release has violated the 149 conditions of his release and is no longer a proper subject for conditional release and requires 150 emergency evaluation to assess the need for inpatient hospitalization, may take the acquittee into custody 151 and transport him to an appropriate location to assess the need for hospitalization without prior judicial 152 authorization. The evaluation shall be conducted immediately. The acquittee shall remain in custody 153 until a temporary detention order is issued or until he is released, but in no event shall the period of 154 custody exceed four hours. If it appears from all evidence readily available (i) that the acquittee has 155 violated the conditions of his release or is no longer a proper subject for conditional release and (ii) that 156 he requires emergency evaluation to assess the need for inpatient hospitalization, the judge as defined in 157 § 37.1-1, or magistrate upon the advice of such person skilled in the diagnosis and treatment of mental 158 illness, may issue an order of temporary detention authorizing the executing officer to place the 159 acquittee in an appropriate institution for a period not to exceed forty-eight hours prior to a hearing. If 160 the forty-eight-hour period terminates on a Saturday, Sunday or legal holiday, the acquittee may be 161 detained until the next day which is not a Saturday, Sunday or legal holiday, but in no event may he be 162 detained for longer than seventy two hours or ninety six hours when the legal holiday occurs on a Monday or Friday. For purposes of this section, a Saturday, Sunday or legal holiday shall be deemed to 163 164 include the time period up to 8 a.m. of the next day which is not a Saturday, Sunday or legal holiday.

165 The committing court or any judge as defined in § 37.1-1 shall have jurisdiction to hear the matter. Prior to the hearing, the acquittee shall be examined by a psychiatrist or licensed clinical psychologist, 166 167 provided the psychiatrist or clinical psychologist is skilled in the diagnosis of mental illness, who shall certify whether the person is in need of hospitalization. At the hearing the acquittee shall be provided 168 169 with adequate notice of the hearing, of the right to be present at the hearing, the right to the assistance 170 of counsel in preparation for and during the hearing, and the right to introduce evidence and 171 cross-examine witnesses at the hearing. Following the hearing, if the court determines, based on a 172 preponderance of the evidence presented at the hearing, that the acquittee (i) has violated the conditions 173 of his release or is no longer a proper subject for conditional release and (ii) is mentally ill or mentally 174 retarded and is in need of inpatient hospitalization, the court shall revoke the acquittee's conditional 175 release and place him in the custody of the Commissioner. When an acquittee on conditional release 176 pursuant to this chapter is taken into emergency custody, detained or hospitalized, such action shall be 177 considered to have been taken pursuant to this section, notwithstanding the fact that his status as an insanity acquittee was not known at the time of custody, detention or hospitalization. Detention or 178 179 hospitalization of an acquittee pursuant to provisions of law other than those applicable to insanity 180 acquittees pursuant to this chapter shall not render the detention or hospitalization invalid. If a person's 181 status as an insanity acquittee on conditional release is not recognized at the time of emergency custody

182 or detention, at the time his status as such is verified, the provisions applicable to such persons shall be 183 applied and the court hearing the matter shall notify the committing court of the proceedings.

184 § 32.1-48.02. Investigations of verified reports or medical evidence; counseling; outpatient and 185 emergency treatment orders; custody upon emergency order.

A. Upon receiving at least two verified reports or upon receiving medical evidence that any person 186 187 who is reputed to know that he is infected with a communicable disease is engaging in at-risk behavior, 188 the Commissioner or his designee may conduct an investigation through an examination of the records 189 of the Department and other medical records to determine the disease status of the individual and that 190 there is cause to believe he is engaging in at-risk behavior.

191 B. If the investigation indicates that the person has a communicable disease caused by a non-airborne 192 microorganism and that there is cause to believe he is engaging in at-risk behavior, the Commissioner or 193 his designee may issue an order for such person to report to the local or district health department in the 194 jurisdiction in which he resides to receive counseling on the etiology, effects and prevention of the 195 specific disease. The person conducting the counseling shall prepare and submit a report to the 196 Commissioner or his designee on the counseling session or sessions in which he shall document that the 197 person so counseled has been informed about the acts that constitute at-risk behavior, appropriate 198 precautions, and the need to use appropriate precautions. The counselor shall also report any statements 199 indicating the intentions or understanding of the person so counseled.

200 C. If the investigation, described in subsection A, indicates that the person has a communicable 201 disease caused by an airborne microorganism which causes serious disease and can result in death and 202 that the person has refused or failed to adhere to a prescribed course of treatment and, despite 203 counseling, is engaging in conduct that places uninfected persons at risk of contracting such airborne 204 communicable disease, the Commissioner or his designee may issue an outpatient treatment order for 205 such person to report to the local or district health department in the jurisdiction in which he resides to 206 receive appropriate outpatient treatment and education concerning his disease.

207 D. If the investigation, described in subsection A, indicates that the person has a communicable 208 disease caused by an airborne microorganism which causes serious disease and can result in death and, 209 despite documented and appropriate counseling, is engaging in conduct that unreasonably places 210 uninfected persons at risk of contracting such airborne communicable disease and medical data demonstrate that he poses an imminent threat to the health of others, the Commissioner may issue an 211 212 emergency order requiring such person to be taken immediately into custody and placed, for a period, 213 not to exceed forty-eight hours, in the least restrictive, willing facility providing protection of the health 214 of others and appropriate treatment to the person upon finding that at least one of the following 215 conditions is met:

216 1. The person has refused or failed to report to the local health department after having been ordered 217 to do so pursuant to subsection C, for appropriate outpatient treatment and education concerning his 218 disease: 219

2. The person has a documented history of failure to adhere to a prescribed course of treatment; or

220 3. Documentation exists that the person has indicated that he will not comply with the prescribed 221 treatment.

222 If the specified forty-eight-hour period terminates on a Saturday, Sunday or legal holiday, such 223 person may be detained until the next day which is not a Saturday, Sunday, or legal holiday. In no 224 event may the person be detained for longer than seventy-two hours or ninety-six hours when the 225 specified forty eight-hour period terminates on a Saturday, Sunday or legal holiday. For purposes of this 226 subsection, a Saturday, Sunday, or legal holiday shall be deemed to include the time period up to 8:00 227 a.m. of the next day which is not a Saturday, Sunday, or legal holiday. During this period, the 228 Commissioner shall proceed in accordance with § 32.1-48.03.

229 E. In order to implement an emergency order issued pursuant to subsection D of this section, all state 230 and local law-enforcement officers are authorized to take custody of the subject of such emergency order 231 immediately upon issuance of the emergency order by the Commissioner. 232

§ 32.1-48.03. Petition for hearing; temporary detention.

233 A. Upon receiving a verified report or upon receiving medical evidence that any person who has 234 been counseled pursuant to § 32.1-48.02 has continued to engage in at-risk behavior, the Commissioner 235 or his designee may petition the general district court of the county or city in which such person resides 236 to order the person to appear before the court to determine whether isolation is necessary to protect the 237 public health.

238 B. If such person cannot be conveniently brought before the court, the court may issue an order of 239 temporary detention. The officer executing the order of temporary detention shall order such person to remain confined in his home or another's residence or in some convenient and willing institution or 240 241 other willing place for a period not to exceed forty-eight hours prior to a hearing. An electronic device 242 may be used to enforce such detention in the person's home or another's residence. The institution or 243 other place of temporary detention shall not include a jail or other place of confinement for persons

244 charged with criminal offenses.

245 If the specified forty-eight-hour period terminates on a Saturday, Sunday or legal holiday, such 246 person may be detained until the next day which is not a Saturday, Sunday or legal holiday- In no event 247 may the person be detained for longer than seventy two hours or ninety-six hours when the specified 248 forty eight-hour period terminates on a Saturday, Sunday or legal holiday. For purposes of this section, a 249 Saturday, Sunday, or legal holiday shall be deemed to include the time period up to 8:00 A.M. of the 250 next day which is not a Saturday, Sunday, or legal holiday.

251 C. Any person ordered to appear before the court pursuant to this section shall be informed of his 252 right to be represented by counsel. The court shall provide the person with reasonable opportunity to 253 employ counsel at his own expense, if so requested. If the person is not represented by counsel, the 254 court shall appoint an attorney-at-law to represent him. Counsel so appointed shall be paid a fee of 255 seventy-five dollars and his necessary expenses.

§ 32.1-48.04. Isolation hearing; conditions; order for isolation; right to appeal.

257 A. The isolation hearing shall be held within forty-eight hours of the execution of any temporary 258 detention order issued or, if the forty-eight-hour period terminates on a Saturday, Sunday or legal 259 holiday, the isolation hearing shall be held within seventy-two or ninety six hours of the execution of 260 any such temporary detention order the next day that is not a Saturday, Sunday or legal holiday.

Prior to the hearing, the court shall fully inform the person of the basis for his detention, if any, the 261 262 basis upon which he may be isolated, and the right of appeal of its decision.

263 B. An order for isolation in the person's home or another's residence or an institution or other place, 264 including a jail when no other reasonable alternative is available, may be issued upon a finding by the 265 court that the following conditions are met:

266 1. The person is infected with a communicable disease.

2. The person is engaging in at-risk behavior.

268 3. The person has demonstrated an intentional disregard for the health of the public by engaging in 269 behavior which has placed others at risk for infection. 270

4. There is no other reasonable alternative means of reducing the risk to public health.

C. Any order for isolation in the person's home or another's residence or an institution or other place 271 272 shall be valid for no more than 120 days, or for a shorter period of time if the Commissioner or his 273 designee, or the court upon petition, determines that the person no longer poses a substantial threat to 274 the health of others. Orders for isolation in the person's home or another's residence may be enforced 275 through the use of electronic devices. Orders for isolation may include additional requirements such as 276 participation in counseling or education programs. The court may, upon finding that the person no 277 longer poses a substantial threat to the health of others, issue an order solely for participation in 278 counseling or educational programs.

279 D. Isolation orders shall not be renewed without affording the person all rights conferred in this 280 article.

281 Any person under an isolation order pursuant to this section shall have the right to appeal such order 282 to the circuit court in the jurisdiction in which he resides. Such appeal shall be filed within thirty days 283 from the date of the order. Notwithstanding the provisions of § 19.2-241 relating to the time within 284 which the court shall set criminal cases for trial, any appeal of an isolation order shall be given priority 285 over all other pending matters before the court, except those matters under appeal pursuant to 286 § 37.1-67.6, and shall be heard as soon possible by the court. The clerk of the court from which an 287 appeal is taken shall immediately transmit the record to the clerk of the appellate court.

288 The appeal shall be heard de novo. An order continuing the isolation shall only be entered if the 289 conditions set forth in subsection B are met at the time the appeal is heard.

290 If the person under an isolation order is not represented by counsel, the judge shall appoint an 291 attorney-at-law to represent him. Counsel so appointed shall be paid a fee of \$150 and his necessary 292 expenses. The order of the court from which the appeal is taken shall be defended by the attorney for 293 the Commonwealth. 294

§ 37.1-67.3. Same; involuntary admission and treatment.

295 The commitment hearing shall be held within forty-eight hours of the execution of the temporary 296 detention order as provided for in § 37.1-67.1; however, if the forty-eight-hour period herein specified 297 terminates on a Saturday, Sunday, or legal holiday, such person may be detained, as herein provided, 298 until the next day which is not a Saturday, Sunday, or legal holiday, but in no event may the person be 299 detained for a period longer than seventy-two hours or ninety-six hours when such legal holiday occurs 300 on a Monday or Friday. A Saturday, Sunday, or legal holiday shall be deemed to include the time 301 period up to 8:00 a.m. of the next day which is not a Saturday, Sunday, or legal holiday.

302 The judge, in commencing the commitment hearing, shall inform the person whose involuntary 303 admission is being sought of his right to apply for voluntary admission and treatment as provided for in 304 § 37.1-65 and shall afford such person an opportunity for voluntary admission. The judge shall ascertain 305 if such person is then willing and capable of seeking voluntary admission and treatment. If the person is 306 capable and willingly accepts voluntary admission and treatment, the judge shall require him to accept 307 voluntary admission for a minimum period of treatment and after such minimum period, not to exceed 308 seventy-two hours, to give the hospital forty-eight hours' notice prior to leaving the hospital, during 309 which notice period he shall not be discharged, unless sooner discharged pursuant to § 37.1-98 or 310 § 37.1-99. Such person shall be subject to the transportation provisions as provided in § 37.1-71 and the 311 requirement for prescreening by a community services board or community mental health clinic as 312 provided in § 37.1-65.

313 If a person is incapable of accepting or unwilling to accept voluntary admission and treatment, the 314 judge shall inform such person of his right to a commitment hearing and right to counsel. The judge 315 shall ascertain if a person whose admission is sought is represented by counsel, and if he is not 316 represented by counsel, the judge shall appoint an attorney-at-law to represent him. However, if such 317 person requests an opportunity to employ counsel, the court shall give him a reasonable opportunity to 318 employ counsel at his own expense.

319 A written explanation of the involuntary commitment process and the statutory protections associated 320 with the process shall be given to the person and its contents explained by an attorney prior to the 321 commitment hearing. The written explanation shall include, at a minimum, an explanation of the 322 person's right to retain private counsel or be represented by a court-appointed attorney, to present any 323 defenses including independent evaluation and expert testimony or the testimony of other witnesses, to 324 be present during the hearing and testify, to appeal any certification for involuntary admission to the circuit court, and to have a jury trial on appeal. The judge shall ascertain whether the person whose 325 326 admission is sought has been given the written explanation required herein.

To the extent possible, during or before the commitment hearing, the attorney for the person whose admission is sought shall interview his client, the petitioner, the examiner described below, the community services board staff, and any other material witnesses. He shall also examine all relevant diagnostic and other reports, present evidence and witnesses, if any, on his client's behalf, and otherwise actively represent his client in the proceedings. The role of the attorney shall be to represent the wishes of his client, to the extent possible.

The petitioner shall be given adequate notice of the place, date, and time of the commitment hearing.
The petitioner shall be entitled to retain counsel at his own expense, to be present during the hearing, and to testify and present evidence. The petitioner shall be encouraged but shall not be required to testify at the hearing and the person whose admission is sought shall not be released solely on the basis of the petitioner's failure to attend or testify during the hearing.

338 Notwithstanding the above, the judge shall require an examination of such person by a psychiatrist or a psychologist who is licensed in Virginia by either the Board of Medicine or the Board of Psychology 339 340 who is qualified in the diagnosis of mental illness or, if such a psychiatrist or psychologist is not 341 available, any mental health professional who is (i) licensed in Virginia through the Department of 342 Health Professions and (ii) qualified in the diagnosis of mental illness. The examiner chosen shall be 343 able to provide an independent examination of the person. The examiner shall not be related by blood or 344 marriage to the person, shall not be responsible for treating the person, shall have no financial interest in 345 the admission or treatment of the person, shall have no investment interest in the hospital detaining or 346 admitting the person under this article, and, except for employees of state hospitals and of the U.S. 347 Department of Veterans Affairs, shall not be employed by such hospital. For purposes of this section, 348 investment interest means the ownership or holding of an equity or debt security, including, but not 349 limited to, shares of stock in a corporation, interests or units of a partnership, bonds, debentures, notes, 350 or other equity or debt instruments.

351 All such examinations shall be conducted in private. The judge shall summons the examiner who 352 shall certify that he has personally examined the individual and has probable cause to believe that the 353 individual (i) is or is not so seriously mentally ill as to be substantially unable to care for himself, or 354 (ii) does or does not present an imminent danger to himself or others as a result of mental illness, and 355 (iii) requires or does not require involuntary hospitalization or treatment. Alternatively, the judge, in his 356 discretion, may accept written certification of the examiner's findings if the examination has been personally made within the preceding five days and if there is no objection sustained to the acceptance 357 358 of such written certification by the person or his attorney. The judge shall not render any decision on 359 the petition until such examiner has presented his report either orally or in writing.

360 Éxcept as otherwise provided in this section, prior to making any adjudication that such person is 361 mentally ill and shall be confined to an institution pursuant to this section, the judge shall require from 362 the community services board which serves the political subdivision where the person resides a 363 prescreening report, and the board or clinic shall provide such a report within forty-eight hours or within 364 seventy-two hours, if the forty-eight-hour period terminates on a Saturday, Sunday or legal holiday, the 365 next day that is not a Saturday, Sunday or legal holiday. If it is impossible or impractical to obtain a 366 prescreening report from the community services board which serves the political subdivision where the

367 person resides, the judge may obtain such report from the community services board of the political 368 subdivision where the person is located. The report shall be admissible as evidence of the facts stated 369 therein and shall state whether the person is deemed to be so seriously mentally ill that he is 370 substantially unable to care for himself, an imminent danger to himself or others as a result of mental 371 illness and in need of involuntary hospitalization or treatment, whether there is no less restrictive 372 alternative to institutional confinement and what the recommendations are for that person's care and 373 treatment. In the case of a person sentenced and committed to the Department of Corrections and who 374 has been examined by a psychiatrist or clinical psychologist, the judge may proceed to adjudicate 375 whether the person is mentally ill and should be confined pursuant to this section without requesting a 376 prescreening report from the community services board.

377 After observing the person and obtaining the necessary positive certification and any other relevant 378 evidence which may have been offered, if the judge finds specifically (i) that the person presents an 379 imminent danger to himself or others as a result of mental illness or has been proven to be so seriously 380 mentally ill as to be substantially unable to care for himself, and (ii) that alternatives to involuntary 381 confinement and treatment have been investigated and deemed unsuitable and there is no less restrictive 382 alternative to institutional confinement and treatment, the judge shall by written order and specific 383 findings so certify and order that the person be placed in a hospital or other facility for a period of 384 treatment not to exceed 180 days from the date of the court order. Such placement shall be in a hospital 385 or other facility designated by the community services board which serves the political subdivision in 386 which the person was examined as provided in this section. If the community services board does not 387 provide a placement recommendation at the commitment hearing, the person shall be placed in a 388 hospital or other facility designated by the Commissioner.

389 After observing the person and obtaining the necessary positive certification and any other relevant 390 evidence which may have been offered, if the judge finds specifically (i) that the person presents an 391 imminent danger to himself or others as a result of mental illness or has been proven to be so seriously 392 mentally ill as to be substantially unable to care for himself, and (ii) that less restrictive alternatives to 393 institutional confinement and treatment have been investigated and are deemed suitable, and if, 394 moreover, the judge finds specifically that (i) the patient has the degree of competency necessary to 395 understand the stipulations of his treatment, (ii) the patient expresses an interest in living in the 396 community and agrees to abide by his treatment plan, (iii) the patient is deemed to have the capacity to 397 comply with the treatment plan, (iv) the ordered treatment can be delivered on an outpatient basis, and 398 (v) the ordered treatment can be monitored by the community services board or designated providers, 399 the judge shall order outpatient treatment, day treatment in a hospital, night treatment in a hospital, 400 outpatient involuntary treatment with anti-psychotic medication pursuant to § 37.1-134.21, or such other 401 appropriate course of treatment as may be necessary to meet the needs of the individual. Upon failure of 402 the patient to adhere to the terms of the outpatient treatment, the judge may revoke the same and, upon 403 notice to the patient and after a commitment hearing, order involuntary commitment for treatment at a 404 hospital. The community services board which serves the political subdivision in which the person 405 resides shall recommend a specific course of treatment and programs for provision of such treatment. 406 The community services board shall monitor the person's compliance with such treatment as may be 407 ordered by the court under this section, and the person's failure to comply with involuntary outpatient 408 treatment as ordered by the court may be admitted into evidence in subsequent hearings held pursuant to 409 the provisions of this section.

410 The judge shall make or cause to be made a tape or other audio recording of the hearing and shall 411 submit such recording to the appropriate district court clerk to be retained in a confidential file. Such 412 recordings shall only be used to document and to answer questions concerning the judge's conduct of the 413 hearing. These recordings shall be retained for at least three years from the date of the relevant 414 commitment hearing. The judge shall also order that copies of the relevant medical records of such 415 person be released to the facility or program in which he is placed upon request of the treating 416 physician or director of the facility or program. Except as provided in this section, the court shall keep 417 its copies of relevant medical records, reports, and court documents pertaining to the hearings provided 418 for in this section confidential if so requested by such person, or his counsel, with access provided only 419 upon court order for good cause shown. Such records, reports, and documents shall not be subject to the 420 Virginia Freedom of Information Act (§ 2.1-340 et seq.). Such person shall be released at the expiration 421 of 180 days unless involuntarily committed by further petition and order of a court as provided herein or 422 such person makes application for treatment on a voluntary basis as provided for in § 37.1-65.

423 The procedures required by this section shall be followed at such commitment hearing. The judge 424 shall render a decision on such petition after the appointed examiner has presented his report, either 425 orally or in writing, and after the community services board which serves the political subdivision where 426 the person resides has presented a prescreening report, either orally or in writing, with recommendations 427 for that person's placement, care and treatment. These reports, if not contested, may constitute sufficient 428 evidence upon which the court may base its decision.

429 The clerk shall certify and forward forthwith to the Central Criminal Records Exchange, on a form 430 provided by the Exchange, a copy of any order for involuntary commitment to a hospital. The copy of 431 the form and the order shall be kept confidential in a separate file and used only for the purpose of 432 conducting a firearms transaction record check authorized by § 18.2-308.2:2.

433 § 63.1-248.9. Authority to take child into custody.

434 A. A physician or protective service worker of a local department or law-enforcement official investigating a report or complaint of abuse and neglect may take a child into custody for up to 435 436 seventy-two hours without prior approval of parents or guardians provided:

1. The circumstances of the child are such that continuing in his place of residence or in the care or 437 438 custody of the parent, guardian, custodian or other person responsible for the child's care, presents an imminent danger to the child's life or health to the extent that severe or irremediable injury would be 439 440 likely to result or if evidence of abuse is perishable or subject to deterioration before a hearing can be 441 held; and 442

2. A court order is not immediately obtainable; and

443 3. The court has set up procedures for placing such children; and

444 4. Following taking the child into custody, the parents or guardians are notified as soon as 445 practicable that he is in custody; and

446 5. A report is made to the local department; and

447 6. The court is notified and the person or agency taking custody of such child obtains, as soon as 448 possible, but in no event later than seventy-two hours, an emergency removal order pursuant to 449 § 16.1-251; however, if a preliminary removal order is issued after a hearing held in accordance with 450 § 16.1-252 within seventy-two hours of the removal of the child, an emergency removal order shall not 451 be necessary.

452 B. If the seventy-two-hour period for holding a child in custody and for obtaining a preliminary or 453 emergency removal order expires on a Saturday, Sunday, or other legal holiday, the seventy-two hours 454 shall be extended to the next day that is not a Saturday, Sunday, or other legal holiday, but in no event 455 shall either such period exceed ninety-six hours.
