## SENATE JOINT RESOLUTION NO. 509

Offered February 16, 2001

*Commending those who provided support services to the USS Cole.*

WHEREAS, the USS *Cole*, under the command of Kirk S. Lippold, Commander, USN, suffered a deadly terrorist attack in the port of Aden, Yemen, on October 12, 2000; and

WHEREAS, 17 members of the crew of the USS *Cole* were killed in the attack, and 39 more were wounded; and

WHEREAS, the United States Navy mustered its forces deployed at sea, as well as those ashore, to provide aid, comfort, and all manner of support to the surviving officers and crew and their dependents and other loved ones at home; and

WHEREAS, among those providing assistance were Rear Admiral James B. RESOLVED by the Senate, the House of Delegates concurring, That the General Assembly commend the many individuals who played a key role in providing crucial support to the officers and crew of the USS *Cole* in the aftermath of the October 12, 2000, terrorist attack; and, be it

RESOLVED FURTHER, That the Clerk of the Senate transmit copies of this resolution to Rear Admiral James B. Foley, Commander Surface Force, U.S. Atlantic Fleet, and Rear Admiral Christopher Cole, Commander Navy Region Mid-Atlantic, as an expression of the General Assembly's admiration and gratitude for their timely and effective reaction to the USS *Cole* attack.
