2 An Act to amend and reenact § 22.1-290.01 of the Code of Virginia, relating to the Virginia Teaching
3 Scholarship Loan Program.

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That § 22.1-290.01 of the Code of Virginia is amended and reenacted as follows:**

8 § 22.1-290.01. Virginia Teaching Scholarship Loan Program established; purpose; Board of Education
9 to administer Program; eligibility requirements for scholarship and awards; collaboration and
10 consultation with State Council of Higher Education; repayment of scholarship required.

11 A. With such funds as may be appropriated for this purpose and any gifts, donations, grants,
12 bequests, and other funds that may be received on behalf of the Program by the Board of Education,
13 there is hereby established the Virginia Teaching Scholarship Loan Program, hereinafter referred to as
14 the "Program," to: (i) increase the number of students pursuing careers in teaching *and students seeking*
15 *endorsements in elementary and middle school education*; (ii) increase the number of teachers in the
16 critical teacher shortage disciplines, including special education, as established by the Board; (iii)
17 *increase the number of teachers in a school division with a shortage of teachers in any discipline or at*
18 *any grade level, as defined in the Board of Education's Regulations Governing the Determination of*
19 *Critical Teacher Shortage Areas*; (iv) assist paraprofessionals enrolled as full-time or part-time students
20 in an approved teacher education program in completing the program to become fully licensed teachers;
21 ~~(iv)~~ (v) expand eligibility to sophomores, ~~and~~ to students enrolled full-time or part-time in an approved
22 teacher education program; and ~~(v)~~ (vi) increase the diversity of persons pursuing careers in teaching.

23 The Program shall consist of ~~five~~ seven components:

- 24 1. Awards to students pursuing teacher licensure;
- 25 2. Awards to students pursuing teacher licensure in critical teacher shortage disciplines;
- 26 3. Awards to assist paraprofessionals in completing an approved teacher education program to
27 become fully licensed teachers;
- 28 4. Awards to sophomores and full-time and part-time students enrolled in an approved teacher
29 education program; ~~and~~
- 30 5. Awards to persons identified by a school board to teach in a discipline or at a grade level within
31 the school division in which a shortage of teachers exists, as defined in the Board of Education's
32 Regulations Governing the Determination of Critical Teacher Shortage Areas. However, such persons
33 shall meet the qualifications for awards granted pursuant to this section;
- 34 6. Awards to students enrolled in any area of an approved teacher education program seeking
35 endorsements in elementary or middle school education; and
- 36 ~~5-~~ 7. Awards to students of diverse backgrounds, pursuant to subsection B.

37 B. In addition, there is hereby established within the Virginia Teaching Scholarship Loan Program a
38 component focused solely on increasing diversity among teachers by providing incentives for students of
39 diverse backgrounds to pursue careers in teaching, which shall be known as the Diversity in Teaching
40 Initiative. The Diversity in Teaching Initiative shall provide scholarships to students of diverse
41 backgrounds enrolled in approved undergraduate and graduate teacher education programs and shall be
42 funded with such moneys as may be appropriated for this purpose, and any gifts, donations, grants,
43 bequests, and other funds as may be received on its behalf by the Board of Education and deposited in
44 the Virginia Teaching Scholarship Loan Fund pursuant to subsection G. The Board shall establish
45 procedures and criteria, in consultation with the Office of the Attorney General, for awarding the
46 Diversity in Teaching Initiative scholarships.

47 C. The Board of Education shall establish, in regulation, criteria for determining, ~~biennially~~, critical
48 teacher shortage areas *and disciplines* for awarding scholarships pursuant to this section. The criteria
49 shall include such factors as the needs in teacher endorsement areas among the several school divisions
50 of the Commonwealth, teacher shortages at the elementary and secondary grade levels, and teacher
51 shortages in rural and urban regions of the Commonwealth. The Program shall be administered by the
52 Board of Education, which shall promulgate such regulations as may be necessary for the
53 implementation of the Program. The Board shall consult with the State Council of Higher Education in
54 the development and implementation of the Program.

55 D. The Program shall consist of scholarships awarded annually to undergraduate students in the
56 sophomore, junior, or senior year of college, and to graduate students at an accredited public or private

57 four-year institution of higher education in the Commonwealth, who (i) are enrolled full-time or
58 part-time in an approved teacher education program, or in a critical teacher shortage discipline, as ~~may~~
59 ~~be determined~~ *established* by the Board of Education ~~biennially~~; (ii) *are enrolled in any area of an*
60 *approved teacher education program seeking endorsements in elementary or middle school education;*
61 *(iii) are of diverse backgrounds and enrolled in approved undergraduate and graduate teacher*
62 *education programs, pursuant to subsection B;* (iv) are employed as paraprofessionals and are enrolled
63 full-time or part-time to complete an approved teacher education program to become fully licensed
64 teachers; ~~(iii)~~ (v) *has been identified by a school board to teach in a discipline or at a grade level*
65 *within the school division in which a shortage of teachers exists, as defined in the Board of Education's*
66 *Regulations Governing the Determination of Critical Teacher Shortage Areas;* (vi) have and maintain a
67 cumulative grade point average of at least 2.7 on a 4.0 scale or its equivalent; and ~~(iv)~~ (vii) are
68 nominated for such scholarship by the institution where they are enrolled.

69 ~~Students enrolled in any area of an approved teacher education program who are seeking~~
70 ~~endorsements in elementary or middle education who meet the program requirements may be eligible for~~
71 ~~such award.~~

72 E. Before any teaching scholarship is awarded in accordance with the provisions of this section, the
73 scholarship recipient shall sign a promissory note under which he agrees (i) to pursue an approved
74 teacher education or graduate education program full-time or part-time at an accredited public or private
75 four-year institution of higher education in Virginia until his graduation and (ii) upon graduation, to
76 begin teaching in the public schools of the Commonwealth in a critical teaching shortage discipline or,
77 regardless of teaching discipline, in a school with a high concentration of students eligible for free or
78 reduced lunch or in a rural or urban region of the Commonwealth with a teacher shortage.

79 Upon graduation, the scholarship recipient shall begin teaching in the public schools of the
80 Commonwealth in the first full academic year after graduating from college and becoming eligible for a
81 teaching license, and shall thereafter teach continuously in Virginia for the same number of years that he
82 was the beneficiary of such scholarship. Such scholarship recipient may fulfill the teaching obligation by
83 accepting a teaching position (i) in one of the critical teacher shortage disciplines as ~~determined~~
84 *established* by the Board of Education; or (ii) regardless of teaching discipline, in a school with a high
85 concentration of students eligible for free or reduced lunch; or (iii) *in any discipline or at any grade*
86 ~~levels level~~ *within a school division* with a shortage of teachers, *as defined in the Board of Education's*
87 *Regulations Governing the Determination of Critical Teacher Shortage Areas;* or (iv) in a rural or urban
88 region of the state with a teacher shortage. The Board of Education may recover the total amount of
89 funds awarded as a scholarship, or the appropriate proportion thereof, including any accrued interest, if
90 the scholarship recipient fails to honor the teaching obligation.

91 F. To ensure a more diverse representation among classroom teachers, especially at the elementary
92 and middle grade levels, the Diversity in Teaching Initiative shall consist of no more than five pilot
93 projects, geographically distributed across the Commonwealth, and shall be designed to attract and
94 encourage elementary and secondary school students, particularly students of diverse backgrounds, to
95 pursue a career in teaching. The pilot projects shall be developed in accordance with the provisions of
96 the appropriation act governing the administration of the Better Information Project within the
97 Pre-Collegiate Program under the Virginia Plan for Equal Educational Opportunity in Higher Education.
98 The pilot projects may include outreach activities such as mentorship programs, linkages between public
99 schools and institutions of higher education, and other programs and activities designed to generate
100 interest in the teaching profession. The Board shall require the evaluation of each pilot project before
101 implementing this component of the Diversity in Teaching Initiative statewide.

102 G. There is hereby created in the Department of the Treasury a special nonreverting fund known as
103 the Virginia Teaching Scholarship Loan Fund, hereinafter referred to as the "Fund." The Fund shall be
104 established on the books of the Comptroller, and any moneys remaining in the Fund at the end of the
105 biennium shall not revert to the general fund but shall remain in the Fund. The Fund shall consist of
106 such moneys as may be appropriated for the Virginia Teaching Scholarship Loan Program and such
107 gifts, donations, grants, bequests, and other funds as may be received on its behalf by the Board of
108 Education. The Fund shall be used solely to fund the Virginia Teaching Scholarship Loan Program.
109 Interest earned on such moneys shall remain in the Fund and be credited to it. Moneys in the Fund shall
110 be used solely to award scholarships pursuant to the Virginia Teaching Scholarship Loan Program as
111 provided in this section. Disbursements from the Fund for such scholarships shall be made by the State
112 Treasurer on warrants issued by the Comptroller upon written request of the President of the Board of
113 Education. The State Treasurer shall ensure that any moneys appropriated or provided to the Fund for
114 the Diversity in Teaching Initiative through appropriations, gifts, donations, grants, and bequests shall be
115 accounted for separately and distributed only for scholarships awarded pursuant to the Diversity in
116 Teaching Initiative.

117 H. The Board of Education and the State Council of Higher Education shall make available to

118 parents, students, teachers, high school guidance counselors, and academic advisors and financial aid
119 administrators at public and private institutions of higher education information concerning the Virginia
120 Teacher Scholarship Loan Program, including the Diversity in Teaching Initiative, eligibility for the
121 loans, and the terms and conditions under which such loans are awarded, in order that students
122 interested in pursuing careers in the teaching profession may be advised of the availability of such
123 financial assistance.

124 I. *For the purposes of this section, "critical teacher shortage area and discipline" means subject*
125 *areas and grade levels identified by the Board of Education in which the demand for classroom teachers*
126 *exceeds the supply of teachers, as defined in the Board of Education's Regulations Governing the*
127 *Determination of Critical Teacher Shortage Areas.*

128 J. For the purposes of this section, "paraprofessional" means a full-time member of a school staff
129 whose primary responsibility is to support instructional programs under the direction of licensed
130 instructional personnel.
