10	Be it enacted by the General Assembly of Virginia:
11	1. That § 9.1-202 of the Code of Virginia is amended and reenacted as follows:
12	§ 9.1-202. Virginia Fire Services Board; membership; terms; compensation.
13	A. The Virginia Fire Services Board (the "Board") is established as a policy board within the
14	meaning of § 2.2-2100 in the executive branch of state government. The Board shall consist of fifteen
15	members to be appointed by the Governor as follows: a representative of the insurance industry; two
16	members of the general public with no connection to the fire services, one of whom shall be a
17	representative of those industries affected by SARA Title III and OSHA training requirements; and one
18	representative member each from the State Fire Chiefs Association of Virginia, the Virginia Firemen's
19	Association, the Virginia Association of Professional Firefighters, the Virginia Fire Service Council, the
20	Virginia Fire Prevention Association, the State Chapter of the International Association of Arson
21	Investigators, the Virginia Municipal League, and the Virginia Association of Counties, and a member of
22	the Virginia Chapter of the International Society of Fire Service Instructors who is a faculty member
23	who teaches fire science at a public institution of higher education. Of these appointees, at least one
24	shall be a volunteer firefighter. The State Fire Marshal, the State Forester and a member of the Board of
25	Housing and Community Development, appointed by the chairman of that Board shall also serve as
26	members of the Board.
27	Each of the organizations represented shall submit names for the Governor's consideration in making
28	these appointments.
29	B. Members of the Board appointed by the Governor shall serve for terms of four years. An
30	appointment to fill a vacancy shall be for the unexpired term. No appointee shall serve more than two
31	successive four-year terms but neither shall any person serve beyond the time he holds the office or
32	organizational membership by reason of which he was initially eligible for appointment.
33	C. The Board annually shall elect its chairman and vice-chairman from among its membership and

C. The Board annually shall elect its chairman and vice-chairman from among its membership and shall adopt rules of procedure. D. Members of the Board shall not be entitled to compensation but shall be reimbursed for all reasonable and necessary expenses incurred in the discharge of their duties as provided in § 2.2-2825.
