WHEREAS, among the victims of the Pentagon attack was Diana Padro of Woodbridge, an accountant in the Office of the Secretary of the Army; and

WHEREAS, a native of Puerto Rico, Diana Padro was a veteran of service in the United States Army, where she met her husband, Jose Padro; and

WHEREAS, Diana Padro was a *magna cum laude* graduate of the InterAmerican University of Puerto Rico and the mother of two sons, Juan, 19, and Jose, 23; now, therefore, be it

RESOLVED by the House of Delegates, the Senate concurring, That the General Assembly note with sadness the loss of Diana Padro, an innocent victim of the September 11 terrorist attacks on the United States; and, be it

RESOLVED FURTHER, That the Clerk of the House of Delegates prepare a copy of this resolution for presentation to the family of Diana Padro as an expression of the heartfelt condolences of the General Assembly of Virginia.
