WHEREAS, Diane Hale-McKinzy was married and the mother of a young daughter; now, therefore, be it

RESOLVED by the House of Delegates, the Senate concurring, That the General Assembly hereby note with great sadness the loss of Diane Hale-McKinzy, an innocent victim of the September 11 terrorist attacks on the United States; and, be it

RESOLVED FURTHER, That the Clerk of the House of Delegates prepare a copy of this resolution for presentation to the family of Diane Hale-McKinzy as an expression of the heartfelt condolences of the General Assembly of Virginia.
