8 WHEREAS, the attack had a devastating effect in Virginia, home of the Pentagon and of many of 9 the personnel, military and civilian, who served there; and

10 WHEREAS, among the victims of the Pentagon attack was Staff Sergeant Maudlyn White of11 Arlington, who had reported for a tour of duty at the Pentagon on September 10; and

12 WHEREAS, a native of St. Croix, Virgin Islands, Sergeant White enlisted in the U.S. Army in 198513 and was a personnel officer; and

WHERĖAS, Sergeant White had returned to the United States in July following a tour of duty with
the 2nd Infantry Division in South Korea, where she was in charge of awards and other personnel
actions for the 2nd Infantry Division Support Command; and

WHEREAS, Sergeant White was dedicated to her Army career and to her six-year-old daughter,Vielda; now, therefore, be it

20 note with great sadness the loss of Staff Sergeant Maudlyn White, a victim of the September 11 terrorist
21 attacks on the United States; and, be it
