11 12	Be it enacted by the General Assembly of Virginia:
13	1. That §§ 2.2-4343 and 23-76.1 of the Code of Virginia are amended and reenacted, and that the
14 15	Code of Virginia is amended by adding in Chapter 45 of Title 2.2 a section numbered 2.2-4517 as follows:
15 16	§ 2.2-4343. Exemption from operation of chapter for certain transactions.
17	A. The provisions of this chapter shall not apply to:
18 19	1. The Virginia Port Authority in the exercise of any of its powers in accordance with Chapter 10 (§ 62.1-128 et seq.) of Title 62.1, provided the Authority implements, by policy or regulation adopted by
20	the Board of Commissioners and approved by the Department of General Services, procedures to ensure
21	fairness and competitiveness in the procurement of goods and services and in the administration of its
22 23	capital outlay program. This exemption shall be applicable only so long as such policies and procedures meeting the requirements remain in effect.
24	2. The Virginia Retirement System for selection of services related to the management, purchase or
25	sale of authorized investments, including but not limited to actuarial services. Selection of these services
26 27	<ul><li>shall be governed by the standard set forth in § 51.1-124.30.</li><li>3. The State Treasurer in the selection of investment management services related to the external</li></ul>
28	management of funds shall be governed by the standard set forth in § 2.2-4514, and shall be subject to
29 30	competitive guidelines and policies that are set by the Commonwealth Treasury Board and approved by
30 31	<ul><li>the Department of General Services.</li><li>4. The Department of Social Services or local departments of social services for the acquisition of</li></ul>
32	motor vehicles for sale or transfer to Temporary Assistance to Needy Families (TANF) recipients.
33 34	5. The University of Virginia in the selection of services related to the management and investment of its endowment funds, <i>endowment income, and gifts pursuant to § 23-76.1</i> . However, selection of these
34	services shall be governed by the Uniform Management of Institutional Funds Act (§ 55-268.1 et seq.)
36	as required by § 23-76.1.
37 38	6. The Board of the Virginia College Savings Plan for the selection of services related to the operation and administration of the Plan, including, but not limited to, contracts or agreements for the
39	management, purchase, or sale of authorized investments or actuarial, record keeping, or consulting
40	services. However, such selection shall be governed by the standard set forth in § 23-38.80.
41 42	7. Public institutions of higher education for the purchase of Items for resale at retail bookstores and similar retail outlets operated by such institutions. However, such purchase procedures shall provide for
43	competition where practicable.
44 45	8. The purchase of goods and services by agencies of the legislative branch that may be specifically exempted therefrom by the Chairman of the Committee on Rules of either the House of Delegates or the

47	exemption shall be in writing and kept on file with the agency's disbursement records.
48 49	9. Any town with a population of less than 3,500, except as stipulated in the provisions of §§ 2.2-4305, 2.2-4308, 2.2-4315, 2.2-4311, 2.2-4330, 2.2-4333 through 2.2-4338, 2.2-4343.1, and
50	2.2-4303, 2.2-4303, 2.2-4313, 2.2-4311, 2.2-4330, 2.2-4355 through 2.2-4358, 2.2-4345.1, and 2.2-4367 through 2.2-4377.
51	10. Any county, city or town whose governing body has adopted, by ordinance or resolution,
52 53	alternative policies and procedures which are (i) based on competitive principles and (ii) generally applicable to procurement of goods and services by such governing body and its agencies, except as
54	stipulated in subdivision 12.
55	This exemption shall be applicable only so long as such policies and procedures, or other policies
56	and procedures meeting the requirements of § 2.2-4300, remain in effect in such county, city or town.

57 Such policies and standards may provide for incentive contracting which offers a contractor whose bid is 58 accepted the opportunity to share in any cost savings realized by the locality when project costs are INTRODUCED

59 reduced by such contractor, without affecting project quality, during construction of the project. The fee, 60 if any, charged by the project engineer or architect for determining such cost savings shall be paid as a separate cost and shall not be calculated as part of any cost savings. 61

11. Any school division whose school board has adopted, by policy or regulation, alternative policies 62 63 and procedures which are (i) based on competitive principles and (ii) generally applicable to 64 procurement of goods and services by the school board, except as stipulated in subdivision 12.

65 This exemption shall be applicable only so long as such policies and procedures, or other policies or procedures meeting the requirements of § 2.2-4300, remain in effect in such school division. This 66 provision shall not exempt any school division from any centralized purchasing ordinance duly adopted 67 68 by a local governing body.

69 12. Notwithstanding the exemptions set forth in subdivisions 9 through 12, the provisions of subsections C and D of §§ 2.2-4303, and §§ 2.2-4305, 2.2-4308, 2.2-4311, 2.2-4315, 2.2-4317 2.2-4330, 2.2-4333 through 2.2-4338, 2.2-4343.1, and 2.2-4367 through 2.2-4377 shall apply to all counties, cities 70 71 72 and school divisions, and to all towns having a population greater than 3,500 in the Commonwealth.

73 The method for procurement of professional services set forth in subdivision 3. a. of § 2.2-4301 in 74 the definition of competitive negotiation shall also apply to all counties, cities and school divisions, and to all towns having a population greater than 3,500, where the cost of the professional service is 75 expected to exceed \$30,000 in the aggregate or for the sum of all phases of a contract or project. A 76 77 school board that makes purchases through its public school foundation or purchases educational 78 technology through its educational technology foundation, either as may be established pursuant to 79 § 22.1-212.2:2 shall be exempt from the provisions of this chapter, except, relative to such purchases, 80 the school board shall comply with the provisions of §§ 2.2-4311 and 2.2-4367 through 2.2-4377.

81 13. A public body which is also a utility operator may purchase services through or participate in contracts awarded by one or more utility operators which are not public bodies for utility marking services as required by the Underground Utility Damage Prevention Act (§ 56-265.14 et seq.). A 82 83 purchase of services under this subdivision may deviate from the procurement procedures set forth in 84 85 this chapter upon a determination made in advance by the public body and set forth in writing that competitive sealed bidding is either not practicable or not fiscally advantageous to the public, and the 86 87 contract is awarded based on competitive principles.

88 14. Procurement of any construction or planning and design services for construction by a Virginia 89 nonprofit corporation or organization not otherwise specifically exempted when (i) the planning, design 90 or construction is funded by state appropriations of \$10,000 or less or (ii) the Virginia nonprofit 91 corporation or organization is obligated to conform to procurement procedures that are established by 92 federal statutes or regulations, whether those federal procedures are in conformance with the provisions 93 of this chapter.

94 15. The provisions of this chapter shall not apply to purchases, exchanges, gifts or sales by the 95 Citizens' Advisory Council on Furnishing and Interpreting the Executive Mansion.

96 B. Where a procurement transaction involves the expenditure of federal assistance or contract funds, 97 the receipt of which is conditioned upon compliance with mandatory requirements in federal laws or 98 regulations not in conformance with the provisions of this chapter, a public body may comply with such 99 federal requirements, notwithstanding the provisions of this chapter, only upon the written determination 100 of the Governor, in the case of state agencies, or the governing body, in the case of political 101 subdivisions, that acceptance of the grant or contract funds under the applicable conditions is in the 102 public interest. Such determination shall state the specific provision of this chapter in conflict with the 103 conditions of the grant or contract. 104

§ 2.2-4517. Exemption from Act.

105 The provisions of this chapter shall not apply to the investment of endowment funds, endowment 106 income, and gifts by the board of visitors of the University of Virginia as provided in § 23-76.1.

107 § 23-76.1. Investment of endowment funds, endowment income, and gifts; standard of care; liability; 108 exemption from the Virginia Public Procurement Act and the Investment of Public Funds Act.

109 A. The board of visitors shall invest and manage the endowment funds and may invest and manage 110 endowment income and gifts of the University in accordance with this section and the provisions of the 111 Uniform Management of Institutional Funds Act (§ 55-268.1 et seq.).

B. No member of the board of visitors shall be personally liable for losses suffered by an 112 113 endowment fund or endowment income and gifts arising from investments made pursuant to the 114 provisions of subsection A.

C. The investment and management of endowment funds and endowment income and gifts of the 115 116 University shall not be subject to the provisions of the Virginia Public Procurement Act (§ 2.2-4300 et 117 seq.) or the Investment of Public Funds Act (§ 2.2-4500 et seq.).

D. In addition to the investment practices authorized by the Uniform Management of Institutional 118 119 Funds Act (§ 55-268.1 et seq.), the board of visitors may also invest or reinvest the endowment funds, 120 endowment income, and gifts in derivatives, options, and financial securities.

121 1. In this section, "derivative" means a contract or financial instrument or a combination of contracts
122 and financial instruments, including, without limitation, any contract commonly known as a "swap,"
123 which gives the University the right or obligation to deliver or receive delivery of, or make or receive
124 payments based on, changes in the price, value, yield or other characteristic of a tangible or intangible
125 asset or group of assets, or changes in a rate, an index of prices or rates, or other market indicator for
126 an asset or a group of assets.

127 2. In this section, an "option" means an agreement or contract whereby the University may grant or receive the right to purchase or sell, or pay or receive the value of, any personal property asset including, without limitation, any agreement or contract which relates to any security, contract or agreement.

131 3. In this section, "financial security" means any note, stock, treasury stock, bond, debenture, 132 evidence of indebtedness, certificate of interest, collateral-trust certificate, preorganization certificate or 133 subscription, transferable share, investment contract, voting-trust certificate, certificate of deposit for a 134 security, fractional undivided interest in oil, gas, or other mineral rights, any put, call, straddle, option, 135 or privilege on any security, certificate of deposit, or group or index of securities (including any interest 136 therein or based on the value thereof), or any put, call, straddle, option, or privilege entered into on a 137 national securities exchange relating to foreign currency, or, in general, any interest or instrument 138 commonly known as a "security," or any certificate of interest or participation in, temporary or interim 139 certificate for, receipt for, guarantee of, or warrant or right to subscribe to or purchase, any of the 140 foregoing.
