**SENATE BILL NO. 499** 1 Senate Amendments in [] - February 12, 2002 2 3 A BILL to amend and reenact § 46.2-725 of the Code of Virginia, relating to special license plates for 4 military combat units with at least 50 but fewer than 350 members; fees. 5 Patron prior to Engrossment-Senator Watkins 6 7 Referred to Committee on Transportation 8 9 Be it enacted by the General Assembly of Virginia: 10 1. That § 46.2-725 of the Code of Virginia is amended and reenacted as follows: § 46.2-725. Special license plates, generally. 11 A. No series of special license plates shall be created or issued by the Commissioner or the 12 Department except as authorized in this article. No special license plates in any series not provided for 13 in this article and no registration decal for any such license plate shall be issued, reissued, or renewed 14 15 on or after July 1, 1995. However, subject to the limitations contained in subdivisions 1 and 2 of 16 subsection B of this section, the Commissioner may issue special license plates that are combinations of no more than two series of special license plates authorized in this article and currently issued by the 17 Department; the fee for any such combination shall be equal to the sum of the fees for the two series 18 plus the fee for reserved numbers and letters, if applicable. The provisions of subdivisions 1 and 2 of 19 20 subsection B of this section shall not apply to special license plates that are combinations of two series of special license plates authorized in this article and currently issued by the Department if one of the 21 22 two combined designs, when feasible, incorporates or includes the international symbol of access. 23 B. Except as otherwise provided in this article: 24 1. No license plates provided for in this article shall be issued until the Commissioner receives at 25 least 350 prepaid applications therefor. In the event that 350 or more prepaid applications have not been received on or before the last day of the third year from the date the license plates were last authorized, 26 27 no such license plates shall be issued unless the license plates are reauthorized by the General 28 Assembly. Such reauthorized license plates shall remain subject to the provisions of this article; 29 2. No additional license plates shall be issued or reissued in any series that, after five or more years 30 of issuance, has fewer than 100 active sets of plates, unless applications therefor again meet the criterion of subdivision 1 of this subsection; and 31 3. The annual fee for the issuance of any license plates issued pursuant to this article shall be ten 32 33 dollars plus the prescribed fee for state license plates. Applications for all special license plates issued pursuant to this article shall be on forms prescribed by the Commissioner. All special license plates 34 35 issued pursuant to this article shall be of designs prescribed by the Commissioner and shall bear unique 36 letters and numerals, clearly distinguishable from any other license plate designs, and be readily 37 identifiable by law-enforcement personnel. No other state license plates shall be required on any vehicles bearing special license plates issued 38 39 under the provisions of this article. 40 All fees collected by the Department under this article shall be paid by the Commissioner into the 41 state treasury and shall be set aside as a special fund to be used to meet the expenses of the 42 Department. C. The provisions of this article relating to registration fees shall apply only to those vehicles 43 44 registered as passenger cars, motor homes, and pick-up or panel trucks, as defined in § 46.2-100. All other vehicle types registered with special license plates shall be subject to the appropriate special 45 46 license plate fees, registration fees and other fees prescribed by law for such vehicle types. 47 D. Notwithstanding the provisions of subdivision B.1., those special license plates authorized by the 48 General Assembly for current or former members of current or former military combat units that have 49 at least 50 but fewer than 350 members may apply directly to the Department for issuance of special license plates for current or former members of such units. Except as otherwise provided in this 50 51 subsection, applications for such special license plates shall be subject to the requirements for the 52 issuance of special license plates prescribed by this article and [ regulations the policies and 53 procedures ] of the Department. In addition to the prescribed registration fee, special license plates issued pursuant to this subsection shall be subject to (i) the ten-dollar annual fee prescribed in 54 subdivision B. 3. and (ii) an additional one-time fee of ten dollars. 55
