| 11 | Be it enacted by the General Assembly of Virginia: |
| 12 | 1. That § 54.1-300, as it is currently effective and as it shall become effective, §§ 54.1-2200 through |
| 13 | 54.1-2203, 54.1-2206, 54.1-2207 and 54.1-2208 of the Code of Virginia are amended and reenacted, |
| 14 15 | and that the Code of Virginia is amended by adding sections numbered 54.1-2206.1 and 54.1-2206.2 or follower |
| 15 16 | 54.1-2206.2 as follows: § 54.1-300. (Effective until July 1, 2003) Definitions. |

- **63** § 54.1-2200. Definitions.
- 64 As used in this chapter, unless the context requires a different meaning:
- 65 "Board" means the Board for Professional Soil Scientists and Wetland Professionals.
- 66 "Department" means the Department of Professional and Occupational Regulation.
- 67 "Eligible soil scientist" means a person who possesses the qualifications specified in this chapter to 68 become certified.

69 "Eligible wetland professional" means a person who possesses the qualifications specified in this 70 chapter to become certified.

⁷¹ "Practice of soil evaluation" means the evaluation of soil by accepted principles and methods
⁷² including, but not limited to, observation, investigation, and consultation on measured, observed and
⁷³ inferred soils and their properties; analysis of the effects of these properties on the use and management
⁷⁴ of various kinds of soil; and preparation of soil descriptions, maps, reports and interpretive drawings.

"Practice of wetland delineation" means the delineation of wetlands by accepted principles and
methods including, but not limited to, observation, investigation, and consultation on soil, vegetation,
and hydrologic parameters; and preparation of wetland delineations, descriptions, reports and
interpretive drawings.

79 "Soil" means the groups of natural bodies occupying the unconsolidated portion of the earth's surface
80 which are capable of supporting plant life and have properties caused by the combined effects, as
81 modified by topography and time, of climate and living organisms upon parent materials.

82 "Soil evaluation" means plotting soil boundaries, describing and evaluating the kinds of soil and predicting their suitability for and response to various uses.

84 "Soil science" means the science dealing with the physical, chemical, mineralogical, and biological85 properties of soils as natural bodies.

¹ "Soil scientist" means a person having special knowledge of soil science and the methods and principles of soil evaluation as acquired by education and experience in the formation, description and mapping of soils.

89 "Virginia certified professional soil scientist" means a person who possesses the qualifications
90 required for certification by the provisions of this chapter and the regulations of the Board and who has
91 been granted certification by the Board.

92 "Virginia certified professional wetland delineator" means a person who possesses the qualifications
93 required for certification by the provisions of this chapter and the regulations of the Board and who is
94 granted certification by the Board.

95 "Wetland delineation" means delineating wetland limits in accordance with prevailing state and 96 federal regulatory guidance and describing wetland types.

97 "Wetland professional" means a person having special knowledge of wetland science and the
98 methods and principles of wetland delineation as acquired by education and experience in the
99 formation, description and mapping of wetlands.

100 "Wetland science" means the science dealing with the physical, chemical, and biological properties 101 of wetland systems integrated through ecological and morphological relationships.

102 "Wetlands" means the same as that term is defined in § 62.1-44.3 and § 28.2-1300.

103 § 54.1-2201. Exceptions.

A. The certification program programs set forth in this chapter is are voluntary and shall not be construed to prohibit:

106 1. The practice of soil evaluation or wetland delineation by individuals who are not certified soil107 scientists or certified professional wetland delineators as defined in this chapter;

108 2. The work of an employee or a subordinate of a certified soil scientist or of an individual who is practicing soil evaluation without being certified; or

110 3. The work of an employee or a subordinate of a certified professional wetland delineator or of an 111 individual who is practicing wetland delineation without being certified;

4. The work of any professional engineer, certified landscape architect, or land surveyor as defined
by § 54.1-400 from rendering any of the services that constitute the practice of wetland delineation or
the practice of soil evaluation; or

3. 5. The practice of any profession or occupation which is regulated by another regulatory board
 within the Department of Professional and Occupational Regulation.

B. Nothing in this chapter shall authorize an individual to engage in the practice of engineering, the
practice of land surveying or to use the title of landscape architect, unless such individual is licensed or
certified pursuant to Chapter 4 (§ 54.1-400 et seq.) of Title 54.1.

120 § 54.1-2202. Board; membership; quorum.

121 Notwithstanding the provisions of § 54.1-200, the Board for Professional Soil Scientists and Wetland

122 *Professionals* shall be composed of five seven members as follows: four three certified professional soil 123 scientists, three certified professional wetland delineators and one citizen member. Of the professional 124 members, one shall have experience in soil mapping and classification, one shall have experience in soil 125 suitability and land use, one shall have experience in teaching and research in soil science and one shall 126 have experience with environmental protection regulations. The professional soil scientist members shall 127 have experience in at least one of the following areas (i) soil mapping and classification, (ii) soil 128 suitability and land use, (iii) teaching and research in soil science, and (iv) environmental protection 129 regulations. Of the wetland professional members, one shall have experience in wetland delineation and 130 description, one shall have experience in teaching and research in wetland science and one shall have 131 experience with natural resource regulations. The terms of the members shall be four years. For the 132 initial appointments of the wetland professionals the terms shall be as follows: one member shall serve 133 a term of two years, one member shall serve a term of three years, and one member shall serve a term 134 of four years. Initial appointments of wetland professional members to the Board shall not be certified 135 professional wetland delineators but shall have a record of at least ten years of experience in wetland 136 delineation. Subsequent terms of the members shall be for four years.

137 The Board shall annually elect a chairman from its membership. Three members of the Board, two of
 138 whom shall be soil scientists, shall constitute a quorum. Four Board members, consisting of two soil
 139 scientists and two professional wetland delineators, shall constitute a quorum.

140 The Governor may select the professional soil scientist members from a list of at least three names 141 for each vacancy submitted by the Virginia Association of Professional Soil Scientists. The Governor 142 may notify the Virginia Association of Professional Soil Scientists of any professional vacancy other 143 than by expiration among the professional *soil scientist* members of the Board and nominations may be 144 made for the filling of the vacancy.

The Governor may select the wetland professionals from a list of at least three names for each
vacancy submitted by the Virginia Association of Wetland Professionals. The Governor may notify and
request nominations from the Virginia Association of Wetland Professionals of any professional vacancy
other than by expiration among the wetland professional members.

149 § 54.1-2203. Eligibility for certification.

A. Any person practicing or offering to practice as a soil scientist in this the Commonwealth may
 submit to the Board evidence of qualification to be certified as provided in this chapter. The Board may
 certify any applicant who has satisfactorily met the requirements of this chapter and its regulations and
 shall specify on the certificate the appropriate endorsement.

B. Any person practicing or offering to practice as a wetland professional in the Commonwealth may
submit to the Board evidence of qualification to be a certified professional wetland delineator as
provided in this chapter. The Board may certify any applicant who has satisfactorily met the
requirements of this chapter and its regulations and shall specify on the certificate the appropriate
endorsement.

159 C. Any individual who allows his certification to lapse by failing to renew the certificate or failing to
 160 meet professional activity requirements stipulated in the regulations may be reinstated by the Board upon
 161 submission of satisfactory evidence that he is practicing in a competent manner and upon payment of
 162 the prescribed fee.

163 § 54.1-2206. Waiver of examination.

164 A. The Board may waive the requirement for examination pursuant to § 54.1-2205 (i) upon written 165 application from an individual who holds an unexpired certificate or its equivalent issued by a regulatory 166 body of another state, territory or possession of the United States and is not the subject of any 167 disciplinary proceeding before such regulatory body which could result in the suspension or revocation 168 of his certificate, if such other state, territory or possession recognizes the certificates issued by the Board; and (ii) upon written application from an individual who has not been examined in the principles 169 170 and practice of soil evaluation as required by § 54.1-2205 when such individual has a record of at least 171 ten years of experience in soil evaluation, the quality of which demonstrates to the Board that the 172 applicant is competent to practice as a professional soil scientist.

173 B. The Board shall waive the requirement for examination pursuant to § 54.1-2206.2 upon the 174 written application from an individual who (i) holds an unexpired certificate or its equivalent issued by 175 a regulatory body of another state, territory or possession of the United States or has been provisionally 176 certified under the U.S. Army Corps of Engineers Wetland Delineator Certification Program of 1993 177 and is not the subject of any disciplinary proceeding before such regulatory body, which could result in 178 the suspension or revocation of his certificate or (ii) has a record of at least ten years of experience in 179 wetland delineation the quality of which demonstrates to the Board that the applicant is competent to 180 practice as a certified professional wetland delineator. This provision shall expire two years after 181 *initiation of the program.*

182 § 54.1-2206.1. Requirements for application for professional wetland delineator certification.

183 The Board may certify any applicant as a Virginia certified professional wetland delineator who has 184 submitted satisfactory evidence verified by affidavits that the applicant:

185 1. Is eighteen years of age or older;

186 2. Is of good moral character; and

187 3. Has successfully completed such educational and experiential requirements as are required by this chapter and the regulations of the Board. 188

§ 54.1-2206.2. Requirements for professional wetland delineator certification.

190 A. In order to be certified as a professional wetland delineator, an applicant shall achieve a score 191 acceptable to the Board on an examination, which may include a field practicum, in the principles and 192 practice of wetland delineation, provide three written references from wetland professionals with at least 193 one from a certified professional wetland delineator, and satisfy one of the following criteria:

194 1. Hold a bachelor's degree from an accredited institution of higher education in a wetland science, 195 biology, biological engineering, civil and environmental engineering, ecology, soil science, geology, hydrology or any similar biological, physical, natural science or environmental engineering curriculum that has been approved by the Board; have successfully completed a course of instruction, in state and 196 197 198 federal wetland delineation methods, that has been approved by the Board; and have at least four years 199 of experience in wetland delineation under the supervision of a certified professional wetland delineator, 200 the quality of which demonstrates to the Board that the applicant is competent to practice as a certified 201 professional wetland delineator;

202 2. Have a record of at least six years of experience in wetland delineation under the supervision of a 203 certified professional wetland delineator, the quality of which demonstrates to the Board that the applicant is competent to practice as a certified professional wetland delineator; or 204

205 3. Have a record of at least four years of experience in wetland science research or as a teacher of 206 wetlands curriculum in an accredited institution of higher education, the quality of which demonstrates 207 to the Board that the applicant is competent to practice as a certified professional wetland delineator.

208 B. Notwithstanding the requirements of subsection A, the requirement for a reference from and 209 supervision by a certified professional wetland delineator shall be waived for the first two years of the 210 program. 211

§ 54.1-2207. Unprofessional conduct.

212 Any professional soil scientist or wetland delineator who is certified as provided in this chapter shall 213 be considered guilty of unprofessional conduct and subject to disciplinary action by the Board, if he: 214

1. Obtains his certification through fraud or deceit;

215 2. Violates or cooperates with others in violating any provision of this chapter, the Code of 216 Professional Ethics and Conduct or any regulation of the Board; 217

3. Performs any act likely to deceive, defraud or harm the public;

218 4. Demonstrates gross negligence, incompetence or misconduct in the practice of soil evaluation or 219 wetland delineation; or 220

5. Is convicted of a felony.

§ 54.1-2208. Unlawful representation as a certified professional soil scientist or wetland delineator.

222 A. No person shall represent himself as a certified professional soil scientist unless he has been so 223 certified by the Board. Any person practicing or offering to practice soil evaluation within the meaning 224 of this chapter who, through verbal claim, sign, advertisement, or letterhead, represents himself as a 225 certified professional soil scientist without holding such a certificate from the Board shall be guilty of a 226 Class 1 misdemeanor.

227 B. No person shall represent himself as a certified professional wetland delineator unless he has 228 been so certified by the Board. Any person practicing or offering to practice wetland delineation within the meaning of this chapter who, through verbal claim, sign, advertisement, or letterhead, represents 229 230 himself as a certified professional wetland delineator without holding such a certificate from the Board 231 shall be guilty of a Class 1 misdemeanor.

232 2. That the provisions of the first enactment of this act shall become effective on July 1, 2004, except that the provisions of § 54.1-2202 shall become effective in due course. 233

234 3. That the provisions of this act shall not affect current members of the Board for Professional 235 Soil Scientists whose terms have not expired as of July 1, 2002.

236 4. That the Governor shall appoint one wetland professional in accordance with § 54.1-2002 to 237 replace a current member of the Board for Soil Scientist whose term has expired as of July 1, 238 2002.

239 5. That the provisions of § 54.1-2202 of this act requiring two wetland professionals for the 240 purposes of establishing a quorum for meetings of the Board for Professional Soil Scientists and

241 Wetland Professionals shall not become effective until the Governor appoints the initial wetland 242

professionals to the Board.
