Summary/PurposeThebillauthorizestheissuanceofCommonwealthofVirginiaParkand RecreationalFacilitiesBondspursuanttoArticleX,Section9(b)oftheConstitutionof Virginiainanamountnotexceeding\$119,040,000,subjecttoapprovalbyamajorityoft he qualifiedvotersoftheCommonwealthvotingthereonattheNovember5,2002,general election.Thepurposeofthebondsistoprovidefundsfor(i)acquiringlandanddeveloping stateparks;(ii)acquiringlandfornaturalareapreservation;and(iii) constructionofnumerous specifiedprojectsatexistingstateparks.ThefullfaithandcreditoftheCommonwealthis pledgedforthepaymentoftheprincipalofandinterestonthebondsandanybond anticipationnotesorrefundingbonds.

Thisbillalso contains a sapre condition for authorization that the Governor prepare and release aplan, to the chairmen of the Senate Finance and House Appropriations Committees by December 1,2002, for the orderly is suance of the bonds. The planis required to include the development of processes to expedite the capital outlay review process and the development of detailed drawschedules, to the extent practicable, and an estimate of the net additional costs of staffing and equipping such projects.

The bill contains a second enactment clause that requires the Secretary of Finance to provide to the chairmen of the Senate Finance and House Appropriations committees, by April 1 and September 1 of each year, a status report on the projects, including compliance with the preconditions as set out for the initial authorization of the projects.

- 8. Fiscalimplications: Thedebtserviceimpactiscomputedbasedonpreliminarydraw scheduleswiththeassumptionoffivetax -exemptbondissues:\$6.1millioninFY2003,\$15.8 millioninFY2004,\$32.0millioninFY2005,\$30.2millioninFY2006,and\$34.9m illionin FY2007.Thisdoesnotfactorintheuseoftax -exemptcommercialpapertoprovideinterim fundingfortheseprojects.Onceallbondsareissued,annualdebtservicewouldpeakat approximately\$12.5millionin2008 anddeclinethereafter .The issuanceofthebondswillbe structuredsothatdebtservicepaymentswouldnotbeginuntil December2003,whichisinFY 2004.

ThefiscalimpactontheDepartmentofConservationandRecreation(DCR)wouldaffectboth expendituresandrevenues.Som eoftheprojectsproposedinthebillwouldgenerate additionalrevenuesforthestateparksystem.However,thedepartmentwouldrequire additionalfundstooperateandmaintainthemajorityofthenewfacilitiesonceacquisition and/orconstructionis completed.Allofthesecostswouldlikelybeoutsidethe2002 -2004 biennium.ThedepartmentwouldalsorequireadditionalpositionsbeginninginFY2004to overseethedesignandconstructionoftheseprojects.Restrictedpositionswhosepayrollcosts arechargeddirectlytotherelatedbondprojectsmaybeutilized.

FortheNovember2002generalelection, the StateBoard of Elections would incurcosts of about \$40,000 for printing informational materials and for advertising the ballot initiative. For further discussion regarding the funding needs of the StateBoard of Elections related to the total costs of all the bond referend a, please refer to the fiscal impacts tatement on SB 131.
