Fiscalimplications: Currently,theCommonwealthreceivestheinterestontheMedical Center'snongeneralfundcashbalancesheldondepositwiththeStateTreasurer.Thelegislation couldcreateageneral fundlossof\$5.0millioninfuturebiennia.Basedonestimatesbythe DepartmentoftheTreasury,theMedicalCenterhasanannualaveragecashbalanceof approximately\$45million.Usinganinterestrateof5.5percent,theyieldontheMedicalCenter balancesisapproximately\$2.5millionperyear.
