Budgetamendmentnecessary:No.Thebillstatesthat"theComptrollerofthe Commonwealthisinstructedandempoweredtodrawannualwa rrantsupontheState Treasurerfromanysumsthatmaybeprovided in the general appropriation act, infavor of the treasurersofRevolutionaryWarmemorialassociationscaringforcemeteries..."Inasimilar programforthemaintenanceofConfederategrav es,languageintheAppropriationAct specifies the funding provided to the Department of Historic Resources to distribute for the careofgraves. The General Assembly did not provide funding in the budget bill as passed for maintenanceofRevolutionaryW argraves. Therefore, since it is not funded in fiscal years 2003and2004, payments will not be made to the memorial association suntil an appropriation isprovided.
- 8. Fiscalimplications: The bill provides for allocation of the appropriations made by asedonthe numberofgravesineachcemeterysetforthinthebillmultipliedbyfivedollarsorthe averageannualcostofroutinemaintenancepergrave, whicheverisgreater. If funded, the expenditureimpactwouldbe\$2,845,asderivedbymultiplying thenumberofRevolutionary Wargraves(569)bythefive -dollarcostpergrave. As discussed above, there is no appropriation for the care of Revolutionary Wargraves in fiscal years 2003 and 2004. When implemented, the Department of Historic Resources w illincursomeminimaladministrative coststoimplementtheprogramthatwillbeabsorbedintheagency'sbudget.
