- 8. Fiscalimplications: Implementingthisbillwouldrequire:
  - Up-frontcoststodesignthenewMedalofValor(estimatedat\$2,000).Th eseexpenses wouldoccurinFY2003.
  - Up-frontcoststomanufacturesufficientquantityofthemedalstolastforaboutfive years,whichwouldbemoreeconomicalinthelongrunthanmanufacturingeachyear onlythethreetobeawardedthatyear).Thisco stisestimatedatabout\$500.These expenseswouldoccurinFY2003.
  - AnnualexpensesforreimbursementofexpensesofthemembersoftheMedalofValor ReviewBoard,estimatedatamaximumof\$2,226(assumingthatallsevenmembersof theboardrequireo vernightaccommodationfortwomeetingsperyear). These expenses

wouldoccurinFY2003andannuallythereafter.[Note,Theamendedbillremovesthe languagethatspecifiesthatmembersoftheboardshallreceivenocompensationbutshall bereimbursed forexpenses.However,section2.2 -2825statesthatallpersonsconducting statebusinessmaybereimbursedforactualexpenses,whichappliesinthiscase.)
