5. Summary/Purpose:

Publicutilities;telecommunication sservices.Providesthatanylocalitythatoperatesan electric distribution system may provide tele communications services, including local exchangetelephoneservice, within or outside its boundaries if the locality obtains a certificate pursuantto § 56-265.4:4and complies with all applicable laws. The certificate for local exchangeserviceorinterexchangeservicegrantedbytheStateCorporationCommissionafter July1,2002,shallbeforservicethroughouttheCommonwealthunlesstheapplicant specifically requests a different certificated service territory. Each local exchange carrier that wascertificatedbeforeJuly1,2001,toprovideserviceinpartoftheCommonwealthshallbe certificatedtoprovidelocalexchangeservicethroughouttheComm onwealthbeginning September1,2002, unless the local exchange carrier notifies the Commission prior to September1,2002, that it elects to retain its existing certificated service territory. No locality providingsuchservicesshallacquirefacilities orotherpropertyofanytelecommunications serviceproviderbyeminentdomain. Anewsection has been added to Title 56 pertaining to anti-competitiveacts(§56 -479.2). Also repeals §56 -484.7:3 pertaining to availability of servicebylessee.

8. Fiscalimplications: Thisbillwouldhaveafiscalimpacton the State Corporation Commission's special regulatory revenue fund provided municipals begin providing service. There is however, now ay at this point to determine how much additional revenue would be generated since there is no past data available on municipal telephone companies. This tax is set at a maximum of two -ten the sofone percent and is based on intrastate revenue only.

TheHouseCommitteesubstitutewasamendedontheHousefloortoprovidethatthelocality mayprovidetelecommunicationsserviceswithinanylocalityinwhichithaselectricdistribution systemfacilitiesasofMarch1,2002.Anylocalityprovidingtelecommunicationsserviceson March1,2002,mayprovidesuchserviceswithinanylocalitywithin75milesofthegeographic boundariesofitselectricdistributionsystemassuchsystemexisted onMarch1,2002.However, §56-265.4:4B1(seeaddedlines307 -316)doesnotreflectthislimitationandprovidesforthe possibilityofcertificatesin"anyterritoryoftheCommonwealth"and"throughoutthe Commonwealth."
