RequiresthePublicDefenderCommissionto(i)requir eandensurethateachpublicdefender officecollectsandmaintainsallcaseloaddataandfieldsinthecasemanagementdatabaseonan annualbasis,(ii)reportannuallyonorbeforeJuly1totheVirginiaStateCrimeCommission,the HouseandSenateComm itteesforCourtsofJustice,theHouseCommitteeonAppropriations, andtheSenateCommitteeonFinancedetailingVirginia'srankingamongstthe50statesinterms ofpayallowedforcourt -appointedcounsel,costeffectivenessofthevariouspublicdefend er officesandthecostseffectivenessofinstallingpublicdefenderofficesintothoselocalitiesthatdo notofferpublicdefenderservicesand(iii)establishfourregionalcapitaldefenseunitsbytheend offiscalyear2004.Thebillalsorequirestha tcounselincapitalcasesbeappointedfromboththe listofqualifiedattorneysdevelopedbytheSupremeCourtandfromoneofthecapitaldefense unitsestablishedbythePublicDefenderCommission.

- 8. Fiscalimplications: Anycosts associated with the maintenance of the case management data base and the de livery of annual reports to the required committees and commissions will be minimal and can be absorbed within current resources.

Thislegislation calls for the establishment of four regional capital defenders of fices by the end of fiscal year 2004. Accor reling to the Public Defenders Commission, the phase in of two of fices in fiscal year 2003 (assuming six months of funding) will require approximately \$447,956 for operating costs and \$261,760 for start upcosts. Twelve positions will also be required. To funding for these two of fices for fiscal year 2004 will be \$895,912. The phase in of the remaining two of fices in fiscal year 2004 will cost approximately 709,716 and 12 positions, including start upcosts. The total fiscal impact for fiscal year 2004 is estimated to be \$1.6 million and 24 positions. The projected annual cost for full operation of four regional capital defenders of fices is \$1.9 million.

According to the Public Defenders Commission, each office will require one of each of the following: capital defender, deputy capital defender, assistant capital defender, mitigation/sentencing specialist, investigator/paralegal and administrative assistant.
