5 6	(Patron Prior to Substitute—Delegate Cox) A BILL to amend and reenact §§ 57-48, 57-49, 57-57 and 57-59 of the Code of Virginia, relating to
7	the registration of charitable organizations; penalties.
8	Be it enacted by the General Assembly of Virginia:
9	1. That §§ 57-48, 57-49, 57-57 and 57-59 of the Code of Virginia are amended and reenacted as
10	follows:
11	§ 57-48. Definitions.
12 13	As used in this chapter, unless the context requires a different meaning:
13 14	"Board" means the Board of Agriculture and Consumer Services. "Commissioner" means the Commissioner of Agriculture and Consumer Services, or a member of his
15	staff to whom he may delegate his duties under this chapter.
16	"Charitable organization" means any person which is or holds itself out to be organized or operated
17	for any charitable purpose, or any person which solicits or obtains contributions solicited from the
18	public. This definition shall not be deemed to include (i) any church or convention or association of
19 20	churches, primarily operated for nonsecular purposes and no part of the net income of which inures to
20 21	the direct benefit of any individual; (ii) any political party as defined in § 24.2-101 or any political campaign committee required by state or federal law to file a report or statement of contributions and
22	expenditures; or (iii) any authorized individual who solicits, by authority of such organization, solely on
23	behalf of a registered or exempt charitable organization or on behalf of an organization excluded from
24	the definition of charitable organization.
25	"Charitable purpose" means any charitable, benevolent, humane, philanthropic, patriotic, or
26	eleemosynary purpose and the purposes of influencing legislation or influencing the actions of any
27 28	public official or instigating, prosecuting, or intervening in litigation. "Civic organization" means any local service club, veterans' post, fraternal society or association,
2 9	volunteer fire or rescue groups, or local civic league or association of ten or more persons not organized
30	for profit but operated exclusively for educational or charitable purposes as defined herein, including the
31	promotion of community welfare, and the net earnings of which are devoted exclusively to charitable,
32	educational, recreational or social welfare purposes.
33 34	"Contribution" means any gift, bequest, devise or other grant of any money, credit, financial assistance or property of any kind or value, including the promise to contribute, except payments by the
35	membership of an organization for membership fees, dues, fines, or assessments, or for services rendered
36	to individual members, and except money, credit, financial assistance or property received from any
37	governmental authority. The term "contribution" shall not include any donation of blood or any gift
38	made pursuant to Article 2 (§ 32.1-289 et seq.) of Chapter 8 of Title 32.1.
39 40	"Federated fund-raising organization" means any federation of independent charitable organizations
40 41	which have voluntarily joined together, including but not limited to a United Fund or Community Chest, for purposes of raising and distributing money for and among themselves and where membership does
42	not confer operating authority and control of the individual agencies upon the federated group
43	organization.
44	"Fund-raising expenses" means the expenses of all activities that constitute or are an integral and
45	inseparable part of a solicitation.
46 47	"Membership" means those persons to whom, for payment of fees, dues, assessments, etc., an organization provides services and confers a bona fide right, privilege, professional standing, honor or
48	other direct benefit, in addition to the right to vote, elect officers, or hold offices. The term
49	"membership" shall not include those persons who are granted a membership upon making a
50	contribution as the result of solicitation.
51	"Parent organization" means that part of a charitable organization which coordinates, supervises or
52 53	exercises control over policy, fund raising, and expenditures, or assists or advises one or more chapters,
53 54	branches or affiliates. "Person" means any individual, organization, trust, foundation, association, partnership, corporation,
55	society, or other group or combination acting as a unit.
56	"Professional fund-raising counsel" means any person who for a flat fixed fee under a written
57	agreement plans, conducts, manages, carries on, advises or acts as a consultant, whether directly or
58 50	indirectly, in connection with soliciting contributions for, or on behalf of, any charitable or civic
59	organization, but who actually solicits no contributions as a part of such services. A bona fide salaried

60 officer or employee of a registered or exempt charitable organization or the bona fide salaried officer or employee of a registered parent organization shall not be deemed to be a professional fund-raising 61 62 counsel.

63 "Professional solicitor" means any person who, for a financial or other consideration, solicits 64 contributions for, or on behalf of, a charitable or civic organization, whether such solicitation is 65 performed personally or through his agents, servants, or employees or through agents, servants, or 66 employees specially employed by, or for a charitable or civic organization, who are engaged in the solicitation of contributions under the direction of such person, or any person who, for a financial or 67 other consideration, plans, conducts, manages, carries on, advises or acts as a consultant to a charitable 68 or civic organization in connection with the solicitation of contributions but does not qualify as a 69 professional fund-raising counsel. A bona fide salaried officer or employee of a registered or exempt 70 71 charitable organization or a bona fide salaried officer or employee of a registered parent organization 72 shall not be deemed to be a professional solicitor.

"Sale," "sell" and "sold" mean the transfer of any property or the rendition of any service to any 73 74 person in exchange for consideration, including any purported contribution without which such property 75 would not have been transferred or such services would not have been rendered.

76 "Solicit" and "solicitation" mean the request or appeal, directly or indirectly, for any contribution on the plea or representation that such contribution will be used for a charitable purpose, including, without 77 78 limitation, the following methods of requesting such contribution: 79

1. Any oral or written request;

80 2. Any announcement to the press, over the radio or television, or by telephone or telegraph concerning an appeal or campaign to which the public is requested to make a contribution for any 81 82 charitable purpose connected therewith;

83 3. The distribution, circulation, posting or publishing of any handbill, written advertisement or other 84 publication which directly or by implication seeks to obtain public support; or

85 4. The sale of, offer or attempt to sell, any advertisement, advertising space, subscription, ticket, or any service or tangible item in connection with which any appeal is made for any charitable purpose or 86 87 where the name of any charitable or civic organization is used or referred to in any such appeal as an 88 inducement or reason for making any such sale, or when or where in connection with any such sale, any 89 statement is made that the whole or any part of the proceeds from any such sale will be donated to any 90 charitable purpose.

91 "Solicitation" as defined herein, shall be deemed to occur when the request is made, at the place the 92 request is received, whether or not the person making the same actually receives any contribution.

"Terrorists and terrorist organizations" means any person, organization, group or conspiracy who 93 assists or has assisted terrorist organizations, as provided in 18 USC § 2339 or who commits or 94 attempts to commit acts of terrorism, as defined in § 18.2-46.4. 95 96

§ 57-49. Registration of charitable organizations.

A. Every charitable organization, except as otherwise provided in this chapter, which intends to 97 solicit contributions within this Commonwealth, or have funds solicited on its behalf, shall, prior to any 98 99 solicitation, file an initial registration statement with the Commissioner upon forms acceptable to him. 100 Each registration statement shall thereafter be refiled on or before the fifteenth day of the fifth calendar month of the next and each following fiscal year in which such charitable organization is engaged in 101 102 solicitation activities within this Commonwealth. It shall be the duty of the president, chairman or principal officer of such charitable organization to file the statements required under this chapter. Such 103 104 statement shall contain the following information: 105

1. The name of the organization and the purpose for which it was organized.

2. The principal address of the organization, the address of any offices in this Commonwealth and its 106 designated agent for process within the Commonwealth. If no such agent is designated, the organization 107 108 shall be deemed to have designated the Secretary of the Commonwealth. If the organization does not 109 maintain an office, the name and address of the person having custody of its financial records. 110

3. The names and addresses of any chapters, branches or affiliates in this Commonwealth.

111 4. The place where and the date when the organization was legally established, the form of its 112 organization, and a reference to any determination of its tax-exempt status under the Internal Revenue 113 Code.

114 5. The names and addresses of the officers, directors, trustees and the principal salaried executive 115 staff officer.

116 6. A copy of a balance sheet and income and expense statement, with the opinion of any independent public accountant, for the organization's immediately preceding fiscal year; a copy of a financial 117 statement certified by an independent public accountant covering, in a consolidated report, complete 118 information as to all the preceding year's fund-raising activities of the charitable organization, showing 119 120 kind and amount of funds raised, fund-raising expenses and allocation of disbursement of funds raised; or a copy of Internal Revenue Service Form 990. The report required by this subdivision shall comply 121

with the accounting standards prescribed pursuant to § 57-53. Any organization with gross revenue of 122 123 less than \$25,000 may submit a balance sheet and income and expense statement verified under oath or 124 affirmation by the treasurer of the organization. 125

7. A statement showing the computation of the percentages provided for in § 57-58.

126 8. A statement indicating whether the organization intends to solicit contributions from the public 127 directly or have such done on its behalf by others.

128 9. A statement indicating whether the organization is authorized by any other governmental authority 129 to solicit contributions and whether it, or any officer, professional fund-raiser or professional solicitor 130 thereof, is or has ever been enjoined by any court or otherwise prohibited from soliciting contributions 131 in any jurisdiction. 132

10. The general purpose or purposes for which the contributions to be solicited shall be used.

11. The name or names under which it intends to solicit contributions.

134 12. The names of the individuals or officers of the organization who will have final responsibility for 135 the custody of the contributions.

136 13. The names of the individuals or officers of the organization responsible for the final distribution 137 of the contributions.

138 14. A statement indicating whether the organization, or any officer, professional fund-raiser or 139 professional solicitor thereof, has ever been convicted of a felony and, if so, a description of the 140 pertinent facts.

141 15. A copy of the current articles of incorporation, bylaws, or other governing documents. If current 142 copies are already on file with the Commissioner, only amendments, if any, shall be filed in years after 143 the initial registration.

144 16. A description of the types of solicitation to be undertaken.

145 A1. Every registration statement shall that states:

146 "No funds have been or will knowingly be used, directly or indirectly, to benefit or provide support, 147 in cash or in kind, to terrorists, terrorist organizations, terrorist activities, or the family members of any 148 terrorist.'

149 A2. No person shall be registered by the Commonwealth or by any locality to solicit funds that are 150 intended to benefit or support terrorists, terrorist organizations or terrorist activities. No person shall be 151 registered by the Commonwealth or by any locality to solicit funds that are intended to benefit or 152 support a family member of any terrorist, unless a court of competent jurisdiction within the Commonwealth, upon petition of an interested person, finds by clear and convincing evidence that, for a 153 154 period of at least 3 years next preceding any act of terrorism committed by such terrorist or terrorist 155 organization, the family members to whom the benefit of the contributions shall inure have been living 156 separate and apart from the terrorist or terrorist organization, and the family members have not 157 provided any financial support, in cash or in kind, to the terrorist or terrorist organization for the same 158 period of time.

159 B. Each chapter, branch or affiliate, except an independent member agency of a federated 160 fund-raising organization, shall separately report the information required by this section or report the information to its parent organization which shall then furnish such information as to itself and all of its 161 162 state affiliates, chapters and branches in a consolidated form. All affiliated organizations included in a 163 consolidated registration statement shall be considered as one charitable organization for all purposes of 164 this chapter. If a consolidated registration statement is filed, all statements thereafter filed shall be upon 165 the same basis unless permission to change is granted by the Commissioner.

166 C. Each federated fund-raising organization shall report the information required by this section in a consolidated form. Any federated fund-raising organization may elect to exclude from its consolidated 167 168 report information relating to the separate fund-raising activities of all of its independent member agencies. No member agency of a federated fund-raising organization shall be required to report 169 170 separately any information contained in such a consolidated report. Any separate solicitations campaign 171 conducted by, or on behalf of, any such member agency shall nevertheless be subject to all other 172 provisions of this chapter.

173 D. The registration forms shall be verified under oath or affirmation by the chief fiscal officer and by 174 another authorized officer of the charitable organization.

175 E. Every charitable organization which submits an independent registration to the Commissioner shall 176 pay an annual registration fee of (i) \$30 if its gross contributions for the preceding year do not exceed 177 \$25,000; (ii) \$50 if its gross contributions exceed \$25,000 but do not exceed \$50,000; (iii) \$100 if its 178 gross contributions exceed \$50,000 but do not exceed \$100,000; (iv) \$200 if its gross contributions 179 exceed \$100,000 but do not exceed \$500,000; (v) \$250 if its gross contributions exceed \$500,000 but do 180 not exceed \$1 million; and (vi) \$325 if its gross contributions exceed \$1 million. A parent organization filing on behalf of one or more chapters, branches or affiliates or a federated fund-raising organization 181 filing on behalf of its member agencies shall pay a single annual registration fee for itself and such 182

183 chapters, branches, affiliates or member agencies included in the registration statement. Organizations 184 with no prior financial history filing an initial registration shall be required to pay an initial fee of \$100. 185 Organizations with prior financial history filing an initial registration shall be required to pay an initial 186 fee of \$100 in addition to the annual registration fee. Any organization which allows its registration to 187 lapse, without requesting an extension of time to file, shall be required to resubmit an initial registration. 188 An extension may be granted upon receipt of a written request. 189

§ 57-57. Prohibited acts.

190 A. No charitable organization shall use or exploit the fact of registration under this chapter so as to 191 lead the public to believe that such registration in any manner constitutes an endorsement or approval by 192 this Commonwealth. The use of the following statement shall not be deemed a prohibited exploitation, 193 "Registered with the Commissioner as required by law. Registration does not imply endorsement of a 194 public solicitation for contributions.'

195 B. No person shall, in connection with the solicitation of contributions or the sale of tangible 196 personal property or services represent, or lead anyone by any manner, means, practice or device 197 whatsoever to believe, that the person on whose behalf such solicitation or sale is being conducted is a bona fide charitable organization or that the proceeds of such solicitation or sale will be used for 198 199 charitable purposes, if he has reason to believe such not to be the fact.

200 C. No person shall, in connection with the solicitation of contributions or the sale of tangible 201 personal property or services for charitable purposes, represent or lead anyone by any manner, means, 202 practice or device whatsoever to believe, that any other person sponsors or endorses such solicitation of 203 contributions, sale of tangible personal property or services for charitable purposes or approves of such 204 charitable purposes or a charitable organization connected therewith when such other person has not 205 given written consent to the use of his name for these purposes.

Any member of the board of directors or trustees of a charitable organization or any other person 206 207 who has agreed either to serve or to participate in any voluntary capacity in the campaign shall be deemed thereby to have given his consent to the use of his name in said campaign. Nothing contained 208 209 in this section shall prevent the publication of names of contributors without their written consents, in an 210 annual or other periodic report issued by a charitable organization for the purpose of reporting on its 211 operations and affairs to its membership or for the purpose of reporting contributions to contributors.

D. No person shall denominate any membership fee or purchase price of goods or services sold, as a 212 213 contribution or as a donation or in any other manner represent or imply that the member or the purchaser of such goods or services will be entitled to an income tax deduction for his cost or any 214 215 portion thereof unless:

216 1. A signed opinion of counsel or an Internal Revenue Service ruling or determination letter holding 217 such cost to be deductible has been obtained; or 218

2. The member or purchaser is informed in writing that such cost may not be deductible.

219 No person shall represent or imply that a contributor will be entitled to an income tax deduction for 220 his contribution unless a signed opinion of counsel or an Internal Revenue Service ruling or 221 determination letter holding gifts to such organization to be deductible has been obtained.

222 E. No person shall make any representation that he is soliciting contributions for or on behalf of a 223 charitable or civic organization or shall use or display any emblem, device or printed matter belonging to or associated with a charitable or civic organization for the purpose of soliciting or inducing 224 225 contributions from the public without first being authorized to do so by the charitable or civic 226 organization. 227

F. No professional solicitor shall solicit in the name of or on behalf of any charitable or civic organization unless such solicitor has:

229 1. Written authorization of two officers of such organization, a copy of which shall be filed with the 230 Commissioner. Such written authorization shall bear the signature of the solicitor and shall expressly 231 state on its face the period for which it is valid, which shall not exceed one year from the date issued.

232 2. Such authorization with him when making solicitations and exhibits it on request to persons 233 solicited, police officers, or agents of the Commissioner.

234 G. No charitable or civic organization shall accept any contribution exceeding five dollars in cash or 235 tangible property without providing, on request of the donor, a written receipt acknowledging such 236 contribution on behalf of the organization.

237 H. No person, and no organization of which such person is an officer, professional fund-raising 238 counsel or professional solicitor, shall solicit within this Commonwealth if:

239 1. Such person has been convicted in any jurisdiction of embezzlement, larceny or other crime 240 involving the obtaining of money or property by false pretenses or the misapplication of funds impressed with a trust, unless such person has received a pardon for such offense or the public is 241 informed of such conviction in a manner approved in writing by the Commissioner before any 242 243 solicitation occurs; or

2. Such person has ever been enjoined by any court or otherwise prohibited from soliciting in any

245 jurisdiction, unless the Commissioner first determines in writing that such person is entitled to solicit in 246 such jurisdiction at the time of soliciting within this Commonwealth or that the reason for such 247 injunction or prohibition does not involve moral turpitude.

248 I. No person shall solicit within this Commonwealth for the benefit of any other person located 249 without the Commonwealth, if such other person refuses to supply any information which the 250 Commissioner deems necessary to assure himself that the provisions of this chapter are complied with. 251 A solicitation shall be deemed to be on behalf of every person who or which receives, directly or 252 indirectly, more than ten percent of the gross amount collected.

253 J. No charitable or civic organization shall allow a professional solicitor to solicit on its behalf if the 254 professional solicitor has not registered pursuant to § 57-61.

255 K. No charitable or civic organization, professional fund-raising counsel or professional solicitor shall 256 solicit in this Commonwealth without being duly registered or granted the appropriate exempt status 257 under this chapter.

258 L. No person shall employ in any solicitation or collection of contributions for a charitable purpose 259 any device, scheme or artifice to defraud or obtain money or property by any misrepresentation or 260 misleading statement.

261 M. No officer, agent, director or trustee of any charitable or civic organization, professional 262 fund-raising counsel or professional solicitor shall refuse or fail, after notice, to produce to the 263 Commissioner any books and records of such organization.

264 N. No person shall use or permit the use of the funds raised by a charitable solicitation for any 265 purpose other than the solicited purpose or, with respect to funds raised by general appeals, the general 266 purposes of the charitable or civic organization on whose behalf the solicitation was made.

267 O. No person shall knowingly and willfully make any false statements in any registration application 268 or statement, report or other disclosure required by this chapter.

269 P. No professional solicitor shall solicit on behalf of a charitable or civic organization unless the 270 charitable or civic organization has registered or been granted the appropriate exempt status under this 271 chapter.

272 Q. No person shall represent, in any solicitation, that tickets to events will be donated for use by 273 another unless he complies with the following requirements:

274 1. He shall have obtained commitments, in writing, from persons or charitable or civic organizations 275 stating that they will accept donated tickets and specifying the number of persons for whom they are 276 willing to accept tickets;

277 2. He shall not collect or accept more contributions for donated tickets than the number of ticket 278 commitments he has received from persons or charitable or civic organizations;

279 3. He shall have printed in advance on each ticket the exact number of persons to be admitted by the 280 ticket and the dollar price or value of each ticket; 281

4. He shall distribute the tickets in a timely fashion to those having given commitments; and

282 5. He shall maintain during the solicitation and for a period of three years thereafter: (i) records 283 reflecting the name and address of each contributor and the amount of money and number of tickets 284 donated by each such contributor; and (ii) the written commitments of each person or charitable or civic 285 organization to accept tickets and specifying the number of persons on whose behalf tickets were to be 286 accepted, as required in subdivision 1 of subsection Q of this section.

287 R. No person shall knowingly use or permit the use of funds raised by a solicitation or by 288 contribution to benefit or provide support, directly or indirectly, in cash or in kind, to terrorists, 289 terrorist organizations, terrorist activities or to family members of any terrorist.

290 § 57-59. Enforcement of chapter; penalties.

291 A. Any person who willfully and knowingly violates or causes to be violated any provision of this 292 chapter, or who willfully and knowingly gives false or incorrect information to the Commissioner in 293 filing statements or reports required by this chapter, whether such report or statement is verified or not, 294 shall be guilty of a misdemeanor and, upon conviction thereof, shall be punished for the first offense by 295 a fine of not less than \$100 and not more than \$1,000 or by confinement in jail for not more than six months, or both, and for the second and any subsequent offense by a fine of not less than \$500 and not 296 297 more than \$2,500 or by confinement in jail for not more than one year, or both.

298 The following property shall be subject to lawful seizure by any law-enforcement officer charged 299 with enforcing the provisions of this article: all moneys or other property, real or personal, together 300 with any interest or profits derived from the investment of such money and used in substantial 301 connection with an act of terrorism as defined in § 18.2-46.4. All seizures and forfeitures under this 302 section shall be governed by the procedures contained in Chapter 22.1 (§ 19.2-386.1 et seq.) of Title 303 19.2.

304 B. Whenever the Commissioner has reasonable cause to believe that a violation of this chapter may 305 have occurred, the Commissioner, upon his own motion or upon complaint of any person, may

investigate any charitable or civic organization, professional fund-raising counsel or professional solicitor
 to determine whether such charitable or civic organization, professional fund-raising counsel or
 professional solicitor has violated the provisions of this chapter. In the conduct of such investigation, the
 Commissioner may:

310 1. Require or permit any person to file a statement in writing, under oath or otherwise as the311 Commissioner determines, as to all facts and circumstances concerning the matter to be investigated.

312 2. Administer oaths or affirmations and, upon his motion or upon request of any party, subpoena
313 witnesses, compel their attendance, take evidence, and require the production of any matter which is
314 relevant to the investigation, including the existence, description, nature, custody, condition, and location
315 of any books, documents, or other tangibles and the identity and location of persons having knowledge
316 of relevant facts or any other matter reasonably calculated to lead to the discovery of material evidence.

Any proceedings or hearings by the Commissioner under this chapter, where witnesses are
subpoenaed and their attendance is required for evidence to be taken or any matter is to be produced to
ascertain material evidence, shall take place within the City of Richmond.

Upon failure to obey a subpoena and upon reasonable notice to all persons affected thereby, the
 Commissioner may apply to the Circuit Court of the City of Richmond for an order imposing
 punishment for contempt of the subpoena or compelling compliance.

323 C. Whenever the Attorney General has reasonable cause to believe that any person has operated, is
324 operating or is about to operate in violation of the provisions of this chapter, the Attorney General may
325 issue a civil investigative demand. The provisions of § 59.1-9.10 shall apply mutatis mutandis to civil investigative demands issued pursuant to this subsection.

327 D. Whenever the Attorney General, or any attorney for the Commonwealth or the attorney for any city, county or town has reason to believe that any charitable or civic organization, professional 328 329 fund-raising counsel or professional solicitor has operated, is operating or is about to operate in violation 330 of the provisions of this chapter, the Attorney General, attorney for the Commonwealth or the attorney for any city, county or town, in addition to all other actions authorized by law, may bring an action in 331 332 the name of the Commonwealth against such charitable or civic organization, professional fund-raising 333 counsel or professional solicitor, or their officers, directors, or other agents to enjoin the continuation of 334 such violation, solicitation or collection, or the engaging therein, or the conducting of any acts in 335 furtherance thereof and for such other relief as the court deems appropriate. E. In any action brought 336 under subsection D, the court may also award to the Commonwealth a civil penalty of not more than \$5,000 per violation, to be paid to the Literary Fund, reasonable expenses incurred by the state or local 337 338 agency in investigating and preparing the case, not to exceed \$250 per violation, and attorney's fees. 339 Such expenses and attorney's fees shall be paid into the general fund of the Commonwealth or of the 340 county, city, or town which such attorney represented.
