9 10	Be it enacted by the General Assembly of Virginia:
11	1. That §§ 3.1-796.73, 3.1-796.122, 18.2-403.2, and 33.1-346 of the Code of Virginia are amended
12	and reenacted as follows:
13	§ 3.1-796.73. Abandonment or dumping of animal; penalty.
14	No person shall abandon or dump any animal. Violation of this section is a Class 3 misdemeanor.
15	However, a violation of this section within any city of the Commonwealth is a Class 1 misdemeanor.
16 17	Nothing in this section shall be construed to prohibit the release of an animal by its owner to an animal
17 18	shelter, pound, humane society, or companion animal rescue agency. § 3.1-796.122. Cruelty to animals; penalty.
19	A. Any person who (i) overrides, overdrives, overloads, tortures, ill-treats, abandons, willfully inflicts
20	inhumane injury or pain not connected with bona fide scientific or medical experimentation, or cruelly
21	or unnecessarily beats, maims, mutilates, or kills any animal, whether belonging to himself or another;
22	(ii) deprives any animal of necessary food, drink, shelter or emergency veterinary treatment; (iii) sores
23	any equine for any purpose or administers drugs or medications to alter or mask such soring for the
24 25	purpose of sale, show, or exhibition of any kind, unless such administration of drugs or medications is within the context of a veterinary client-patient relationship and solely for therapeutic purposes; (iv)
$\frac{23}{26}$	willfully sets on foot, instigates, engages in, or in any way furthers any act of cruelty to any animal; (v)
27	carries or causes to be carried in or upon any vehicle, vessel or otherwise any animal in a cruel, brutal,

31 32	B. Any person who (i) tortures, willfully inflicts inhumane injury or pain not connected with bona fide scientific or medical experimentation, or cruelly and unnecessarily beats, maims, mutilates or kills
33	any animal whether belonging to himself or another; (ii) sores any equine for any purpose or administers
34	drugs or medications to alter or mask such soring for the purpose of sale, show, or exhibit of any kind,
35	unless such administration of drugs or medications is under the supervision of a licensed veterinarian
36	and solely for therapeutic purposes; (iii) instigates, engages in, or in any way furthers any act of cruelty
37 38	to any animal set forth in clause (i); or (iv) causes any of the actions described in clauses (i) through (iii), or being the owner of such animal permits such acts to be done by another; and has been within

44 45	C. Any person who abandons or dumps any dog, cat or other companion animal in any public place including the right-of-way of any public highway, road or street or on the property of another shall be
46	guilty of a Class 3 misdemeanor.
47	$\oplus C$ . Nothing in this section shall be construed to prohibit the dehorning of cattle.
<b>48</b>	ED. For the purposes of this section and §§ 3.1-796.111, 3.1-796.113, 3.1-796.114, 3.1-796.115, and
<b>49</b>	3.1-796.125, the word animal shall be construed to include birds and fowl.
50 51	FE. This section shall not prohibit authorized wildlife management activities or hunting, fishing or
51 52	trapping as regulated under other titles of the Code of Virginia, including, but not limited to Title 29.1, or to farming activities as provided under this title or regulations promulgated thereto.
53	GF. In addition to the penalties provided in subsection A, the court may, in its discretion, require
54	any person convicted of a violation of subsection A to attend an anger management or other appropriate
55	treatment program or obtain psychiatric or psychological counseling. The court may impose the costs of
56	such a program or counseling upon the person convicted.
57 59	<b>H</b> G. It is unlawful for any person to kill a domestic dog or cat for the purpose of obtaining the hide,
58	fur or pelt of the dog or cat. A violation of this subsection shall constitute a Class 1 misdemeanor. A

second or subsequent violation of this subsection shall constitute a Class 6 felony. 59

60 IH. Any person who (i) tortures, willfully inflicts inhumane injury or pain not connected with bona 61 fide scientific or medical experimentation or cruelly and unnecessarily beats, maims or mutilates any dog 62 or cat that is a companion animal whether belonging to him or another and (ii) as a direct result causes

63 the death of such dog or cat that is a companion animal, or the euthanasia of such animal on the 64 recommendation of a licensed veterinarian upon determination that such euthanasia was necessary due to

the condition of the animal, shall be guilty of a Class 6 felony. The provisions of this subsection shall 65 not overrule § 3.1-796.93:1 or § 3.1-796.116. 66

§ 18.2-403.2. Offenses involving animals /- Class 3 misdemeanors. 67

The following unlawful acts and offenses against animals shall constitute and be punished as a Class 68 69 3 misdemeanor:

70 1. Violation of § 3.1-796.71 pertaining to the failure of a shopkeeper or pet dealer to provide 71 adequate care to animals.

 $\hat{2}$ . Violation of § 3.1-796.72 pertaining to the misrepresentation of an animal's condition by the 72 73 shopkeeper or pet dealer.

74 3. Violation of § 3.1-796.73 and subsection C of § 3.1-796.122 pertaining to the abandonment of 75 animals. 76

4. Violation of § 3.1-796.70 pertaining to the sale of baby fowl.

77 5. Violation of § 3.1-796.125 pertaining to fighting cocks, dogs and other animals.

78 6. Violation of clause (iii) of subsection A of § 3.1-796.122 pertaining to soring horses.

79 7. Violation of § 3.1-796.83:2 pertaining to notice of consumer remedies required to be supplied by 80 boarding establishments.

81 § 33.1-346. Dumping trash, companion animals, etc., on highway, right-of-way or private property; 82 penalty.

83 A. It shall be unlawful for any person to dump or otherwise dispose of trash, garbage, refuse, litter, a 84 companion animal within any city limits for the purpose of disposal, or other unsightly matter, on public property, including a public highway, right-of-way, property adjacent to such highway or right-of-way, 85 or on private property without the written consent of the owner thereof or his agent. Any violation of 86 87 this subsection shall constitute a misdemeanor punishable by confinement in jail for not more than 88 twelve months and a fine of not less than \$250 or more than \$2,500, either or both.

89 B. When any person is arrested for a violation of this section, and the matter alleged to have been 90 illegally dumped or disposed of has been ejected from a motor vehicle or transported to the disposal site 91 in a motor vehicle, the arresting officer may comply with the provisions of § 46.2-936 in making such 92 arrest.

93 When a violation of the provisions of this section has been observed by any person, and the matter 94 illegally dumped or disposed of has been ejected or removed from a motor vehicle, the owner or 95 operator of such motor vehicle shall be presumed to be the person ejecting or disposing of such matter. However, such presumption shall be rebuttable by competent evidence. 96

Any person convicted of a violation of this subsection shall be guilty of a misdemeanor punishable 97 98 by confinement in jail for not more than twelve months and a fine of not less than \$250 or more than 99 \$2,500, either or both.

100 C. The governing bodies of counties, cities and towns are hereby authorized to adopt ordinances not 101 in conflict with the provisions of this section, and may repeal, amend or modify such ordinances.

D. The provisions of this section shall not apply to the lawful disposal of such matter in landfills. 102
