AMENDMENT IN THE NATURE OF A SUBSTITUTE
(Proposed by the Senate Committee on Commerce and Labor
on February 10, 2003)

(Patron Prior to Substitute—Delegate Nixon)

A BILL to amend and reenact § 60.2-602 of the Code of Virginia, relating to unemployment compensation; weekly benefit amount.

Be it enacted by the General Assembly of Virginia:

1. That § 60.2-602 of the Code of Virginia is amended and reenacted as follows:

§ 60.2-602. Weekly benefit amount.

A. Beginning September 9, 2001, and expiring January 4, 2003, for claims filed on or after September 9, 2001, and for claims for which a claimant had established a benefit year as of September 9, 2001, an eligible individual's weekly "benefit amount" shall be the amount appearing in Column B in the "Benefit Table" in this section on the line on which in Column A of such table, there appears the total wages for insured work paid to such individual in the two quarters of his base period in which such total wages were highest.
