

VIRGINIA ACTS OF ASSEMBLY — CHAPTER

An Act to amend and reenact § 4, as amended, of Chapter 308 of the Acts of Assembly of 1979, which provided a charter for the Town of Gretna, relating to council elections.

Be it enacted by the General Assembly of Virginia:

1. That § 4, as amended, of Chapter 308 of the Acts of Assembly of 1979 is amended and reenacted as follows:

§ 4. Administration and government.

A. The administration and government of the Town of Gretna shall be vested in one body, to be called the council of the Town of Gretna, which shall consist of seven members, six of whom shall be known as councilmen and one to be known as mayor, all of whom shall be residents and qualified voters of the town. The council of the town shall have power to elect or appoint such other officers as it may deem necessary, and to define their duties, including a town manager, who shall, under the control of the council, have the general charge and management of the administrative affairs and work of the town, and who shall perform such other duties as may be required of him by the council. The manager shall receive a salary as shall be allowed him by the council, and may be dismissed at any time by the council. The council may create, appoint, or elect such other departments, bodies, boards, and other officers as are hereinafter provided for, or as are permitted or required by law to be appointed by the council.

B. The present mayor and council of the Town of Gretna shall continue in office until the expiration of the term for which they were respectively elected, or until their successors are duly elected and qualified.

~~C. On the first Tuesday in May, nineteen hundred eighty, and every two years thereafter, there shall be elected at large by the qualified voters of the town of Gretna, a mayor and six councilmen of the town, and the mayor and councilmen shall constitute the town council. They~~ *The mayor shall be elected at large by the qualified voters of the Town of Gretna at a municipal election to be held on the first Tuesday in May in the year 2004 and every two years thereafter in the manner prescribed by law for a term of two years beginning on the July 1 next following his election and shall serve until his successor shall have been elected and qualified.*

In the year 2004, six councilmen shall be elected by the qualified voters of the Town of Gretna at a regular municipal election to be held on the first Tuesday in May. Those three councilmen receiving the greatest number of votes shall serve a four-year term. Those three councilmen receiving the fewest number of votes shall serve a two-year term until the year 2006. The mayor and the six councilmen shall constitute the town council of Gretna. The members of the town council shall take office on the first day of July next following their election and shall continue until their successors have been elected and qualified.

Three councilmen shall be elected at large by the qualified voters of the Town of Gretna at a regular municipal election to be held on the first Tuesday in May in the year 2006 for four-year terms.

Three councilmen shall be elected at large by the qualified voters of the Town of Gretna at a regular municipal election to be held on the first Tuesday in May in the year 2008 for four-year terms; thereafter, all councilmen shall be elected for four-year terms, in the manner prescribed by law, for terms beginning on July 1 next following their election, each of whom shall serve until his successor shall have been elected and qualified.

The council shall be a continuing body, and no measure pending before such body shall abate or be discontinued by reason of expiration of the term of office or removal of the members of such body or any of them. Every person elected shall take an oath faithfully to execute and discharge the duties of his office to the best of his judgment, and the mayor shall take an oath prescribed by law for State officers. The failure of any person elected or appointed under the provisions of this charter to qualify or to take the oath required, within the time prescribed for entering upon the discharge of the duties of the office to which he is elected or appointed, shall vacate the office, and the council shall proceed and are hereby vested with power to fill such vacancy in the manner herein prescribed.

Any vacancy occurring during the term of any member of the council shall be filled by the council by the appointment of anyone eligible to such office. A vacancy in the office of mayor shall be filled by the council from the electors of the town as soon as possible.

D. For the transaction of business by the council, four members, of whom the mayor may be counted

57 as one, shall constitute a quorum.

58 E. Each member of the council may receive a salary to be fixed by the council, payable at such
59 times, and in such manner, as the council may direct. The mayor may receive a salary to be fixed by
60 the council, payable in such manner and at such times as the council may direct. No increase in salary
61 of a council member or the mayor shall take effect during the incumbent council member's or mayor's
62 term of office.

63 F. The mayor shall preside at the meetings of the council and perform such other duties as may be
64 prescribed by this charter and by general law, and such as may be imposed by the council, consistent
65 with his office. The mayor shall have no right to vote in the council, except that in case of a tie vote
66 then the mayor shall vote.

67 G. The council shall, as soon as practicable, after qualification, choose one of its members as vice
68 mayor. The vice mayor shall perform the duties of the mayor during his absence or disability, and in
69 event of a vacancy for any reason in the office of mayor, he shall serve until a mayor is duly appointed
70 by the council or is elected. The vice mayor shall continue to have all rights, privileges, powers, duties,
71 and obligations of a councilman while performing the duties of mayor, during the absence or disability
72 of the mayor of the town. In the absence of the mayor or vice mayor, the mayor may designate a
73 member of the council to perform his duties.

74 H. The council shall, by ordinance, fix the time for their meetings, but shall have at least one
75 meeting each month. Special meetings shall be called by the clerk at the instance of the mayor or any
76 three members of the council, in writing; no business shall be transacted at a special meeting but that
77 for which it shall be called, unless the council be unanimous. The meetings of the council shall be open
78 to the public, except such meetings as may be permitted by general law to be closed.

79 I. The council shall keep a minute book, in which the clerk shall note the proceeding of the council,
80 and shall record proceedings at large on the minute book and keep the same properly indexed.

81 J. The council may adopt rules for regulating its proceedings, but no tax shall be levied or corporate
82 debt contracted, except by a vote of two-thirds of the council, four votes being counted as two-thirds,
83 which vote shall be taken by "Yeas" and "Nays," and recorded in the minute book. It may appoint such
84 committees as may be deemed proper for the transaction of business, and may compel attendance of
85 absent members.

86 K. The council may require the mayor to communicate to it annually as soon after the close of the
87 fiscal year, or more often, if necessary a general statement of the condition of the town in relation to its
88 government, finances and improvements, with such recommendations as he may deem proper. He shall
89 exercise a constant supervision over the conduct of all subordinate officers, have power and authority to
90 investigate their acts, have access to all books and documents in their offices, and may examine such
91 officer on oath. He shall have power to suspend all officers appointed by the council until the next
92 regular meeting of the council, but such suspension shall, in all cases, be for misconduct in office or
93 neglect of duty, to be specified in the order of suspension. In case of suspension of any officer, the
94 mayor shall submit a written report of the same to the council at its next regular meeting, or any
95 meeting called for that purpose, specifically designating the charge against the officer and reasons for
96 dismissal, and in case of suspension by the mayor, he shall have power to appoint some other person in
97 his place to hold such office and perform the duties thereof until the next regular meeting of the
98 council.

99 L. Every ordinance passed by the council for the violation of which a penalty is imposed shall be
100 published in such a way as the council may order, so as to give general publicity thereto, and no order
101 may become effective until so published, either by handbills posted in at least two public places, or in a
102 newspaper published and having general circulation in the town, except in the case of an emergency, in
103 which instance the ordinance shall so state and shall become effective immediately upon its passage. If
104 published by handbill, a certification of the posting thereof shall be made by the clerk or sergeant as to
105 the time and place where the ordinance is recorded; provided, however, that after the expiration of six
106 months from date of the passage of any ordinance, its publication shall not be questioned, or its validity
107 affected by any failure to publish the same.

108 M. The council may, in addition to a town manager, appoint a town sergeant, a clerk and a treasurer.
109 Such officers shall qualify and give bond, if any be required, in such amount as council may deem
110 proper. Such officers shall perform those duties as council, from time to time, may prescribe by
111 ordinance not inconsistent with the Constitution and general laws of this Commonwealth. The clerk of
112 the council and the treasurer may be one and the same person in the discretion of the council.

113 N. The council may add penalties and interest, in an amount not to exceed that provided for, if any,
114 by State law, for failure of any person or firm or corporation to pay taxes or licenses at the time
115 provided for by ordinances of the council, and there shall be a lien for all taxes assessed which may be
116 enforced as provided by general law of the Commonwealth.

117 O. The council shall issue no bonds or certificates of debt, except in anticipation of current revenue,

118 until it shall have first submitted to the qualified voters of the town by a court ordered election on the
119 question of whether or not such bonds shall be issued and a majority of the qualified voters voting at
120 any election held for such purpose shall have voted for such issue. Such election shall be held as
121 provided for by general laws of this Commonwealth including, specifically, § 24.1-165. A copy of the
122 court order shall be published at least five days before the election in some newspaper published in the
123 town or having general circulation therein. The publisher of the newspaper shall certify to the
124 publication thereof, which certification shall be recorded in the minute book of the town.

125 P. The council may provide for a sinking fund for the purpose of paying off as it matures, any
126 indebtedness of the town and may make an additional levy therefor, such sinking fund to be set aside
127 and invested as provided for hereinafter.

128 When taxes on real and personal property are collected for the year, the town treasurer shall take
129 therefrom the necessary amount of any additional sum, if any, so set apart, and deposit the same in a
130 separate account to the credit of the sinking fund in such bank or banks as the council may designate.

131 All sinking funds shall be used exclusively in the payment or purchase and redemption of the
132 outstanding bonds of the town, and when such sinking funds are not required or may not, within a
133 reasonable time, be required for payment of any bond of the town, or cannot be used to advantage in
134 purchase and redemption of any bond of the town, which may be outstanding, the same shall be
135 securely invested in interest bearing municipal, State or U. S. government bonds or obligations, or
136 invested in any security approved by the general laws of the Commonwealth of Virginia for investment
137 of such funds. Such sinking funds may be used in the payment or redemption of all bonds of the town,
138 at the discretion of the council.

139 The town council shall act as the sinking fund commission or committee and shall provide for the
140 investment, deposit and application of the funds in conformity to the provisions of this charter; and may
141 require any bank or banks receiving on deposit its revenues or any of its sinking fund a fidelity bond or
142 other security.

143 Q. The council may provide for charging and collecting fees for permits to use public facilities and
144 for public services and privileges. The town shall have the power and right to charge a different rate for
145 any service rendered or convenience furnished to citizens without the corporate limits from the rates
146 charged for similar services to citizens within the corporate limits.

147 R. The council may establish, regulate and control a department or division of fire.

148 S. The council may establish, regulate and control a department or division of police.
