11	Be it enacted by the General Assembly of Virginia:
12	1. That §§ 45.1-161.58, 45.1-161.292:31, 45.1-181, 45.1-184.2, 45.1-235, 45.1-361.29, and 45.1-361.33
13	of the Code of Virginia are amended and reenacted as follows:
14	§ 45.1-161.58. Fee to accompany application for license; fund; disposition of fees.
15	Each application for a license or a renewal or transfer of a license shall be submitted to the
16	Department, accompanied by a fee, payable to the State Treasurer, in the amount of seventy-five
17	dollars\$180. All such fees collected shall be retained by the Department and paid into the state treasury
18	and shall constitute a fund under the control of the Director. Expenditures from this fund may be made
19	by the Department for safety equipment, safety training, safety education or for any expenditure to
20	further the safety program in the mining industry. All expenditures from this fund must be approved by
20 21	the Director.
22	§ 45.1-161.292:31. Fee to accompany application for license; fund; disposition of fees.
$\frac{22}{23}$	Each application for a mineral mine license or a renewal or transfer of a license shall be submitted to
23 24	the Department, accompanied by a fee, payable to the State Treasurer, in the amount of seventy-five
25	dollars\$180. However, any person engaged in mining sand or gravel on an area of five5 acres or less
23 26	shall be required to pay a fee of twenty dollars \$48. All such fees collected shall be retained by the
27 27	Department and paid into the state treasury and shall constitute a fund under the control of the Director.
28	Expenditures from this fund may be made by the Department for safety equipment, safety training,

33 34	It shall be unlawful for any operator to engage in any mining operation in Virginia, without having first obtained from the Department a permit to engage in such operation and paying a fee therefor of

59 a reasonable estimate of the number of acres of land that will be disturbed by mining operations on the 60 area to be covered by the permit during the ensuing year; (8) whether any mining permits of any type are now held by the applicant and the number thereof; (9) the name and address of the applicant, if an 61 individual; the names and addresses of all partners, if a partnership; the state of incorporation and the 62 63 name and address of its registered agent, if a corporation; or the name and address of the trustee, if a 64 trust; and (10) if known, whether the applicant, or any subsidiary or affiliate or any partnership, 65 association, trust or corporation controlled by or under common control with applicant, or any person required to be identified by item (9) above, has ever had a mining permit of any type issued under the 66 laws of this or any other state revoked or has ever had a mining or other bond, or security deposited in 67 lieu of bond, forfeited. 68

69 The application for a permit shall be accompanied by  $\frac{1}{1000}$  copies of an accurate map or aerial photograph or plan and meeting the following requirements: 70

71 (a) Be prepared by a licensed engineer or licensed land surveyor or issued by a standard mapping service or in such a manner as to be acceptable to the Director; 72 73

(b) Identify the area to correspond with the land described in the application;

(c) Show adjacent deep mining, if any, and the boundaries of surface properties, with the names of 74 75 owners of the affected area which lie within 100 feet of any part of the affected area; 76

(d) Be drawn to a scale of 400 feet to the inch or better;

77 (e) Show the names and location of all streams, creeks or other bodies of public water, roads, 78 buildings, cemeteries, oil and gas wells, and utility lines on the area affected and within 500 feet of such 79 area:

80 (f) Show by appropriate markings the boundaries of the area of land affected, the outcrop of the 81 seam at the surface or deposit to be mined, and the total number of acres involved in the area of land 82 affected: 83

(g) Show the date on which the map was prepared, the north arrow and the quadrangle name;

84 (h) Show the drainage plan on and away from the area of land affected, including the directional 85 flow of water, constructed drainways, natural waterways used for drainage and the streams or tributaries 86 receiving the discharge.

87 Upon receipt of a written request by any landowner on whose property a sand and gravel operation 88 is permitted pursuant to this section, the operator of the sand and gravel operation shall provide a copy 89 of the map, photograph or plan to the landowner.

90 No permit shall be issued by the Department until the Director has approved the plan of operation 91 required in this section and § 45.1-182.1 and the bond from the applicant as required in § 45.1-183. 92

§ 45.1-184.2. Succession of one operator by another at uncompleted project.

93 Where one operator succeeds another at any uncompleted operation, whether by sale, assignment, 94 lease, merger, or otherwise, the Director may release the first operator from all liability under this 95 chapter as to that particular operation and transfer the permit to the successor operator; provided, however, that the successor operator has complied with the requirements of this chapter, and the 96 97 successor operator assumes as part of his obligation under this chapter, all liability for the reclamation of 98 the area of land affected by the first operator. No fee, or any portion thereof, paid by the first operator 99 shall be returned to either operator. The permit fee for the successor operator for the area of land 100 permitted by the first operator shall be six dollars \$16 per acre, except as provided by § 45.1-180.4. The mining permit for the successor operator shall be valid for one 1 year from the date of issuance and 101 102 shall be renewed thereafter in accordance with the provisions of this chapter. 103

§ 45.1-235. Form and contents of permit application; fee.

A. Application for a surface mining permit shall be made to the Division in the format required by 104 the Director and shall be signed and verified under oath by the person, or his legal representative, 105 intending to engage in the surface mining of coal. 106

107 B. The application shall contain such information as shall be required by regulations adopted by the 108 Director, including, but not limited to, the information required under the provisions of § 507 (b) of the 109 federal act.

110 C. To the extent that funds are available from the federal Office of Surface Mining, the Director 111 shall provide for permit application assistance to small operators as provided in § 507 (c) and (h) of the federal act. Such assistance shall be provided in accordance with regulations adopted by the Director. 112

113 D. Each applicant for a permit shall be required to submit to the Division as part of the permit application an operations plan and a reclamation plan which shall meet the requirements of this chapter 114 115 and regulations promulgated by the Director.

E. Each application for a coal surface mining permit issued under this chapter shall be accompanied 116 117 by a fee of twelve dollars\$26 per acre for the area of land to be affected by the total operation for which plans have been submitted. An anniversary payment of six dollars\$13 per acre for areas disturbed 118 under the permit shall be payable annually on the anniversary date of the permit. All fees collected 119 under the provisions of this chapter shall be paid into a special fund of the Department to be used for 120

121 the administration of the coal surface mining regulatory program and are hereby appropriated for that 122 purpose.

123 F. Each applicant for a coal surface mining permit shall file a copy of his application for public 124 inspection at an appropriate public office approved by the Director where the mining is proposed to 125 occur. However, information which pertains only to the analysis of the chemical and physical property 126 of the coal, excepting information regarding such mineral or elemental content which is potentially toxic 127 in the environment, shall be kept confidential upon request of the applicant and not made a matter of 128 public record.

129 G. Each applicant for a coal surface mining permit shall be required to submit to the Division as part 130 of the permit application a certificate issued by an insurance company authorized to do business in the 131 Commonwealth, certifying that the applicant has a public liability insurance policy in force for the 132 surface mining and reclamation operations for which such permit is sought. Such policy shall provide 133 for personal injury and property damage protection in an amount, not less than that specified in 134 regulations adopted by the Director, adequate to compensate any persons damaged as a result of surface coal mining and reclamation operations, including use of explosives, and entitled by law to 135 136 compensation under applicable provisions of law. Such policy shall be maintained in full force and 137 effect during the terms of the permit or any renewal, and including the length of all reclamation 138 operations. The Director is authorized to promulgate regulations which provide for the submission by the 139 applicant of evidence of self-insurance, meeting the requirements of this subsection, in lieu of a 140 certificate of a public liability insurance policy.

141 § 45.1-361.29. Permit required; gas, oil, or geophysical operations; coalbed methane gas wells; 142 environmental assessment.

143 A. No person shall commence any ground disturbing activity for a well, gathering pipeline, 144 geophysical exploration or associated activity, facilities or structures without first having obtained from 145 the Director a permit to conduct such activity. Every permit application or permit modification application filed with the Director shall be verified by the permit applicant and shall contain all data, 146 maps, plats, plans and other information as required by regulation or the Director. 147

148 B. For permits issued on July 1, 1996, or thereafter, new permits issued by the Director shall be 149 issued only for the following activities: geophysical operations, drilling, casing, equipping, stimulating, 150 producing, reworking initially productive zones and plugging a well, or gathering pipeline construction 151 and operation. Applications for new permits to conduct geophysical operations shall be accompanied by 152 an application fee of \$100\$130. Applications for all other new permits shall be accompanied by an 153 application fee of \$200\$260.

154 C. For permits issued prior to July 1, 1996, prior to commencing any reworking, deepening or 155 plugging of the well, or other activity not previously approved on the permitted site, a permittee shall first obtain a permit modification from the Director. All applications for permit modifications shall be 156 accompanied by a permit modification fee of \$100\$130. For permits issued on July 1, 1996, or 157 158 thereafter, prior to commencing any new zone completions a permittee shall first obtain a permit 159 modification from the Director.

160 D. All permits and operations provided for under this section shall conform to the rules, regulations 161 and orders of the Director and the Board. When permit terms or conditions required or provided for 162 under Article 3 (§ 45.1-361.27 et seq.) of this chapter are in conflict with any provision of a 163 conservation order issued pursuant to the provisions of Article 2 (§ 45.1-361.13 et seq.) of this chapter, 164 the terms of the permit shall control. In this event, the operator shall return to the Board for 165 reconsideration of a conservation order in light of the conflicting permit. Every permittee shall be responsible for all operations, activity or disturbances associated with the permitted site. 166

167 E. No permit or permit modification shall be issued by the Director until he has received from the 168 applicant a written certification that (i) all notice requirements of this article have been complied with, together with proof thereof, and (ii) the applicant has the right to conduct the operations as set forth in 169 170 the application and operations plan.

171 F. A permit shall be required to drill any coalbed methane gas well or to convert any methane 172 drainage borehole into a coalbed methane gas well. In addition to the other requirements of this section, 173 every permit application for a coalbed methane gas well shall include: 174

1. The method that the coalbed methane gas well operator will use to stimulate the well.

175 2. a. A signed consent from the coal operator of each coal seam which is located within 750 176 horizontal feet of the proposed well location (i) which the applicant proposes to stimulate or (ii) which 177 is within 100 vertical feet above or below a coal bearing stratum which the applicant proposes to 178 stimulate.

179 b. The consent required by this section may be (i) contained in a lease or other such agreement; (ii) 180 contained in an instrument of title; or (iii) in any case where a coal operator cannot be located or identified and the operator has complied with § 45.1-361.19, provided by a pooling order entered 181

182 pursuant to § 45.1-361.21 or § 45.1-361.22 and provided such order contains a finding that the operator 183 has exercised due diligence in attempting to identify and locate the coal operator. The consent required 184 by this section shall be deemed to be granted for any tract where title to the coal is held by multiple 185 owners if the applicant has obtained consent to stimulate from the co-tenants holding majority interest in the tract and none of the coal co-tenants has leased the tract for coal development. The requirement of 186 187 signed consent contained in this section shall in no way be considered to impair, abridge or affect any 188 contractual rights or objections arising out of a coalbed methane gas contract or coalbed methane gas 189 lease entered into prior to January 1, 1990, between the applicant and any coal operator, and any extensions or renewals thereto, and the existence of such lease or contractual arrangement and any 190 191 extensions or renewals thereto shall constitute a waiver of the requirement for the applicant to file an 192 additional signed consent.

193 3. The unit map, if any, approved by the Board.

194 G. No permit required by this chapter for activities to be conducted within an area of Tidewater 195 Virginia where drilling is authorized under subsection B of § 62.1-195.1 shall be granted until the 196 environmental impact assessment required by § 62.1-195.1 has been conducted and the assessment has 197 been reviewed by the Department.

H. The operator of any coalbed methane well drilled within 250 feet of a cemetery shall comply with 198 199 a written request of any person owning an interest in a private cemetery or the authorized agent of a 200 public cemetery that the operator of such well suspend operations for a period from two2 hours before 201 to two 2 hours after any burial service that takes place on the surface area of such cemetery. However, 202 if the well operator or a mine operator determines that suspension of such operations will have an 203 adverse effect on the safety of the well operations or mining operations, the operator shall be under no obligation to comply with the request, and operation of the well shall continue. 204 205

§ 45.1-361.33. Expiration of permits.

206 All permits issued pursuant to this chapter shall expire twenty-four24 months from their date of issuance unless the permitted activity has commenced within that time period. An operator may renew 207 208 the existing permit for an additional twenty-four24 months by submitting a written request containing the coal operator's approval and remitting a  $\frac{250}{325}$  renewal fee no later than the expiration date. 209

2. The Virginia Gas and Oil Board shall increase the fee for filing an application for the 210 establishment of units, spacing, or pooling orders, as provided for in 4 VAC 25-160-30, to \$130. 211 212 Action by the Board to increase this fee shall be exempt from the provisions of the Administrative Process Act (§ 2.2-4000 et seq. of the Code of Virginia). 213

214 3. The Department of Mines, Minerals, and Energy shall increase the fee for filing an application 215 to transfer gas or oil permit rights, as provided for in 4 VAC 25-150-120, to \$65. Action by the 216 Department to increase this fee shall be exempt from the provisions of the Administrative Process

217 Act (§ 2.2-4000 et seq. of the Code of Virginia).
