That the Code of Virginia is amended by adding a section numbered 62.1-44.38.1 as follows: 10 § 62.1-44.38:1. Comprehensive water supply planning process; state, regional and local water supply 11 12 plans. 13 A. The Board, with the advice and guidance from the Commissioner of Health, local governments, 14 public service authorities, and other interested parties, shall establish a comprehensive water supply 15 planning process for the development of local, regional and state water supply plans consistent with the 16 provisions of this chapter. This process shall be designed to (i) ensure that adequate and safe drinking water is available to all citizens of the Commonwealth, (ii) encourage, promote, and protect all other 17 18 beneficial uses of the Commonwealth's water resources, and (iii) encourage, promote, and develop 19 incentives for alternative water sources, including but not limited to desalinization. 20 B. Local or regional water supply plans shall be prepared and submitted to the Department of 21 Environmental Quality in accordance with criteria and guidelines developed by the Board. Such criteria 22 and guidelines shall take into account existing local and regional water supply planning efforts and 23 requirements imposed under other state or federal laws. 24 2. That the State Water Control Board shall promulgate regulations necessary to carry out the 25 provisions of this act, including criteria for the development of local and regional water supply plans. Draft criteria for the development of local and regional water supply plans shall be 26 27 prepared by December 1, 2003. 28 3. That the State Water Control Board shall prepare a preliminary state water resources plan in 29 accordance with § 62.1-44.38 by December 1, 2003, which includes information from existing local and regional water supply plans. The Department of Health and all other state agencies shall assist 30 31 in the preparation of the state water resources plan, and water supply systems shall provide available information, including existing water supply plans, as needed to develop the preliminary 32 state plan. The preliminary plan shall be submitted to the Governor, the Senate Committee on 33 Agriculture, Conservation and Natural Resources, the House Committee on Agriculture, 34 35 Chesapeake and Natural Resources, and the State Water Commission. 36 4. That the Water Policy Technical Advisory Committee shall work with the Department of 37 Environmental Quality and the Virginia Department of Health on the development of the plan required by this act and shall advise these agencies on any further changes needed to the 38

39 Commonwealth's water resources policies and programs.
