Fiscalimplications: Theimpactoftheproposedlegislationisnotknown.Itcannotbe determinedhowmanyattorneysfortheCommonwealthmightfailtocomplywithanorderof thecourt.AccordingtotheDepartmentofState Police,in2002therewereapproximately 235,000criminalarrestswhichdiscoverymayhavebeenanissue.Itisalsonotknownhow manydefendantsmightrequesttheStatePolicetoinvestigateaninstanceofnoncompliance byattorneysfortheCommonwealt h.Thedepartmentestimatestheproposedlegislation couldcostfrom\$518,000to\$740,000andrequireseventotenpositions.

IfitisdeterminedthatanattorneyfortheCommonwealthhasnotcompliedwiththe legislation,theattorneyisguiltyofaC lass1misdemeanor.Assuch,theattorneyissubject toasentenceofupto12monthsinjail.Anyincreaseinjailpopulationwillincreasecoststo thestate.Itisanticipatedthatanypotentialincreasewouldbeminimal.

TheCommonwealthpaysthel ocalities \$8.00 aday for each misdemean antorotherwise local responsible prisoner heldinajail. Itals of und sthemajority of the jails' operating costs, e.g. correctional officers. The state's share of these costs varies from locality to locality. According to the Compensation Board's most recent Jail Cost Report (FY 2001), the estimated to tal state support for local jails averaged \$31.83 perinmate, perday in FY 2001.
