TheChildSupportGuidelineScheduleisusedbythecourtsandtheDepartment ofSocial Services'DivisionofChildSupportEnforcementtodeterminechildsupportobligationsfor childrenofseparatedparents.Inaddition,thebillincludesseveralotherprovisionsrelatedto calculationofchildsupportawards: 1)Clarificationan dexpansionofthecomponentsofincomethatmaybeconsideredin rebuttingthepresumptionsestablishedbytheGuideline,specificallyincomefrom overtimeorasecondjob. 2)AdetailedlistofthekeyeconomicassumptionsandfactorsuponwhichtheSch edule isbased. 3)Aself -supportreserveembeddedintheSchedule,whichwillprotecttheabilityof low-incomenoncustodialparentstosupporthemselves,byensuringthatchild supportobligationswillnotreducetheirincometobelow150percentofth epoverty line. 4)Clarificationthatgrossincomeexcludessecondaryemploymentincomethatthepayor parentearnedinagoodfaithefforttopayoffchildsupportarrearagesforthechildren atissue. 5)Arequirementthatparentspayinproportionto theirincomeanyuninsuredmedical anddentalexpensesinexcessof\$250perchildperyear. 6)Newthresholdsforcalculatingtheamountforchildcarecostsincurreddueto employmentthatshouldbeaddedtothebasicchildsupportobligation,specifica lly factoringinthechildcaretaxcredit.

8. Fiscalimplications: ThenewscheduleofChildSupportGuidelines,thefirstupdatesince 1988,willbringsupportawardsintobetter alignmentwithtoday'scostofraisingchildren. Duetochangesintheguidelines,theDivisionofChildSupportEnforcement'sautomated system, APECS, will need to be updated. There is an approximate one -time cost of \$40,000 that can be absorbed within the existing Division appropriation.
