That §§ 2.2-200 and 2.2-204 of the Code of Virginia are amended and reenacted and the Code 10 of Virginia is amended by adding in Chapter 2 of Title 2.2 an article numbered 2.1, consisting of a 11 section numbered 2.2-203.3, as follows: 12 § 2.2-200. Appointment of Governor's Secretaries; general powers. 13 14 A. The Governor's Secretaries shall be appointed by the Governor, subject to confirmation by the 15 General Assembly if in session when the appointment is made, and if not in session, then at its next succeeding session. Each Secretary shall hold office at the pleasure of the Governor for a term 16 17 coincident with that of the Governor making the appointment or until a successor is appointed and 18 qualified. Before entering upon the discharge of duties, each Secretary shall take an oath to faithfully 19 execute the duties of the office. 20 B. Each Secretary shall be subject to direction and supervision by the Governor. Except as provided 21 in Article 5 (§ 2.2-208 et seq.) of this chapter, the agencies assigned to each Secretary shall: 22 1. Exercise their respective powers and duties in accordance with the general policy established by the Governor or by the Secretary acting on behalf of the Governor; 23 24 2. Provide such assistance to the Governor or the Secretary as may be required; and 25 3. Forward all reports to the Governor through the Secretary. 26 C. Unless the Governor expressly reserves such power to himself and except as provided in Article 5 27 (§ 2.2-208 et seq.) of this chapter, each Secretary may: 1. Resolve administrative, jurisdictional, operational, program, or policy conflicts between agencies or 28 29 officials assigned; 30 2. Direct the formulation of a comprehensive program budget for the functional area identified in 31 § 2.2-1508 encompassing the services of agencies assigned for consideration by the Governor; 32 3. Hold agency heads accountable for their administrative, fiscal and program actions in the conduct 33 of the respective powers and duties of the agencies; 34 4. Direct the development of goals, objectives, policies and plans that are necessary to the effective 35 and efficient operation of government; 36 5. Sign documents on behalf of the Governor that originate with agencies assigned to the Secretary; 37 and 38 6. Employ such personnel and to contract for such consulting services as may be required to perform 39 the powers and duties conferred upon the Secretary by law or executive order. D. As used in this chapter, "Governor's Secretaries" means the Secretary of Administration, the 40 41 Secretary of Agriculture and Forestry, the Secretary of Commerce and Trade, the Secretary of 42 Education, the Secretary of Finance, the Secretary of Health and Human Resources, the Secretary of Natural Resources, the Secretary of Public Safety, the Secretary of Technology, and the Secretary of 43 44 Transportation. 45 Article 2.1. 46 Secretary of Agriculture and Forestry. § 2.2-203.3. Position established; agencies for which responsible; additional duties. 47 **48** The position of Secretary of Agriculture and Forestry (the Secretary) is created. The Secretary shall be responsible to the Governor for the following agencies: Department of Forestry, Department of 49 50 Agriculture and Consumer Services, Virginia Agricultural Council, and Virginia Marine Products Board. 51 The Governor, by executive order, may assign any state executive agency to the Secretary, or reassign 52 any agency listed in this section to another Secretary. 53 § 2.2-204. Position established; agencies for which responsible; additional duties. 54 The position of Secretary of Commerce and Trade (the Secretary) is created. The Secretary shall be responsible to the Governor for the following agencies: Department of Business Assistance, Department 55 of Forestry, Virginia Economic Development Partnership Authority, Virginia Tourism Authority, Department of Labor and Industry, Department of Mines, Minerals and Energy, Virginia Employment 56 57 Commission, Department of Professional and Occupational Regulation, Milk Commission, Department of 58 59 Agriculture and Consumer Services, Department of Housing and Community Development, Department

- The Secretary shall implement the provisions of the Virginia Biotechnology Research Act (§ 2.2-5500 65 66 et seq.).
