6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 46.2-392 of the Code of Virginia is amended and reenacted as follows:**

8 § 46.2-392. Suspension of license or issuance of a restricted license on conviction of reckless or
9 aggressive driving; probationary conditions required; generally.

10 In addition to the penalties for reckless driving prescribed in § 46.2-868 ~~any~~ and the penalties for
11 aggressive driving prescribed in § 46.2-868.1, the court may suspend ~~any~~ the driver's license issued to a
12 convicted person under Articles 1 through 9 (~~§ 46.2-300 et seq.~~) of this chapter convicted of reckless
13 driving or aggressive driving for a period of not less than ~~ten~~ 10 days nor more than six months and the
14 court shall require the convicted person to surrender his license so suspended to the court where it will
15 be disposed of in accordance with § 46.2-398. Additionally, any person convicted of a reckless driving
16 offense which the court has reason to believe is alcohol-related or drug-related may be required as a
17 condition of probation or otherwise to enter into and successfully complete an alcohol safety action
18 program.

19 If a person so convicted has not obtained the license required by this chapter, or is a nonresident, the
20 court may direct in the judgment of conviction that he shall not, for a period of not less than ~~ten~~ 10
21 days or more than six months as may be prescribed in the judgment, drive any motor vehicle in the
22 Commonwealth. The court or the clerk of court shall transmit the license to the Commissioner along
23 with the report of the conviction required to be sent to the Department.

24 The court may, in its discretion and for good cause shown, provide that such person be issued a
25 restricted permit to operate a motor vehicle during the period of suspension for any of the purposes set
26 forth in subsection E of § 18.2-271.1. The court shall order the surrender of such person's license to
27 operate a motor vehicle to be disposed of in accordance with the provisions of § 46.2-398 and shall
28 forward to the Commissioner a copy of its order entered pursuant to this subsection, which shall
29 specifically enumerate the restrictions imposed and contain such information regarding the person to
30 whom such a permit is issued as is reasonably necessary to identify such person. The court shall also
31 provide a copy of its order to the person who may operate a motor vehicle on the order until receipt
32 from the Commissioner of a restricted license. A copy of such order and, after receipt thereof, the
33 restricted license shall be carried at all times while operating a motor vehicle. Any person who operates
34 a motor vehicle in violation of any restrictions imposed pursuant to this section shall be punished as
35 provided in subsection C of § 46.2-301. No restricted license issued pursuant to this section shall permit
36 any person to operate a commercial motor vehicle as defined in the Virginia Commercial Driver's
37 License Act (§ 46.2-341.1 et seq.).
