6 Be it enacted by the General Assembly of Virginia: 7 1. That § 46.2-301 of the Code of Virginia is amended and reen

7 1. That § 46.2-301 of the Code of Virginia is amended and reenacted as follows:
 § 46.2-301. Driving while license, permit, or privilege to drive suspended or revoked.

9 A. In addition to any other penalty provided by this section, any motor vehicle administratively 10 impounded or immobilized under the provisions of § 46.2-301.1 may, in the discretion of the court, be impounded or immobilized for an additional period of up to ninety 90 days upon conviction of an 11 offender for driving while his driver's license, learner's permit, or privilege to drive a motor vehicle has 12 been suspended or revoked for (i) a violation of §§ 18.2-36.1, 18.2-51.4, 18.2-266 or § 46.2-341.24 or a 13 substantially similar ordinance or law in any other jurisdiction or (ii) driving after adjudication as an 14 15 habitual offender, where such adjudication was based in whole or in part on an alcohol-related offense, or where such person's license has been administratively suspended under the provisions of § 46.2-391.2. 16 17 However, if, at the time of the violation, the offender was driving a motor vehicle owned by another person, the court shall have no jurisdiction over such motor vehicle but may order the impoundment or 18 19 immobilization of a motor vehicle owned solely by the offender at the time of arrest. All costs of 20 impoundment or immobilization, including removal or storage expenses, shall be paid by the offender 21 prior to the release of his motor vehicle.

B. Except as provided in §§ 46.2-304 and 46.2-357, no resident or nonresident (i) whose driver's 22 23 license, learner's permit, or privilege to drive a motor vehicle has been suspended or revoked or (ii) who 24 has been directed not to drive by any court, or by the Commissioner, or by operation of law pursuant to 25 this title or (iii) who has been forbidden, as prescribed by law, by the Commissioner, the State 26 Corporation Commission, the Commonwealth Transportation Commissioner, any court, or the 27 Superintendent of State Police operation of any statute of the Commonwealth or a substantially similar 28 ordinance of any county, city or town, to operate a motor vehicle in the Commonwealth shall thereafter 29 drive any motor vehicle or any self-propelled machinery or equipment on any highway in the 30 Commonwealth until the period of such suspension or revocation has terminated or the privilege has 31 been reinstated. A clerk's notice of suspension of license for failure to pay fines or costs given in 32 accordance with § 46.2-395 shall be sufficient notice for the purpose of maintaining a conviction under 33 this section. For the purposes of this section, the phrase "motor vehicle or any self-propelled machinery 34 or equipment" shall not include mopeds.

C. À first or second offense of violating this section shall constitute violation of subsection B is a Class 1 misdemeanor. A third or subsequent offense shall constitute a Class 1 misdemeanor punishable by a minimum, occurring within a 10-year period shall include a mandatory minimum term of confinement in jail of ten 10 days which shall not be suspended in whole or in part. However, the court shall not be required to impose a minimum, mandatory minimum term of confinement in any case where a motor vehicle is operated in violation of this section in a situation of apparent extreme emergency which requires such operation to save life or limb.

In addition D. Upon a violation of subsection B, the court shall suspend the person's driver's license
 or privilege to drive a motor vehicle for the same period for which it had been previously suspended or
 revoked when the person violated this section.

45 D. In the event the person has violated this section subsection B by driving during a period of
46 suspension or revocation which was not for a definite period of time, the court shall suspend the
47 person's license, permit or privilege to drive for an additional period not to exceed ninety 90 days. Any
48 additional suspension ordered under the provisions of this section shall, to commence upon the
49 expiration of the previous suspension or revocation unless or to commence immediately if the previous
50 suspension or revocation has expired prior to the ordering of an additional suspension or revocation.
